I submit that our greatest challenges as an organization continue to be:

Alternate Executive Delegate's Report

April 2000 Board of Directors Meeting

USLA National Certification Program

- There are now 85 agencies certified or under review.
- In our region, Los Angeles County Lakes and Oceanside, California have not made progress on their initial certification applications for a number of years. The USLA Board of Directors will hear a proposal that they be provided 60 days to respond and that their applications be terminated if no satisfactory response is received. This will not prevent a subsequent application.
- CSLSA agencies being considered for recertification or new certification include:
 1. California Lifesaving Association
 2. Camp Surf (YMCA), San Diego
 3. Hawaii (County of), HI
 4. Imperial Beach, CA (City of)
 5. Kauai, HI (County of)
 6. Long Beach Marine Safety Division, CA
 7. Maui (County of), HI
 8. Mauna Kea Beach Resort, HI
 9. San Diego Lifeguard Service, CA
 10. North Island Naval Air Station, San Diego, CA (New Application)
- On a trial basis, the YMCA has approved a program whereby the San Diego Regional Lifeguard Academy will include an eight-hour training module that will allow those in attendance to receive a YMCA pool lifeguard certificate. This will allow them to work at a pool which recognizes the YMCA certificate during periods that they are not offered employment by one of the agencies participating in the San Diego Regional Academy system.
- On May 25, 2000, San Diego's Miramar College, in conjunction with the San Diego Regional Lifeguard Academy, will issue its first Associates of Science degree entitled, "Open Water Lifeguard Professional." This degree is achieved by earning 30 units of college credit in lifeguard related subjects combined with 30 units of general education. A Certificate of Achievement can also be obtained by taking just the 30 units related to lifeguarding. The lifeguard related subjects include such courses such as Intro to Open Water Lifeguarding, Lifeguard Vehicle Operations, cliff rescue, swiftwater rescue, PWC Operations, and Instructor Training. A seasonal San Diego lifeguard, Mike Clegg, will be the first to receive this newly created degree. This represents the culmination of a goal set four years ago to create a college degree in lifesaving. Many more lifeguards the San Diego area are working on obtaining either the AS or Certificate.
- Two projects are underway in Panama City Beach to improve lifesaving. One involves a group seeking to create a new lifesaving organization. Another involves an effort by a local community college to develop a course. There are some challenges being faced in this process, which will be considered by the USLA Board of Directors.
- A writer, assigned by Funworld magazine to investigate and report on Dr. Henry Heimlich's abdominal thrust recommendations for drowning resuscitation, interviewed a variety of doctors and other experts, as well as me. The completed report raises a number of concerns. Immediately after an advance copy was shown to Ellis and Associates, the only lifeguard training organization in the world of which I am aware which taught the procedure, Ellis changed their teaching protocols to excise the Heimlich abdominal thrust, and posted information about this on their website. Ellis and Associates is best known for teaching lifeguards for the waterpark and pool environment. Funworld is a magazine produced by the International Association of Amusement Parks and Attractions. According to a

letter from the President of the organization to IAAPA members, "This report was scheduled to be published in the May issue of Funworld magazine. However, it has come to our attention that members of the news media are independently pursuing the issue. In order to better prepare all IAAPA members for possible media inquiries, the report has been pulled from the magazine's editorial lineup and sent immediately to each IAAPA member."

- As National Certification Committee Chair, I received a complaint that the City of Jacksonville's life-guard program, which has been certified since May 1995, is not in compliance. I sent a letter detailing the allegations and requesting a reply. The agency replied and provided extensive documentation. It is my view, based on the documentation provided, that while the agency can improve in certain areas, the agency appears to be in substantial compliance with USLA requirements. Pending approval of the USLA Board of directors, I will continue to work with the agency to ensure full compliance.
- The terms of Certification Officers, who review incoming certifications, have expired. CSLSA has nominated the following persons as Certification Officers. The USLA President makes appointments as he considers appropriate:

USLA Textbook Committee

- Through December 1999, a total of 9,743 books had been sold. USLA received a check for \$404.45 for that period. Total earnings to date are \$10,036.49. Our royalty is now 10% for regular sales in the United States. Books sold to other countries or via mail order have a fixed 5% royalty.
- Brady has been contacted by letter and telephone in efforts to arrange for a second edition of the book, upgraded with a variety of changes that have been recommended. These discussions are not finalized at this time.
- Remember, one of the best ways agencies can support USLA and educate lifeguards and junior lifeguards is to buy books for your training programs and for the reference of your lifeguards. Please mention this in your newsletters, meetings, and in any other way possible.

International Issues

- Volusia County, Florida (Daytona Beach) and the United States Lifesaving Association have been awarded the right to conduct Rescue 2002 by the International Life Saving Board of Directors, pending a final site review. Volusia County representatives made an excellent presentation at the ILS Board of Directors meeting. They will conduct beach events at Daytona Beach and pool events in Orlando. They expect to have a website up, with all details, in June (www.rescue2002.com). It is important to note that ILS awarded this event to both organizations, because it wants USLA to take responsibility for ensuring conduct of the event. Volusia County agreed to include USLA representatives on the organizing committee. I will recommend that the USLA President and/or Board of Directors designate appropriate persons for this work.
- Rescue 2000 was conducted in Sydney, Australia by Surf Life Saving Australia. It included various competitions, a Board of Directors meeting, and a quadrennial General Assembly. The US team made a fine showing. Results can be found at: www.wavecam.com.au/rescue2000. Recognition is due Tim and Elise Gallagher for their extensive efforts to raise funds for the team and to manage their activities. Dr. Peter Wernicki attended as team physician. Tom Daly and Carl Martinez attended as members of commissions. Charles Hartl and Andy Healey attended as officials. A number of individuals and teams also attended from Bethany Beach, Monmouth County, Galveston, New York, Los Angeles, San Diego, and other parts of the US.

- Alan Whelpton, of Surf Life Saving Australia, has been elected President of ILS for a four-year term. Alan has extensive experience in lifesaving and many contacts around the world. Most recently, he has served as President of the Asia/Pacific Region of ILS and headed Surf Life Saving Australia. Dr. Harald Vervaecke was reelected Secretary General.
- Various USLA members will continue to serve on the ILS Board and committees. Dr. Peter Wernicki was reappointed to a four-year term as Chair of the Medical Commission. Tom Daly was reappointed to a four-year term as a member of the Sport Commission. Carl Martinez was reappointed to a four-year term as a member of the Rescue and Education Commission. I was reelected President of the Americas Region of ILS, and thereby continue to serve as one of four vice-presidents of ILS.
- Brazil has become a Full Member of ILS from the Americas Region. Uruguay has indicated an interest in becoming a Full Member as well. We are working with several other countries with a similar interest.

USLA Website

- The initial site sponsors, Physio-Control and Ambu, were promised a two-year, category exclusive recognition on the site in compensation for their initial sponsorship of the site. Their sponsorship paid for design, hosting, and a two-year maintenance contract for our website. The two-year term expired in November 1999. Dick Colosi subsequently arranged with Physio-Control to extend their sponsorship for two years for \$4,000. They are now being recognized on the site under the banner of Medtronic. Net income to USLA should be at least \$1,500 per year after commissions and general website costs.
- It was decided in November 1999 that a USLA Store should be developed on the website where links would be made available to any USLA revenue partner willing to sign a contract with USLA for a certain percentage of income and to design a site to agreed specifications. The first revenue partner to meet the required standards is Uniserv, which is now linked in the new USLA Store. This allows anyone visiting USLA.ORG to purchase a variety of branded USLA items. Soon, other revenue partners should be added to the site. This can be expected to increase revenues to USLA for branded items and will make them available year-round, throughout the world.
- The Guard to Guard Bulletin Board crashed and all posted items were lost. The problem has been corrected and this BB is in use again.
- No major upgrades of the site are currently planned. Any feedback is welcome.

California Legislative Report

April 2000 Board of Directors Meeting

BILL NUMBER: AB 2045

Recommendation: SUPPORT WHEN AMENDED

AMENDED IN ASSEMBLY APRIL 3, 2000
AMENDED IN ASSEMBLY MARCH 23, 2000

INTRODUCED BY Assembly Member Nakano

FEBRUARY 18, 2000

An act to amend Sections 668.1 and 668.2 of, and to add Section 668.3 to, the Harbors and Navigation Code, relating to boating.

LEGISLATIVE COUNSEL'S DIGEST

AB 2045, as amended, Nakano. Boating safety.

Existing law permits, and in some cases requires, any person convicted of specified offenses relating to the operation of vessels to be ordered by the court to complete and pass a boating safety course.

This bill would require the Department of Boating and Waterways to approve boating safety courses for those purposes. The bill would make conforming changes.

The bill also would require the department to develop a *voluntary* personal watercraft education course ~~which would be voluntary~~. The bill would require ~~that~~

the course to be made available on the department's website *and would authorize the course to be made available in other formats, as determined by the department*.

The bill would also require the department to conduct an annual study and to prepare an annual report to the Legislature evaluating public participation in the course and the effect of the course on personal watercraft safety.

Existing law authorizes the department to grant funds from the Harbors and Watercraft Revolving Fund, which is available upon appropriation by the Legislature, for, among other things, scholarship funding relating to boating safety education and to finance the purchase of vessels and related safety equipment for use in boating safety education classes.

This bill would also authorize the department to grant funds from that fund to provide the voluntary personal watercraft education course developed by the department pursuant to the bill in those situations where the department determines the course would not otherwise be available to a significant number of personal watercraft operators.

BILL NUMBER: AB 2538

Recommendation: SUPPORT

AMENDED IN ASSEMBLY MARCH 30, 2000

INTRODUCED BY Assembly Member Brewer

FEBRUARY 24, 2000

An act to amend Sections 651 and 658.3 of the Harbors and Navigation Code, relating to vessels.

LEGISLATIVE COUNSEL'S DIGEST

AB 2538, as amended, Brewer. Operation of vessels: boating safety.

(1) Existing law prohibits a person from operating a motorboat, sailboat, or vessel that is 26 feet or less in length unless every person who is 6 years of age or younger is wearing a type I, II, or III Coast Guard-approved personal flotation device, or unless the person is operating a sailboat on which the person who is 6 years of age or younger is restrained, as provided, or the person is operating a vessel on which the person who is 6 years of age or younger is in an enclosed cabin, or unless the person is operating a motorboat, sailboat, or vessel if the operator is reacting to an emergency rescue situation.

This bill would make those requirements that currently apply to a person who is 6 years of age or younger, instead, apply to a person who is 11 years of age or younger, and would require the flotation device to be a type I, II, III, or V Coast Guard-approved personal flotation device. The bill would also require any person aboard a personal watercraft or any person being towed behind a vessel on water skis, an aquaplane, or similar device to wear a type I, II, III, or V Coast Guard-approved personal flotation device, except as provided. Because other existing law makes a violation of these requirements an infraction, the bill would impose a state-mandated local program.

(2) Existing law prescribes the length of "personal watercraft" as less than 12 feet.

This bill, instead, would prescribe the length of "personal watercraft" as less than ~~12~~ 13 feet.

(3) The California Constitution requires the state to reimburse local agencies and school districts for certain costs mandated by the state. Statutory provisions establish procedures for making that reimbursement.

Television

- **MTV plans to televise from a studio on the beach in San Diego for the summer of 2000 (four months) pending regulatory approval. They have indicated that they will be promoting the USLA Nationals on MTV regularly during the summer and that they will cover the event to an as yet undetermined degree on national television.**

Brochure

- **A brochure on the event has been produced and will be sent to all persons on the American Life-guard Magazine mailing list within two months.**

Website

- **A website with updated details, including a site map, schedule of events, and list of hotels has been developed. Event registration will occur on the website via credit card (see below). The address of the site is www.uslanationals.org. Persons registering via the site will receive an email receipt.**

Officials

- **Budgeted funds are available for 30 officials, each of whom will be reimbursed up to \$700 each for airfare and hotel, with proof of expense. In return, San Diego is requesting their volunteer skills on all three days of the event. USLA is responsible for designating the officials in advance.**
- **It is recommended that three officials be designated, in advance, to adjudicate any rules disputes and that they not have any other responsibility. Their decision would be final.**

Competition Management

- **An event organizing committee has been working on the event since the fall of 1999.**
- **A professional event organizer is being retained to coordinate the overall event.**
- **A professional athletic event organizer is being retained to organize competition events on the beach. He will work in conjunction with the officials.**
- **A professional registration and scoring company is being retained to handle all registration and scoring for the event.**

Mexico

- **A day in Rosarito Beach, Mexico is being organized for Sunday, August 13, 2000. Rosarito Beach is about 20 miles south of the Mexican border. Transportation would be either by bus or by cruise ship.**

Event Registration

- In an effort to ensure advance registration, the event organizers wish to offer registration via the website for \$25, with on-site registration at \$50. This is to be discussed by the Competition Committee.
- In an effort to plan for the number of persons in each event, so that there is a roster available to officials and adequate materials available, the organizers wish to allow competitors to sign up for a fixed number of events free of charge, then charge \$5 per event thereafter. The primary goal is not fund raising, but rather planning for the number of persons and the name of the persons who will compete in each event.
- It is tentatively planned that event registration will be limited to the USLA website, to the competition site on the evening of Wednesday, August 9, then from 7:00 a.m. to 8:00 a.m. at the site on August 10, 11, and 12. This will allow the scoring and registration company to provide a full roster of names of participants in each event to the officials responsible.

- Preliminaries for Surfboats, Landline, and Beach Flags will be on August 10, 2000 simultaneous with Junior Lifeguard Events. Landline, Rescue Race, and Rescue Board Rescue Race will be limited to four teams per chapter, per prior action of the Competition Committee.

2000 Nationals: August 10 (JG's and prelims for LG events), 11 and 12 at Crystal Pier, Pacific Beach, San Diego

Other events scheduled for this summer include ASRA (Scott Hubbell) Events on July 6 at Zuma Beach and August 26 at Long Beach, the Taplin Relay in Los Angeles County on August 5, and the All-Women Tournament at Gateway National Recreational Area on July 26. In addition, the Wieland Shield will be contested between Victoria, Australia and California in the first week of August.

The USLA Competition Rulebook is being overhauled and updated. Hopefully, some of the "gray areas" can be clarified and cleaned up.

New for the 2000 Nationals: Preliminary heats for Landline, Beach Flags, and Surfboats will be held on Thursday (August 10). Landline, Rescue Race, and Rescue Board Rescue Race will be limited to 4 teams per Chapter. The idea behind these changes is to help keep the competition running on time. One additional change is to allow the Head Officials to implement a time limit in which to complete any given event.

The "water judge" will from now on be a member of the "Corp of Officials." Speaking of officials, we are always looking for new officials. If you are interested in helping out as an official at Regionals, Nationals, or both, please contact Rob McGowan.

Rule changes that were adopted by the USLA that go into effect in 2000 include the addition of Women's age groups so that the Women's age categories are the same as the Men's. In addition, the "Host Event" has been eliminated. Just a reminder that competition caps (beanies) are required at all USLA events. The rules are going to state that you must start and **finish** with the cap on your head.

The USLA National Team competed in *Rescue 2000* March 24 - 26. CSLSA members included Diane Graner-Gallas, Ericka Keithly, Craig Hummer, Mitch Kahn, and Paige Gallas replacing Heidi Kissel who stayed home to train for the Olympic Trials. There was an interclub and masters competition as well, and several CSLSA chapters were represented at

the World Championships. Although the U.S. team finished a disappointing ninth in the Ocean events and thirteenth overall, they did earn an invitation to the Goodwill Games that are scheduled to be held in Brisbane, Queensland, Australia in September, 2001. The competition will be a team based surf competition, similar but not identical to the Rescue 2000 Surf events, with team point scoring. The best part is that the Goodwill Games are picking up the expenses for a team of nine plus a manager/coach. Full details are supposed to be out in June. I am not sure if team members will be picked based on the results of this year's Nationals, but that would be my suggestion.

Speaking of National teams, the USLA needs to take a closer look at selection criteria for members of the National Team if we are going to perform better at future World Lifesaving Championships. I plan to propose that we add pool tryouts as part of the process of selecting the National Team. Please bring any input you have to the committee meeting today. The 2001 Nationals are supposed to be in the Southeast Region (south Florida), but I have received some preliminary indications that they may be interested in passing. Perhaps this is the time to revamp the rotation to eliminate the places we really don't want to compete in August. Please bring your thoughts to today's meeting. This is also the meeting that we can submit rule change proposals for implementation in 2001, so if you have any ideas, bring them to committee.

COMMITTEE REPORT FOR TRAINING**April 27, 2000**

Since the fall of 1999 Southern California Lifeguard Agencies have started to strengthen their working relationships in regards to training. As of January the committee has grown to include a large majority of Southern California's Lifeguard Agencies. The intent is to work together, and to start producing, training curriculum that will be universal for all open water lifesaving agencies. Basically, we as a community of professionals will be putting into place a training curriculum for the professional lifeguard. This curriculum will follow the guidelines established by the United States Lifesaving Association. The committee is also looking at all levels of lifeguarding.

Newport Beach has taken a very strong lead in developing the Open Water Lifeguard Occupation Analysis, which will allow for cataloging of all levels of lifeguarding. The unique thing about the occupation analysis is it allows for common training that is shared throughout the lifeguard community and also allows for each agency to add specific topics that are unique to their organization.

At this time Newport Beach Marine Safety Supervisors, Mike Halphide and Brian O'Rourke, have put in a number of hours in developing the structure of the occupation analysis. At the same time Mike Halphide has set up a working site on Blackboard.com so that individuals can participate and develop curriculum.

The next training officers meeting will be in Newport Beach at the Central Library's computer room from 11:00am to 1:00 pm, Tuesday, May 16, 2000. The focus of the meeting will be an orientation to Blackboard.com and how to use it. If you are interested please attend the meeting and bring any other key people that might want to attend.

Subject: Public Education Committee Report
Date: April 28, 2000

The following issues were discussed in today's committee meeting:

Committee discussed focusing efforts on pursuing alternative funding options for future projects, via grants and/or scholarships. Committee requested permission from the Executive Board to explore pursuing coursework in grant writing. As part of this, the committee proposed to consider sending two representatives to a formal seminar on grant writing, with the initial goal of learning to write grants, with a final goal of obtaining grant funding for future projects. Once suitable courses are located, the committee will submit a request for tuition to the Executive Board. Initial estimates for classes are approximately \$150 per person, or \$300 for two members. Funds would be generally beneficial to the CSLSA, and specifically targeted for Public Education.

Committee also discussed possibility and desirability of creating a library of photographs and offering cash incentives to encourage contributions. Estimated costs would be approximately \$150 twice per year (\$300 annually). Request for funding for this project was not submitted at this time, due to an outstanding request for photographs from another committee. These photos can be used as a base for the library to be built upon. Discussion also focused on the appropriateness of Public Education maintaining such a library. Due to possible digital access of the photos, maintenance of the library may be more appropriate by the Web Site Ad Hoc Committee. The Public Education Committee will discuss these issues at the next General Board Meeting.

"Lifeguards for Life"

The United States Lifesaving Association (USLA) is a non-profit entity holding an exemption with the Internal Revenue Service as an educational organization under Section Number 501(c)3. Currently the primary source of funding of the association is membership dues and donations of its members through United Way. Secondary funding comes via specific sponsorships or grants for programs.

The organization is made up of individual members who form chapters in a local area. The chapters join together to create a region of the US wherein they can exchange local and regional information relative to their activities. There are currently eight regions within the USLA. Twice annually these regions come together for a Board of Directors meeting, to conduct business of the association and an Educational Conference to bring new information to the members.

The regions also conduct lifesaving competitions to allow their members to demonstrate their abilities in the water while performing against other lifeguards in events that simulate the rescue activities of guards. Once a year the national organization conducts a National Championship to showcase the most proficient lifesavers and to place lifesaving more into the spotlight as a profession.

The USLA's primary goals and objectives can best be summed up in the following:

***OPEN WATER SAFETY THROUGH EDUCATION**

USLA members volunteer their services for youth and educational programs in local areas for schools and service organizations. The programs are designed to bring to the community a safety awareness and prevention program that will reduce the number of aquatic related accidents in the United States.

Members gain insight into new and improved operational philosophies and practices through educational conferences and clinics designed to acquaint today's lifeguard with the most current and up-to-date lifesaving information. The USLA also produces AMERICAN LIFEGUARD a magazine for professional lifeguards and interested parties outside the profession.

Educational slide presentations and videos have also been produced to expand the tools for educating the public.

***OPEN WATER SAFETY THROUGH PREVENTION**

Although education plays a vital role in prevention, all lifeguard and marine safety chapters of the association, place priority on the reduction of aquatic related accidents. Through intensive education and training, beach and open water rescues and medical aids can be prevented before they happen, thus preventing serious injury or death. Prevention is often conducted on the spot, in the environment, with public address systems or direct personal contact with people in the field to warn them out of hazardous situations or directing them away from such situations before an incident occurs.

***OPEN WATER SAFETY THROUGH ACTION**

The primary responsibility and job of the lifeguard has been to prevent aquatic accidents, however because of the sheer numbers of individuals that use our aquatic resources, lifeguards still must perform a major portion of their function in the water or on the beach providing rescues to people in distress, medical aids to the sick or injured and numerous other related activities.

USLA Lifeguards annually rescue more than 50,000 distressed swimmers, perform over one million preventative actions and provide medical aids to over 45,000 individuals who have done everything from stub their toe to suffer cardiac arrest.

means of protection against votes being cast by other than legal voters. Voting by mail cannot be a secret ballot, as it is necessary for the tellers to know by whom each vote is cast. By some such method as the above it is practicable to give all the members, however scattered they may be, an opportunity to vote on questions of great importance.

Proxy Voting . A proxy is a power of attorney given by one person to another to vote in his stead and it is also used to designate the person who holds the power of attorney. It is unknown to a strictly deliberative assembly, and is in conflict with the idea of the equality of members, which is a fundamental principle of deliberative assemblies. There can be but little use for debate where one member has more votes than another, possibly more than all the others combined. If the proxy voting is limited to the election of a board of directors, as it is practically in stock corporations, and if, also, the proxies must be given to members of the corporation in all cases where it requires an election to become a member -- with these two limitations proxy voting would be useful and do no harm. In stock companies the members meet only annually to elect directors, who elect the officers and transact the business of the corporation. Though the directors are elected largely by proxies, their own meetings, where all the business is done, are as secret as they choose to make them, no proxies being allowed in them, and therefore proxy voting does not interfere with their business. As any one can dispose of his stock to any one else, there is no objection to his appointing any one as his proxy. But the case is very different with many incorporated societies of a social, benevolent, or religious character, whose business meetings are sometimes secret. Their membership cannot be transferred by the members like stock, and therefore they should not be allowed to appoint any proxies who are not members of the organization. The state law is above the by-laws of the society, and if the state law empowers members of all corporations to appoint proxies to vote at all business meetings, no by-laws of an incorporated secret society could prevent non-members holding proxies from attending and voting at all business meetings of the society. This should not be the case. With stock corporations it does no harm, because all the business is done by directors, and no proxies are allowed in their meetings, and no one can be present without their consent. But in many societies of the kind mentioned the business is transacted in meetings attended by none but members, and unlimited proxies would be a serious interference with their work. If the state law requires proxy voting in all corporations, it should be limited to the election of officers, including directors, and also the proxies should be required to be held by members of the corporation in all organizations whose primary object is not pecuniary profit.

1. Taking a vote by yeas and nays, which has the effect to place on the record how each member votes, is peculiar to this country, and, while it consumes a great deal of time, is rarely useful in ordinary societies. While it can never be used to hinder business, as long as the above rule is observed, it should not be used at all in a mass meeting, or in any other assembly whose members are not responsible to a constituency. By the Constitution, one-fifth of the members present can, in either house of Congress, order a vote to be taken by yeas and nays. In representative bodies this method of voting is very useful, especially where the proceedings are published, as it enables the people to know how their representatives voted on important measures. If there is no legal or constitutional provision for the yeas and nays being ordered by a minority in a representative body they should adopt a rule allowing the yeas and nays to be ordered by a one-fifth vote, as in Congress, or even by a much smaller number. In some small bodies a vote on a resolution must be taken by yeas and nays upon the demand of a single member.

47. Votes that are Null and Void even if Unanimous. No motion is in order that conflicts with the laws of the nation, or state, or with the assembly's constitution or by-laws, and if such a motion is adopted, even by a unanimous vote, it is null and void. No rule that conflicts with a rule of a higher order is of any authority; thus, a by-law providing for the suspension by general consent of an article of the constitution would be null and void; so, the general parliamentary rule allowing a two-thirds vote to amend the by-laws after due notice, is only in force when the by-laws are silent on the subject. Rules that protect absentees cannot be suspended informally by general consent, or formally by a unanimous vote, as the absentees have not given their consent. For instance, a rule requiring the giving of a specified notice of certain motions, as an amendment of the by-laws, cannot be suspended by general consent or by a unanimous vote. When a vote is required to be taken by ballot, the object is to enable members to conceal their votes, and any motion that defeats this object is out of order. Thus, when the rules require the vote to be by ballot, as is usual in elections to office or membership, this rule cannot be suspended even by general consent, because no one can object without exposing

ARTICLE V
REGIONAL COUNCILS

SECTION 1 - Definition

The UNITED STATES LIFESAVING ASSOCIATION will be divided into Regional Councils to be determined by the Board of Directors. The Regional Council shall be composed of designated representatives from chapters within the region. The representative to the Regional Council shall be known as a delegate.

SECTION 2 - Duties and Powers

- A) The regional powers, business and affairs shall be exercised, conducted and controlled by the Regional Council through the By-Laws that the Regional Council may enact. Regional Council By-Laws, if any, shall not be in conflict with the By-Laws of the UNITED STATES LIFESAVING ASSOCIATION. In the event a conflict may arise the By-Laws of the UNITED STATES LIFESAVING ASSOCIATION shall preempt the By-Laws of a Regional Council.
- B) Any proposed change in geographical regions must be approved by the affected Regional Council(s) before the issue may be brought before the National Board. (Amended 10/25/92)

SECTION 3 - Nomination and Election to Regional Council

- A) Qualifications: The privilege of being delegates, holding office and voting shall belong to each member of each chapter in good standing.
- B) Each chapter shall be entitled a member/delegate ratio established by the Regional Council.
- C) Each delegate shall be entitled to one vote.

SECTION 4 - Vacancy

Any delegate vacancy occurring on the Regional Council by reason of death, resignation or otherwise shall be filled by the Regional Council. (Amended 11/06/93)

SECTION 5 - Resignation

A delegate shall give notice to the Regional Council and the chapter of the intent to resign from the Regional Council. The chapter shall have the power to fill such vacancy on the date when said resignation becomes effective. The appointed shall hold office Until an election is held at the next meeting of the regional council. (amended 5/07/94)

ARTICLE III
MEMBERSHIP

Section A – Regular Membership

To qualify for regular membership in the Association, an individual must meet each of the following criteria:

- 1) Be a direct, active employee of a federal, state, county, municipal or other governmental agency primarily assigned to provide ocean, bay, lake or open water life-saving and rescue services or a retired employee thereof who is drawing a pension. All chiefs, directors or equivalent are qualified for membership, including those who have retired. The foregoing notwithstanding, all members of Chapters in good standing as of April 1993 are deemed to be qualified for regular membership so long as they also meet all other requirements of these Bylaws and unless and until such time as the Chapter may be expelled from the CSLSA for cause as provided for under these Bylaws.
- 2) Have worked a minimum of eight (8) hours for a respective service in the current calendar year unless the individual is retired from the service.
- 3) Be a member of a Chapter associated with the respective service.

(Amended: April 16, 1993)

Section B – Associate Membership

Any person who does not meet the requirements of regular membership, but who desires to participate in and contribute to the lifesaving movement is qualified to be an associate member.

Section C – Life Membership

- 1) To qualify for life membership in the CSLSA an individual must:
 - a) have twenty years of service as a professional lifeguard and/or lifeguard administrator; and,
 - b) have been an active member of the CSLSA or its predecessors for at least ten years; and,
 - c) have served as a member of the Board of Directors, Executive Board or as an elected officer of the CSLSA or its predecessors; and,

ARTICLE III
MEMBERSHIP

SECTION 1 - Qualifications for Individual Membership

To qualify for membership in the association each individual must:

- A) Be a member of an ocean, bay, lake, river, or open water lifesaving or rescue service. All Chiefs, Directors, or equivalent of are qualified for membership. (Amended 5/04/79)
- B) Have worked a minimum of eight hours annually for a respective service to qualify for current active membership. (Amended 11/05/88)
- C) Be a member of a chapter for voting privileges.
- D) Maintain dues structure as prescribed by the Board of Directors.

SECTION 2 - Types of Members (Amended 5/04/79)

Each individual who meets the qualifications shall be eligible for membership. Members shall be of two types:

- A) Permanent Member; those individuals who by reason of job title or salary are considered by their hiring agency to be permanent in status.
- B) Recurrent Member; those individuals who by reason of job title or salary are considered by their hiring agency to be seasonal or hourly in status.
- C) Junior Lifeguard Member; Those individuals who by reason of participation are considered Junior Lifeguards by their agency or Chapter to be eligible for such membership. Recommendations for membership must be approved by the Chapter. Junior Lifeguard membership is a non-voting membership and does not count in calculating delegate representation to the Regional Council or National Board of Directors Meetings. (Adopted 5/07/94)

SECTION 3 - Good Standing

Members remain in good standing as long as they conform to the standards set by the UNITED STATES LIFESAVING ASSOCIATION and are not in conflict with the standards of the Regional Council. As a minimum obligation each member shall pay dues in the amount established by the Board of Directors.

ARTICLE IV
LOCAL CHAPTER MEMBERSHIP

Lifesavers and other qualified persons who by reason of common hiring agency, job similarity, or for reason of geographic unity may associate themselves for purposes of forming a chapter of the association. (Amended 5/04/79)

SECTION 1 - Qualifications for Chapter Membership

To qualify for membership in the association, each chapter must:

- A) contain two (2) or more members who meet the individual requirements for membership as outlined in Article III Section I.
- B) be approved by 2/3rds vote of the Regional Council.
- C) all existing chapters of this association as of May 4, 1979 shall be deemed to have qualified for the purposes of members serving on the Regional Council or Board of Directors.
- D) must meet minimum guidelines of the UNITED STATES LIFESAVING ASSOCIATION. (Amended 11/05/88)

SECTION 2 - Good Standing

A chapter remains in good standing as long as it performs all the duties and obligations deemed by the Regional Council and Board of Directors to be incumbent upon every chapter. As a minimum obligation each chapter shall pay annual membership dues in the amount established by the Board of Directors and Regional Council to be paid to the UNITED STATES LIFESAVING ASSOCIATION Treasurer by August 1st of each year. (Amended 11/05/88)
