- O Certification issues are expected to be a major topic in November.
- O A letter from Mike Hensler of the Southeast Region suggests that more discussion of the commercial lifeguard issue is possible.
- O Also to be discussed is a certification program for non-lifeguard water rescue agencies, college curricula, and minimum equipment standards.

USLA Manual

- O It is believed that over 5,000 copies of *The United States Lifesaving Association Manual of Open Water Lifesaving* have now been sold.
- O All agencies are reminded to order manuals and to use them in their training programs.
- O To order, call 800-638-0220 or 800-374-1200.

International Life Saving

- O This organization, which I serve as President for the Americas Region, continues to grow.
- O The American Red Cross and YMCA have now applied for membership.
- O Various textbooks are planned, one in conjunction with Baywatch.
- O An important agreement was reached in Durban that marketing efforts will not be commenced in a country without that country's permission.
- O The World Oceanman competition looms, with a possible event in California next year.
- O While the organization is experiencing some growing pains, the overall concept of an international body representing all lifeguard federations in the world is sure to survive.

International Medical/Rescue Conference

- O Dr. Peter Wernicki and I are organizing an International Medical/Rescue Conference to be hosted by the ILS Americas Region in San Diego in September 1997, along with an ILS Board of Directors meeting. The events will include pivotal conferences and discussions on the future of world lifesaving.
- O A few of the medical topics included in the conference will be the latest updates on drowning physiology and triage, proper resuscitation procedures, spinal injury extrication, and scuba illness and treatment. Confirmed medical speakers include

- over 30 internationally recognized experts on drowning, resuscitation, spinal injury management, communicable disease avoidance, and so on.
- O Anticipated rescue topics include victim identification, search policies and procedures, and psychological issues for victims and lifesavers. Speakers who have helped develop helicopter rescue, flood rescue, and coastal cliff rescue teams will participate. A major focus will be lifeguard injury avoidance from communicable disease, urban runoff, orthopedic accident, and so on. Several rescue demonstrations are planned.
- O Prior to the conference, time is allotted for the five ILS Commissions (Rescue, Medical, Development Aid, Competition, and Education) to meet. After the conference, the final Board of Directors meeting prior to the ILS General Assembly in February 1998 will be conducted.
- O Tentative dates for the International Medical/Rescue Conference are September 15, 16 & 17, 1997.

Executive Board

- O The Executive Board has met regularly over the past six months, working hard on your behalf.
- Much of the important work of CSLSA is done by your officers and committee chairs. Each of them must be acknowledged.

Outside Activities

- A number of activities outside CSLSA are having an impact on my ability to contribute to CSLSA.

 - ILS Vice-Presidency
 - Speaking in the US and abroad
 - Employment responsibilities
- O I am very much devoted to CSLSA and regret that I have not been more involved. I wish to make it clear that I will not stand for reelection in 1997. I therefore hope that a leader or leaders will step forward to take over CSLSA leadership.

You should have been there! The fireworks took place right after the introductions in Fort Lauderdale. I had corresponded with the National Secretary, Mr. Shotwell, informing him that Mr. Brewster's Region report had omitted my name on the 1996-97 slate of officers. It was suggested that I make the motion to approve the minutes as corrected. After a second to my motion, the President, Mr. Richardson, discussed a memo dated December 27, 1995, to the Executive Committee indicating his decision based on a point of order that a portion of the Competition Committee report concerning adding the Asay boat specifications to the rule book should be deleted. Mr. Gallagher of the Mid-Atlantic Region erupted. An amendment to the motion by Mr. Gallagher "to set aside as out of order the deletion directed by the President" was seconded. Considerable discussion followed. Motion by Mr. Brewster "to lay the motion on the table to permit the Secretary to call the roll of attending delegates" was seconded and passed unanimously. The president then brought the tabled motion and amendment off the table for consideration. The amendment to the motion "to set aside as out of order the deletion directed by the President" was approved unanimously on a roll call vote. The amended motion "to accept the minutes as corrected" was then passed unanimously.

Now if you understand all of that, explain it to me. My original motion is what passed. We spent the opening of the meeting which is normally housekeeping in heated debate. This was the start of the upcoming controversial surf boat issue. What they heard is not what I said, and what I said is not what they heard. With all of the good we had to accomplish, the boat issue that was a hot topic when I began in this organization, again showed it's ugly head. Minds were closed and made up.

Do we continue this stalemate or can we come up with solutions that can cause compromise? We sing to the choir when we talk among ourselves. When we try to use history, logic, or any other approach, it does not matter - politics win out. If you say this report is on white paper with black type and you do not have the votes, guess what, it's not white paper with black type! Knowing this, we as a region must rethink what we want to accomplish. If regions choose not to back us, it will not happen. This goes with all issues.

The frustration that we all feel on any given issue is part of the process. This volunteer organization has a noble cause and most of the participants are to be commended on both sides of each and every issue. The belief is honest and true whether we discuss boats, lifeguards

renting beach equipment, the landline is the primary piece of rescue equipment, the contents of the textbook, etc. In this democratic process we deal with all types. Some are in this profession for the public, profession, and their fellow lifeguards AND some are in it for themselves. I believe most of our region's hard working volunteers are in this business for the greater good. I am proud to be associated with many members of both the region and the national. I do not respect the individuals who are in it only for themselves. With that in mind, it allows me to continue to strive for what we as a region believe is the "right thing to do" and to not give up when things do not go our way.

If we do not continue to find common ground with other regions and just give up and not attend, the USLA will be a different organization. We must gain membership for the common good of our region with more participation, have a larger voice at the national level, and be prepared for (as the saying goes) "when you least expect it, expect it," when dealing with other philosophies. If we know in our hearts that we are doing the right thing, we must not give up. We must try find common ground and accomplish what we can. If we don't, no one will!

I was disappointed a the surprise presentation during the national meeting. The topic was on the lack of professionalism and was delivered during one of the region reports. I would hope in the future that a common courtesy would be extended to the involved parties within the region prior to such a delivery. I had no problem with the content, but embarrassing one's peer(s) in the process without a "heads up" is, in my opinion, just as unprofessional. Hopefully neither situation will occur again and lessons have been learned.

We need to re-evaluate the number of participants that are allowed to enter the National Beach Flags. Dr. Peter Wernicki made some excellent suggestions.

We need to evaluate our regionals, who owns them and what rights do we have on the beach that is hosting the event. Security for competitors and their personal belongings needs to be considered in future event negotiations. Published reports say that the surf festival committee will spend upwards of \$20,000 for an executive director. How is this so when we are told they are broke and are having trouble getting sponsors. The committee was a group of community based volunteers that believed in lifesaving, aquatic events, and community thanks to the seed planted by Sheridan Byerly. Do these plans to hire an executive director explain the reason our region has not realized financial gain for our property? When it was volunteer, negotiations always included money for our region either directly or through our fund raiser. What happened this year?

What's with our microscopic logo on the poster we supported? If you can not read it from 3-5 feet away, should we be charged for it in good conscience? Where are our proofs of the regionals that took place three months ago? What happened to membership?

These topics are to pique your interest, inform, and stimulate dialogue that will hopefully contribute to the improvement of our mission, organization, and the saving of lives. They are not to divide, hold back, or stifle our goals.

COMPETITION COMMITTEE CHAIRMAN'S REPORT

Another summer has come and gone, and with it another competition season. Ahead we have rule changes to vote on at the upcoming USLA Fall Board of Directors meeting next month, and the USLA Nationals will be coming to San Diego next summer. According to USLA President, Bill Richardson, feelers are out to obtain television coverage for the 1997 Nationals. This would be a great opportunity for nationwide exposure of lifeguarding and lifeguard competition. Also scheduled to come to our coast next summer is the International Ironman Super Series. Sanctioned by International Lifesaving, this series will be contested between the top 25 men and 15 women competitors, and will travel to six countries. Craig Hummer and Heidi Hannenian have been invited to compete.

The 1996 Regionals at the San Clemente Pier went well, in spite of less than perfect weather. Thank you to S.C.O.F. for hosting and to K-38 for providing the team and high point trophies. Additional thanks to Rags, for the tops they gave to the individual high point man and women. Team results were L.A. County first, California State Parks second, and San Diego City third. Craig Hummer was the high point man, and Shari Latta the high point woman.

The Weiland Shield was contested at the Manhattan Beach Pier on August 1 and 2 between a strong team from Victoria, Australia and a California team without Craig Hummer. Craig broke his toe the week before the competition and was unable to compete. Craig was inspirational as team captain, but after two days of hard fought racing, the Victorians came out on top.

The weather in Florida for Nationals was great! It started off with an awesome electrical storm the night before the J.G. competition, but then leveled off to not too hot for Florida in August. The competition was plenty hot though. With Craig Hummer out with an injury, and LACOLA with a small team and no boats, the team competition was up for grabs. In spite of its small numbers, LACOLA captured its tenth consecutive team trophy, with Rehoboth Beach, Delaware second and Monmouth County third. Mitch Kahn and Heidi Hannenian were the individual high point winners. Daytona Beach did an outstanding job of hosting and the awards-farewell party set a new benchmark for Nationals. Craig Hummer did a commendable job of announcing the play by play. By all accounts, San Diego will have its work cut out to improve upon the standard set by Daytona Beach; but if anyone can do it, it's Marshall Parks and his staff.

In addition to the direction we want to take on the proposed rule changes, we need to discuss where we want to go with Regionals for 1997. San Clemente has expressed interest in hosting again, however there were some concerns over the 1996 event, and we may want to go elsewhere next year. There is still a desire to hold the Junior Guard Regionals and Lifeguard Regionals at the same location on back to back dates. The opportunity to tie in with a major surf contest is another appealing alternative.

The rule changes that have been proposed and will be voted on are:

- 1. With regard to rule 5.11, 2d, clarify definition of "bottom" and change if necessary. (Mid Atlantic)
- 2. Leave the rules as they are with the clarification of 5.11, 2d as mentioned above, and allow the currently competing boats to compete until the year 2001. Solicit a new design from manufacturers with the goal of a USLA one-design, mono hull surfboat. (CSLSA)
- 3. Increase the number of places that score in Seniors, Senior Women, Masters and Veterans to five, and provide medals through 5th place in those age categories. Scoring would be changed as follows: 1st place: 7, 2nd place: 5, 3rd place: 3, 4th place: 2, 5th place: 1. (South Atlantic)
- 4. Create a new age group, "Super Vets" age 59 and up, to be run with the Veterans. Will score on the same scale as Veterans, with separate awards. (Southeast)
- 5. Increase the late registration fee for Nationals to \$50 or double the "on time" fee. (CSLSA)
- 6. Add a mid-distance surfboat race (5 miles) to be held the day following the 3-lap race. (CSLSA)
- 7. Require that responses to protests at Nationals be in writing, and reviewed at the next USLA National Competition committee meeting. (CSLSA)
- 8. Add a "Separation Rule" for boats at turns similar to the NDA rule. (CSLSA) NDA RULE:
 - A. The NDA recognizes that surf dory racing is an unpredictable sport and there may, at times, be contact between the boats due to reasons not entirely controlled by the crews of the individual dories. This rule is designed to limit the intentional contact and interference between boats during surf races to the extent practical.
 - B. This rule shall rule shall apply during surf races when a boat crosses the line of an imaginary circle with a fifty foot radius around each mark.
 - C. If, at the a boat crosses that line, there is any other boat inside of the first boat whose bow is even with or past the stern oarlocks of the first boat, then that first boat must yield at the mark to permit the inside boat sufficient space at the mark to permit the turn without contact with the hull or oars of the first boat. This rule shall also apply if there is more than one boat having the overlap described in this section.
 - D. If a boat does not have the bow/stern overlap when crossing the 50 foot radius line, it may not acquire it within that radius, and must yield to the boats in front of it at that mark and not interfere with them.
 - E. If a trailing boat loses the requisite overlap within the 50 foot radius, it loses the right-of-way, and must yield to the boats in front of it.
 - F. Unless there are independent water judges with dory racing experience present under the authority of the NDA, this is a self-enforced rule. If it is determined by the Competition Committee that there has been interference at a mark in violation of this rule, then the offending boat or boats shall forfeit their lane position for the next surf race and be assigned the highest lane number for that next race. If there is more than one boat in violation of this rule in one race, the President shall hold a drawing between those boats for the highest lane numbers.
 - 1. Every effort should be made to have at least one water judge present during each surf race.



Ground Breaking on New Lifeguard Headquarters, Zicatela Beach, Puerto Escondido, Oaxaca

Ground breaking ceremonies for the construction of Mexico's first central Lifeguard Headquarters took place September 29, 1996 on Zicatela Beach In the state of Oaxaca, Mexico. Government officials and representatives of the United States Lifeguard Association placed the symbolic "Corner Stone". Completion date will be approximately November 20, 1996, just in time for the Mexican holiday season.

The American team presented to the Salvavidas, their first Rescue Vehicle, which was specially outfitted and painted. 5 rescue boards, 12 rescue cans, uniforms, fins, and other emergency equipment were also formally presented to the Salvavidas.

Salvavidas Salary

Presently, the Salvavidas Team is staffing Zicatela Beach on weekends and holidays. They further respond to emergencies as need arises. The community has created a salary participation commitment, allowing the USLA to continue to effect a more solid program through the State Government. The placement of the program under the administration of the State of Oaxaca, will give the Salvavidas civil service status and insure the full time coverage so greatly needed.

The Turtle Club



The U.S.L.S.A. representatives have presented to the community the Turtle Club. Those participating in the support of the program will receive a hand carved and painted wood turtle with the inscription "We help fund the Lifeguards on this beach for your safety, Swim near a Lifeguard".

The turtle theme will also branch off into Turtle lifeguard support T-shirts, Hand carved and painted wood turtles from Oaxaca, and shells made like turtles. All the promotions from this theme will allow the Salvavidas to generate extra income to expand their service.

The Turtle Club concept will be expanded to the USA. The U.S.L.A. and associated chapters will use promotion eager companies and the news media to generate maximum exposure. The U.S.L.S.A. Mexican Liaison will meet with the authorities in the state capital of Caxaca November 13th & 14th to hopefully finalize the Zicateia program and outline the next phase of creating similar Mexican Lifesaving Clubs under the State umbrella

- 2. Leave the rules as they are with the clarification of 5.11, 2d as mentioned above, and allow the currently competing boats to compete until the year 2001. Solicit a new design from manufacturers with the goal of a USLA one-design, mono hull surfboat. (CSLSA) WITHDRAW
- 3. Increase the number of places that score in Seniors, Senior Women, Masters and Veterans to five, and provide medals through 5th place in those age categories. Scoring would be changed as follows: 1st place: 7, 2nd place: 5, 3rd place: 3, 4th place: 2, 5th place: 1. (South Atlantic) YES

 NOT A RULE CHANGE
- Letter from Australian Competitor requesting to allow a limited number of Australian Master and Veteran competitors to compete in USLA Nationals. Allow them to compete as long as they don't score points or take places away from US competitors. Entry fee to cover cost of commemorative medal, if any.

- ✓ BEACH FLAGS Discussion on how to reduce the number of competitors in Flags at Nationals in order to reduce the time it takes to run the event and to reduce injuries. Committee recommends limit of 10 competitors per Region.
- Discussion of "Separation Rule" for boats. See text of NDA rule in Competition Committee Chairman's report. Much discussion - Idea to use 2-3 experienced water judges in a "committee boat"; judges call out "GIVE WAY." If offending boat fails to yield after 3 verbal warnings, it is disqualified. Change wording of "imaginary circle with a fifty foot radius around each mark" to "within three boat lengths of the mark." After all this discussion, the committee came to realize that this is not really a rule change, since it is not in its final form, and as such cannot be voted on.
- Surfboat Issues After looking at the state of things relative to the boats, the committee decided to withdraw the rule change proposal that would create a new design by 2001 and to continue to lobby for a reasonable solution to the problem of two classes of boats competing against one another at Nationals. Bottom line would be to seek an outside arbitrator to interpret the legality of the two boat designs in the USLA Nationals Rules as they are currently written.
- ✓ Junior Guard Regionals will be at Seal Beach on July 18, 1997.
- ✓ CSLSA REGIONALS are undecided at this time. We would like to go to
 Huntington if the is no conflict with surf contests. Second choice would be
 to negotiate with San Clemente to obtain a better deal than we had this
