I would like to start out dedicating this meeting in memory of Melissa Miller Jeffries, daughter of one of our founding fathers, Dick Miller, and wife of Grant Jeffries of the Long Beach Lifeguard Service. Melissa succumbed to cancer last week, and our prayers go out to her husband and her family. I wish to thank Api Weinert and the COLA Chapter for hosting this meeting.

The members of your Executive Board have been very busy since our last meeting in Del Mar. Our region is hosting the USLA Board of Directors Meeting next month in Hawaii, and the Executive Board has been meeting monthly to plan for that meeting. Chris Graham has done an outstanding job of coordinating and planning the meeting, and thanks to the generosity of Scott Hubbell of SHP, Inc., our regional fundraiser, and our other sponsors, the meeting should be a huge success without bankrupting our regional treasury. Thanks too to Ralph Goto and the Hawaiian Lifeguards. Without their help and support, the Hawaii meeting would not be possible. I hope a few of you have planned to attend the meeting and see what transpires at a USLA National meeting.

Your Executive Board has been working to bring our marketing contract with SHP, Inc. into conformance with the USLA by-laws. It is the opinion of the USLA legal advisor that the CSLSA, as a region of the USLA, did not have the authority to enter into an independent marketing agreement like the one we have with SHP without the consent of the national body. Bill Richardson has been working directly with SHP's attorney to resolve the contract issues in a manner that is acceptable to all parties concerned. We have also contacted another attorney and Bill worked with him to determine the CSLSA's rights in the contract matters. Furthermore, SHP is interested in entering into a marketing agreement with the entire USLA, so hopefully the issues can be resolved and we can move forward. It seems like a win-win situation for the USLA and SHP if logic and a spirit of compromise can prevail, but at this point in time, the issues remain unresolved.

We have continued to work with SHP to supplement our membership kits for the upcoming year. The USLA is providing us with T-shirts and sun care products from Panama Jack, and SHP will be supplying bags and visors courtesy of Arrowhead Spring Water. SHP will also be subsidizing our California Surf Lifesaving Championships, hosted again by Los Angeles County. This year the Junior Lifeguard Championships will be held at Dockweiler State Beach, on

Friday, July 25, followed by the California Surf Lifesaving Championships at Zuma Beach on Saturday, July 26

With the great membership kits we hope to increase our membership numbers over last years total of more than 1400 lifeguard members. I know the JG numbers will be up, because thanks to the efforts of Kyle Daniels and Bob Moore, the Los Angeles County JG's will include membership in the program registration fee. This alone will boost our JG membership by about 2000 members! Thanks to membership committee chairman Don Rohrer, and to Gordon Gray for once again volunteering to use his garage to warehouse and distribute the membership materials. We will be distributing some of the kit materials at the meeting today, but some may not arrive on time and will have to be shipped to the chapters. Please be sure that Don has a contact person and address from you chapter before you leave this meeting.

Although he will not be present at this meeting due to a conflict with the ILS Meeting in St. Lucia, Chris Brewster has continued to do a lot of work for the USLA. He has submitted a written report that will be distributed. Most significantly, Chris finished editing the second edition of the USLA textbook, *Open Water Lifesaving — The United States Lifesaving Association Manual*. The book is at the publishers now and I believe Chris said it should be out by early summer. There are a couple of items in his report that Chris has requested our support on. He also asked me to commend the volunteers from the San Diego Lifeguard Service who went to Bolivia to provide flood rescue training. The following is an excerpt from a report Chris wrote about the trip. "The team leader was Sgt. Albers, an 18-year lifeguard veteran and River Rescue Team Squad Leader. (Albers is a recipient of the United States Lifesaving Association Medal of Valor.) Retired Lt. Marshall Parks, a former River Rescue Team Leader and recipient of the 1999 Higgins and Langley Lifetime Achievement Award volunteered to go, as did Darrell Esparza, also a veteran lifeguard and 10 year River Rescue Team member. Marc Brown, a San Diego lifeguard for 10 years and a River Rescue Team member for two, was to be the fourth instructor. A fifth was also prepared to participate, but a last minute illness intervened. One challenge, particularly considering the highly technical nature of the instruction, involved the fact that very few in Bolivia speak English and none of the team members have strong Spanish skills. Mark Korch, a San Diego lifeguard with eight years of experience and strong Spanish skills stepped forward. Not surprisingly, his skills turned out to be critical to the expeditions success." The weeklong training was basically a train-the-trainer session for sixteen members of the Bolivian Air Force, two police officers, and two civic defense workers. The training team provided the equipment and left it for future use. The group has been nominated for a Higgins and Langley Memorial Award in the field of swift water rescue. On behalf of the CSLSA, I would like to commend these individuals for their volunteer efforts in lifesaving. Perhaps Marshall will give us a more in depth report.

Marshall has been working hard as your competition committee chairman. At the national level he has been heading up a sub committee to revise the officiating organization at Nationals. He is also a member of a sub committee that is looking

at the feasibility of changing the age groups to five-year increments, instead of the current ten year groups. Hopefully he will update us on his progress today.

Vince Lombardi and Eric Sandy continue to provide us with up to date and informative issues of *Cal Surf News*. We are hoping to have some advance copies of the next issue at our meeting today. Vince is also our Webmaster and Recurrent Representative. He has updated the test dates section of the website and continues to post upcoming events. A big thanks is due to Pat Francis for doing the continuing maintenance and upgrades to www.cslsa.org at a very reasonable rate.

Thanks also to Reenee Boyer and Rob Williams for their contributions by attending the monthly Executive Board meetings, and especially for hosting the last one at Newport. I'm sure they will be giving us an update on their committee's happenings. And last, but certainly not least, thank you to Mike Beuerlein, our secretary for keeping track of and recording everything we do (Minutes from past meetings are available in the "Events" section of the website), Treasurer Bob Moore for keeping track of our finances, and Executive Delegate extraordinaire and publisher of *American Lifeguard*, Mike Bartlett. Welcome to Ross Pounds and Terry Murphy, the new co-chairs of the Training Committee, who took over when Scott Diederich stepped down last October.

We will have several presentations today. The returning New Zealand exchange lifeguards, Lindsay Ortega from Huntington City, and Rebecca Levine of Huntington State will be covering the highlights of their trip to New Zealand last January, and we will be presenting heroic acts awards to Chris and Scott Bredesen, and Bill and Brad Davidson for their rescue of two ponga fishermen at k-38 in Baja California. Bill Humphreys will be showing us the scheduling program he created using Excel for the City of San Clemente Lifeguard Service. All and all, this should be a very informative and educational meeting.

1. Hawaii USLA Meeting

- ✓ Prepared the meeting brochures and mailed copies to each member of the USLA Executive Committee. From the brochure format the material to be placed on the USLA/CSLSA websites was also created.
- ✓ Created and printed the "Certificates of Participation" for the USLA Educational Conference.
- ✓ Created, printed and laminated the name tags for all known participants to the USLA Board Meeting. Obtained shell lei lanyards to be used with the name tags.
- ✓ Assigned to obtain a meeting committee vehicle in Hawaii to be used for airport transportation and meeting logistics transportation issues. The costs for the rental were well below original projected and budgeted costs.

2. Scott Hubbell Productions Agreement

- ✓ History
 - o CSLSA signed an agreement with Scott Hubbell Productions, Inc. (SHP) for retention of marketing services in August of 2001.
 - o At the USLA BOD meeting in Idaho, November 2001, Rob McGowan reported the signing of the contract and CSLSA's intent to utilize two sponsors obtained by SHP for kits and operation of the CSLSA Championships in July of 2002.

- o CSLSA, in an attempt to do the right thing for the good of the national organization agreed to advise SHP to hold off until national sponsorship issues were resolved.
- o The USLA President assigned myself and the USLA Legal Advisor (Chip More) to develop some specific “reporting protocols” to avoid future potential conflicts and to attempt to defray the perceived conflict of CSLSA with USLA in marketing matters. The product we developed was voted in as the “Reporting Protocols” to be implemented as a Policy and Procedure at the meeting in November of 2001, with a sunset clause set for the next regularly scheduled USLA Board Meeting at which time the Policy and Procedure would be voted on to become a Bylaw amendment. That action occurred in May of 2002.
- o In November of 2002, the issue was again brought to the floor by Mr. Moore who advised the USLA Board that CSLSA was still in conflict with USLA and advised the following:
 - The CSLSA/SHP contract is void as a matter of law.
 - CSLSA innocently acted beyond the scope of its authority by entering into an exclusive agreement which binds the Region and is in conflict with the nationals (interests).
 - The (SHP) contract is in violation of the Bylaws, Policies and Procedures of USLA.
- o As a result of a vote of the USLA BOD the CSLSA was directed to meet with SHP to quickly rectify this conflict.
- o After about four months of bickering and ineffective communication, I was assigned to contact John Fletcher, SHP’s attorney, to see if the agreement could be amended in any way to meet the concerns of USLA, while at the same time not tying SHP’s hands so as to be ineffective for CSLSA.
- o Two additional months of communication ensued and I felt we were making some inroads to successfully resolving the problem. Unfortunately my evaluation of the situation was incorrect and SHP’s final position was that we have a valid contract and wanted to continue to operate under that agreement.
- o The CSLSA Executive Committee met and decided to seek legal advice from an independent corporate attorney to answer the following three questions:

- a. As a separately incorporated entity, can CSLSA negotiate contracts or agreements on its own behalf.
 - b. Does CSLSA have a valid agreement with SHP?
 - c. Is it true that because the “Reporting Protocols” in the USLA Bylaws were created after the signing of the SHP agreement, that the enforcement of them in regard to that agreement would be an ex post facto application of the bylaw?
 - o Mr. Kenneth Bayer, Attorney at Law, from Utah, was contacted and the issues were discussed. Mr. Bayer asked for and was sent numerous items relevant to the contract, the USLA’s position and the USLA Legal Advisor’s recommendations for changes in the agreement, copies of the CSLSA Articles of Incorporation, Bylaws and Policies and Procedures as well as the USLA Bylaws and Policies and procedures and all relevant communication I had a hand about the matter.
 - o Mr. Bayer reported in a nine page letter that the answer to all the foregoing questions was YES, and backed up his opinion with case law.
 - ✓ The bottom line is that we are currently at status quo. As I see the problem currently, the only issue is with regard to exclusivity and the parties interpretation of that clause in the agreement.
 - ✓ As a result of this independent CSLSA believes it has the authority to negotiate this type of contract, has a valid agreement with SHP and that USLA is acting outside their authority in asking CSLSA to modify or negate the agreement with SHP.
 - ✓ Where we go from here is up to the Executive Committee to discuss before we leave this meeting. The consensus, however is to maintain the SHP contract.
3. Laura Slane, former YMCA Director of Aquatics contacted me to ascertain if USLA would be interested in a cooperative effort between YMCA, American Red Cross and USLA to set specific minimum guidelines for lifeguards, both open water and pools, upon which all three organizations will lend their approval to. She proposed a meeting with each organization sending two reps to a location to be determined in the last week of June.
 4. My next project will be to complete the necessary paperwork and processes to obtain a not-for-profit tax ID number for CSLSA, with a deadline of completion to be no later than the next CSLSA BOD meeting in October.



Executive Delegate's Report

Spring 2003 CSLSA
Board of Directors Meeting

ILS Board of Directors

- I regret being unable to attend this meeting due to a conflict with the ILS Board of Directors meeting, which is being hosted on the Caribbean island of St. Lucia. The location was selected in an effort to help spur development of national lifesaving federations from the Caribbean that can become members of ILS. In conjunction with the Board meeting, a Caribbean Life Saving Conference and lifesaving sport development event, with a lifesaving championship under international rules, are scheduled.

USLA National Certification Program

- I continue to chair the USLA National Certification Program. The program is thriving, with over 100 agencies certified.

USLA Textbook Committee

- The second edition was completed and mailed to the publisher on March 15, 2003 (roughly two weeks past the intended deadline). Extensive work on the part of the Textbook Committee went into this edition. Thanks to Dan McCormick for his editing of the photographs and for having some photographs of certain techniques photographed. It was a lot of work. Thanks also to members of the Textbook Committee (and others) who provided timely and thorough reviews of the chapters. In particular, Dave Shotwell and Eric Bauer provided feedback within a day or two in most cases. That was very helpful. Every chapter was first presented to all members of the Textbook Committee for input. Final versions of each chapter were then sent to the Textbook Committee. As in the past, this has helped ensure a national approach to the manual. Content of the book is greatly improved over the prior edition and many new elements were included that should prove very useful. The second edition title will be, "Open Water Lifesaving--The United States Lifesaving Association Manual" This will hopefully be a little easier for people.
- Carl Martinez will be spearheading development of the additional learning elements for which we are responsible. Specifically, this will include a Test Manager (being handled by Duke Brown), a PowerPoint presentation (being handled by Bob Ogoreuc), and an Instructor's Guide (being coordinated by Mr. Martinez).
- Through December 2002, a total of 12,829 copies of the first edition had been sold. USLA received a royalty check for \$1,252.68 for the period of July through December.

Total earnings to date are \$15,719.22. Our royalty is 10% for regular sales in the United States. Books sold to other countries or via mail order have a fixed 5% royalty.

World Congress on Drowning 2002

- **A publication with papers from an extraordinary array of worldwide experts on drowning and rescue is expected later this year. I am editing a section of the publication related to rescue. Attached you will please find the Final Recommendations of the World Congress on Drowning 2002.**

National Weather Service Collaboration

- **The National Weather Service has voiced a strong interest in collaborating with USLA and Sea Grant to produce rip current posters and brochures. They realize that rip current information produced by NWS has been internally inconsistent, so they created a rip current standardization team. They are not looking to issue watches or warnings, but would like to communicate to the public the hazard level (i.e. low, moderate, or high) and would like to have nationally reviewed and approved posters and brochures produced to explain both rip currents and the daily information on them that would be available from NWS. If NWS, USLA, and Sea Grant could collaborate on a single product, including the logo of all of our organizations, then national standardization and a higher resulting public comprehension might result. Importantly, NWS sees our dissemination routes (i.e. posters and brochures at lifeguard stations, as well as updated tide boards with current hazard level) as ideal routes. Thus, there is the possibility that they would fund the materials, and they certainly would develop the artwork. They are most interested in setting up a team approach that could result in a tremendous boost to the efficiency with which our message is broadcast and the national profile of USLA. Pending approval of the USLA Board of Directors, the target date for completion is May 2004.**

Bolivia

- **In January 2003, under the auspices of the International Life Saving Federation Americas Region flood rescue training in Bolivia was organized and funded. This was a train the trainers program involving a team of flood rescue experts from the San Diego Lifeguard Service, who volunteered their time. Several organizations contributed lifesaving equipment, which was used in the training and left in Bolivia for use by the rescuers. Twenty people from teams throughout Bolivia were trained. Over US \$8,000 in equipment was donated to Bolivia for flood rescue training.**

Mexico

- **Work continues in an effort to organize the various lifesaving efforts in Mexico into a single national federation, similar to USLA and other national lifesaving organizations. This is being led by Victor Zavala of Ensenada, with the strong support of Bob**

Burnside and others. I lend support wherever possible.

American Samoa

- **A group on American Samoa is endeavoring to improve aquatic safety in that area. Drownings there occur for a number of reasons, including lack of swimming skills, strong currents in offshore reefs, and lack of an organized rescue response. Assistance being offered includes advice and public education materials.**

USLA.QRG Upgrade Proposal

- **A proposal has been submitted for a comprehensive upgrade of the USLA site. As Chair of the USLA Website Committee, I am recommending that this proposal be adopted in full. I would appreciate support of the CSLSA Board of Directors. Cost is estimated at \$8,000. As the CSLSA Board of Directors well knows, the USLA website has been and continues to be of great value to USLA and lifeguards throughout the US, as well as the rest of the world. It was one of the first lifesaving sites on the web and is highly visited. Currently the site receives, on average, 55,000 page views per month. This is a high level of traffic that goes beyond many commercial sites, even though we primarily provide a library of information. This upgrade is needed for several reasons:**
 - Adtell, which designed the original site, has dissolved and is no longer providing support.
 - The technology used to create the site is outdated and routine updates are costly in that they must be done by a third party (contractor). This delays updates and increases their cost.
 - Certain elements of the site are not working at all, including membership and statistics submission.
 - The current design of the site does not allow us to take advantage of a variety of new technologies, such as modern banner advertising, which could help generate income.
 - Use of our bulletin boards does not require registration, which might be used to discourage anonymous and inappropriate posts.
- **The full proposal which has been submitted has a number of significant advantages:**
 - It will allow the website editor to make most routine updates immediately and without cost. Examples include USLA contacts (i.e. email addresses, etc. of officers), lifesaving links, certified agencies, etc.
 - It will allow password protecting the bulletin boards.
 - It will allow significant improvements the statistics section, essentially providing agencies the opportunity to use the USLA site to store their own statistics on the USLA site, and to search and query them. USLA would benefit by having real time information on statistics throughout the year. This element of the site was designed by the proposers in concert with Rick Gould.
 - It will allow an updated membership process that will immediately (after credit card verification)

give the applicant a receipt and a membership number. The registrant will be entered into a membership database available to designated USLA officials. This will eliminate concerns about delays in receiving a membership card, but a regular membership kit will be sent as usual. Even the day of a competition, a competitor could conceivably become a member almost instantly through the web-site. If desired, regions could also use this process for mass sign-ups.

- As noted, the cost for full implementation would be \$8,000. It is important to remember that the initial cost of the site was \$5,000. The proposer estimates actual value of the proposal at over \$21,000. Moreover, this proposal will allow savings of updating costs and speedier changes, along with streamlined membership, a significant service with respect to statistics, and many other features. The proposer estimates the potential for advertising income from the site at several thousand dollars per month.
- The company offering this work is composed of lifeguards with some significant experience in the area. They are therefore offering a substantial discount to USLA. They have also done work for California State Parks and Warner Brothers. I have personally reviewed a site designed for the employer of these lifeguards which includes interactive on-line scheduling and extensive reporting of employee activity.
- My thanks to Rick Gould for making the contacts required to get this proposal moving.

Lifesaving Advocacy

- As Chair of the National Certification Program, at the request of the mayor of Destin, Florida, Southeast Region President Jim McCrady and I visited this Florida Panhandle community to review beach safety issues and make recommendations. We met with a wide variety of officials, including the mayor, fire chief, sheriff's department, and tourist development council. This is a relatively affluent community, but provides no lifeguards. Beach ownership and historical experience have led them in that direction. We intend to issue a comprehensive report.

Lifesaving Hall of Fame

Final Recommendations of the World Congress on Drowning Amsterdam 26—28 June 2002

The *Maatschappij tot Redding van Drenkelingen* was established in 1767 to promote awareness of drowning in the Netherlands. The organization has initiated the World Congress project in 1998 to facilitate involved experts, institutions and organizations to further develop insight in methods to reduce drowning and improve the outcome after drowning. The activities merged together during an interdisciplinary, international and interactive convention in Amsterdam in June 2002.

An important result of the World Congress on Drowning, that was attended by more than 500 experts from all over the world, was the establishment of recommendations. The recommendations were prepared by task-forces in the preceding years and extensively discussed by experts during the congress.

Implementation of each recommendation is expected to contribute to a reduction of the annual number of drowning (some 500,000 drowning deaths each year worldwide) and to the improvement of treatment.

On behalf of all participating experts of the World Congress on Drowning, we would like to inform you about these recommendations. We would advocate to study all the recommendations, select those of importance for your organization and include the implementation of the relevant recommendations in your action plans for the coming three years. It is beyond the capacities of our national organization to take care of the implementations worldwide.

The *Maatschappij tot Redding van Drenkelingen* will contact experts and other organizations involved again at the end of 2005 to be informed on the progress and difficulties in the implementation. At that time, the *Maatschappij tot Redding van Drenkelingen* would like to know if the initiative has created new activities and concerted actions in your organization. Based on this evaluation, a new initiative may be taken to give all involved experts, institutions and organizations the opportunity and facilities to meet each other again.

Final recommendations of the World Congress on Drowning Amsterdam 26—28 June 2002

*The World Congress on Drowning is an initiative of
de Maatschappij tot Redding van Drenkelingen
Established in Amsterdam in 1767*

As a result of an interactive process that was initiated in 1998 by nine task forces, including some 80 experts, and finalized during plenary sessions, expert meetings and research meetings in 2002 at the World Congress on Drowning, recommendations were made in the field of drowning prevention, rescue and treatment. This was the first time that many of these subjects were addressed in a global forum.

The congress was attended by more than 500 persons. Although not every participant was directly involved in the development of each recommendation, these recommendations can be considered to be the most authoritative recommendations on the issue of drowning prevention, rescue and treatment at this moment.

Many of the foremost authorities have been involved in the preparations during the four years prior to the congress and have been actively involved during the congress. The draft version of the 13 final recommendations was presented at the plenary closing ceremony of the congress. That preliminary version of the recommendations was distributed by e-mail and adapted as a result of the comments received. An additional series of detailed recommendations in the areas of rescue and diving (breath hold, scuba and hose diving) were agreed upon within the nominated task forces.

This final version of the recommendations was then agreed upon by the members of the scientific steering group and the chairs of the nine task forces (epidemiology, prevention, rescue, resuscitation, hospital treatment, brain and spinal protection, immersion hypothermia, diving and drowning and water-related disasters).

All recommendations, together with the preparatory documents as consensus papers, reports of expert and research meetings, will be published in 2003 in the Handbook on Drowning.

A list of names of the members of the scientific steering group, task forces and attendees of the World Congress on Drowning is included.

1. A new, more appropriate, world-wide uniform definition of drowning must be adopted.

A uniform definition of drowning is important for purposes of registration, diagnosis and research.

The following definition was accepted: “Drowning is the process of experiencing respiratory impairment from submersion/immersion in liquid.”

All organizations involved in epidemiological research and vital statistical data collection as well as rescue organizations and the medical community should consider and preferably accept this new definition as a basis for useful communication and include it in their glossary. Further consultation of drowning experts is needed to uniformly classify morbidity and mortality due to drowning.

2. There is a great need of adequate and reliable international registrations of drowning incidents

International and national registration procedures of the number of drowning victims, immersion hypothermia victims, rescues, and hospital data are needed to better appreciate the world-wide burden of drowning. Also clinical data, for example on resuscitations and rewarming techniques, are needed to improve treatment.

International organizations, such as The World Health Organization (WHO), the International Red Cross and Red Crescent organizations (IRCRC), the International Life Saving Federation (ILS), the International Life Boat Institute (ILF) and Diver's Alert Network (DAN), as well as national organizations, institutions and medical research consortiums are advised to set up and coordinate data-collection.

3. More data must be collected and knowledge gained about drowning in low-income countries and societies

According to repeated WHO reports, over 80% of all drownings occur in low-income countries or in low-income groups in high income countries. Nevertheless only few epidemiological data about these risk groups are available. The WHO, IRCRC, ILS, ILF and the European Consumer Safety Institute (ECOSA) are encouraged to expand the research on drowning risk factors in these low-income groups because this is expected to have a major impact in reducing the risk of drowning.

4. Preventive strategies and collaboration are needed

The vast majority of drownings can be prevented and prevention (rather than rescue or resuscitation) is the most important method by which to reduce the number of drownings. The circumstances and events in drowning differ across many different situations and in different countries world wide. Considerable differences exist in the locations of drowning and among different cultures. Therefore, all agencies concerned with drowning prevention — legislative bodies, consumer groups, research institutions, local authorities and designers, manufacturers and retailers - must collaborate to set up national and local prevention initiatives. These will depend on good intelligence and insightful research, and must include environmental design and equipment designs as a first route, in conjunction with education, training programs and policies which address specific groups at risk, such as children. The programs must be evaluated and the results of the evaluations must be published.

5. All individuals, and particularly police officers and fire fighters, must learn to swim

Knowing how to swim is a major skill to prevent drowning for individuals at risk. International organizations such as WHO, IRCF and ILS, and their national branches must emphasize the importance of swimming lessons and drowning survival skills at all levels for as many persons as possible. The relationships between swimming lessons, swimming ability and drowning in children needs to be studied. In addition, certain public officials who frequently come in close contact with persons at risk for drowning, such as police officers and fire fighters, must be able to swim for their own safety and for the safety of the public.

6. Rescue techniques must be investigated

Most of the current rescue techniques have evolved by trial and error, with little scientific investigation. Rescue organizations such as the ILS, ILF, IRCRC but also the International

Maritime Organization (IMO) must be encouraged to evaluate the self-rescue and rescue techniques in their training programs in accordance with current scientific data on the effectiveness and efficiency. Based on the data, the best rescue techniques must be selected for education and training programs.

7. Basic resuscitation skills must be learned by all volunteer and professional rescuers as well as lay persons who frequent aquatic areas or supervise others in water environment

The instant institution of optimal first aid and resuscitation techniques is the most important factor to survive after drowning has occurred. Resuscitation organizations, such as organizations, in particular those related to International Liaison Committee on Resuscitation (ILCOR), as well as professional rescue organizations and other groups who frequent aquatic areas, must promote training programs in first aid and Basic Life Support for anyone who frequently visits or is assigned to work in the aquatic or other water environment.

8. Uniform glossary of definitions and a uniform reporting of drowning resuscitation must be developed and used

To increase the understanding of the dying process and the resuscitation potential in drowning, a uniform reporting system must be developed and used for the registration of resuscitation of drowning.

International resuscitation organizations, such as JLCQR-related organizations and medical groups, must establish a uniform reporting system, facilitate its use, be involved in the analysis of the data and support of recommendations based on the studies.

9. Hospital treatment of the severe drowning victim must be concentrated

The optimal treatment of drowning victims includes dealing with specific severe complications such as the Acute Respiratory Distress Syndrome, pneumonia, hypoxic brain damage, hypothermia and cervical spine injuries. Due to the limited exposure and experience of most physicians with drowning victims, these victims should ideally be treated in specialised intensive care centres for optimal treatment and promotion of clinical research.

10. Treatment of the patient with brain injury resulting from cardiopulmonary arrest attributable to drowning must be based on scientific evidence. Due to the absence of interventional outcome studies in human drowning victims, current therapeutic strategies must be extrapolated from studies of humans or animals having similar forms of acute brain injury

The following recommendations for care of drowning victims who remain unresponsive due to anoxic encephalopathy are made on the basis of best available scientific evidence. The highest priority is restoration of spontaneous circulation. Subsequent to this, continuous monitoring of core and/or brain (tympanic) temperature is mandatory in the emergency department and intensive care unit (and in the prehospital setting to the extent possible). Drowning victims with restoration of adequate spontaneous circulation who remain comatose should not be actively rewarmed to temperature values $>32-34^{\circ}\text{C}$. If core temperature exceeds 34°C , hypothermia ($32-34^{\circ}\text{C}$) should be achieved as soon as possible and sustained for 12-24 hours. Hyperthermia should be prevented at all times in the acute recovery period. There is insufficient evidence to support the use of any neuro-resuscitative pharmacologic therapy. Seizures should be appropriately treated. Blood glucose concentration should be frequently monitored and

normoglycemic values maintained. Although there is insufficient evidence to support a specific target PaCO₂ or oxygen saturation during and after resuscitation, hypoxemia should be avoided. Hypotension should also be avoided. Research is needed to evaluate specific efficacy of neuroresuscitative therapies in drowning victims.

11. Wearing of appropriate and insulating life jackets must be promoted

Without floating aids, a subject generally drowns within minutes due to swimming failure in cold water. Therefore, the development of insulating and safe garments for aquatic activities is needed. Life jackets should always be worn when immersion can occur to prevent submersion in an early stage. When only non-insulating floating aids can be used, the victim should consider whether swimming ashore is achievable.

12. The balance between safety and profitability of recreational diving must remain critically observed

It was agreed that self-regulation within the world-wide recreational diving industry continues to be the practical route for further improvement but that there is a need to counter the perception that there is a conflict between commercial interest and safety.

13. Safety of diving fishermen needs more attention

Subsistence fishermen, who are predominantly found in the poor countries around the world, use equipment that is minimal and their training, regulations and medical support appear to be zero. To improve diving-fishermen safety and reduce drowning there is a need to collect data on accidents and drowning among representative samples of diving fishermen around the world. This should be followed up with international non-governmental organizations, other charities and appropriate UN development initiatives so that existing academic societies, training organizations and others could deliver suitable medical and diving advice and training for fishermen compatible with the limits of available local resources.

Several more specific recommendations have been proposed and need the full support of related organizations

These recommendations refer to the further development of existing research projects such as:

- Global uniformity of beach signs and safety flags
- Risk assessment of beach hazards
- Determination of optimal visual scanning techniques
- Construction of the most adequate rescue boats, including alternatives such as jet boats, hovercrafts, with minimum risk of injuries for the drivers

Other recommendations were made to improve practical aspects related to:

- Legal aspects of drowning incidents
- Evacuation planning of large passenger ships
- Uniformity in training programs for lifeguards
- Fund raising for aquatic safety activities

All recommendations, together with the preparatory documents as consensus papers, reports of expert and research meetings, will be published in the Handbook on Drowning. The Handbook will be available in 2003.

A large number of additional recommendations were elaborated before and during the World Congress on Drowning by the members of the task forces rescue and diving (breath hold, scuba and hose diving). These detailed recommendations are included in the appendices.

All recommendations need full support from governments, organizations, institutions and individuals to enable reduction of the last remaining field of neglected injuries. Each year some 500,000 persons world-wide are still dying from drowning. This is too much.

Appendices to Recommendations of the World Congress on Drowning Amsterdam 26 - 28 June 2002

Overview recommendations task force Rescue

During the preparation of the World Congress on Drowning, experts have prepared documents on a wide variety of topics. These topics have been further elaborated at the congress by the members of the task force rescue. Because of practical limitations in time, and the wide variety of subjects to be covered, there were no opportunities to include these recommendations in the final procedures.

Recommendations aimed at all national and international governmental bodies, including IMO, Search and Rescue organizations, the International Lifeboat Institution and prevention institutions

1. The existing standard for the evaluation of hazard presented at beaches should be implemented as the world-wide standard to enable the development of appropriate drowning prevention strategies at beaches.
2. Communities throughout the world which can expect to face flooding, must prepare themselves and the emergency workers they designate, to effectively respond to flood rescue.
3. Search and rescue response must be ensured in areas around the world where there is significant maritime traffic, whether it be cruise liners, cargo ships, fishing boats or leisure craft.
4. The International Aeronautical and Maritime Search and Rescue Manual should be reviewed and incorporated by the sea rescue organizations of all of the nations of the world to ensure a coordinated and effective approach to maritime emergencies.
5. The Incident Command System, which has been developed to allow for effective

oversight and organization of emergency responses, should be adopted by all aquatic rescue organizations worldwide.

Recommendations aimed at all national and international bodies in the area of rescue, including the International Red Cross and Red Crescent organizations, the International Lifeboat Institutions and the International Life Saving Federation

1. Scientific study should be undertaken to form a basis for determining the skills and minimum competencies required to rescue another human in an aquatic emergency.
2. Further research is needed in the area of surveillance, scanning and vigilance by lifeguards from a physiological and psychological perspective to determine the best methods of instruction and practice.
3. Further research should be undertaken to identify appropriate use and training of the personal watercraft (PWC) in aquatic rescue.
4. Rescue communications must provide dependable, robust, integrated, and effective command and control for all involved segments of the response system, not simply point to point communications.
5. Sea rescue providers should ensure that their rescue craft keep pace with available technology, evaluating and embracing effective new types of surface rescue craft and air rescue craft.
6. It is recommended that common terms for spinal injury immobilization techniques be adopted by all lifesaving organizations and that the terms should be vice grip, body hug, and the extended arm grip. Studies should be conducted on each of these methods to establish the best possible methods of extrication.
7. All lifesavers should be taught the standing backboard technique, to allow for immediate stabilization of the spine of a person who walks up to the lifeguard complaining of spinal pain post trauma.
8. An international study of fund-raising activities by aquatic lifesaving organizations should be commenced to identify the most effective methods.

Appendices to Recommendations of the World Congress on Drowning Amsterdam 26 - 28 June 2002

Overview recommendations task force task force Diving (breath hold, scuba and hose diving)

During the World Congress on Drowning, experts of the task force Breath hold, scuba and hose diving have finalized a consensus document on a variety of topics.

It was agreed that

1. Well-constructed national regulations have been effective where enforced and that any significant improvements in health and safety would arise only from a more inclusive definition of working divers and a wider application of existing procedures.
2. Self-regulation within the world-wide recreational diving industry continues to be the practical route for further improvement but that there is a need to counter a perception that there is a conflict between commercial interests and safety.
3. The training agencies comply with international quality assurance and control procedures (QA/QC) such as the International Standard ISO 9000 series and also encourage independent monitoring to assure the effective and safe use of existing and new procedures.
4. Subsistence fishermen who are predominantly found in the poor countries around the world, use equipment that is minimal and that their training, regulations and medical support appear to be zero.
To improve diving-fishermen safety and reduce drowning there is a need to collect data on accidents and drowning among representative samples of diving fishermen around the world.
This should be followed up with international non-governmental organisations (NGOs), other charities and appropriate UN development initiatives so that existing academic societies, training organisations and others could deliver suitable medical and diving advice and training for fishermen compatible with the limits of available local resources.
5. The collection of diver morbidity and mortality data and the associated contributory factors for each incident is a necessary first step in reducing drowning incidents among divers. Also needed are the denominator data that will allow the calculation of risk.

6. Recreational divers are free to dive when, where and how they like but the diver also has an obligation to the public. Any underwater accident to a diver can put buddy divers and rescuers at considerable risk.
7. Greater stringency is needed in the assessment of the physical, mental and medical fitness of all who choose to dive. A single assessment of fitness for diving at the beginning of diver training should not be considered valid throughout the rest of the diver's life. Re-assessments are recommended at intervals that may diminish with advancing years and re-assessment may also be needed after illness or injury.
8. To give a medical opinion on a diver's fitness, the doctor should have prior knowledge of the unique hazards faced by a diver. Whenever possible, the medical assessment should be conducted by a doctor acknowledged as competent in this special subject. It is recommended the training of diving doctors, both for the medical examination of divers and also for the treatment of medical emergencies in diving, complies with guidance such as that published by the European Diving Technology Committee (ECHM) and the European Committee for Hyperbaric Medicine (EDTC). Periodical revision training is also important.
9. The mental, physical and medical standards of fitness in each category of diving should be harmonized internationally.
10. Greater emphasis should be placed at all levels of training on the causation and prevention of in-water fatalities.
11. After some 3 to 5 years without regular diving, the individual should be subject to a formal re-assessment of competence before re-entering the water.
12. The policy of training children as young as 8 years old to dive should emphasize the immaturity of mental outlook that many young persons may have when an emergency occurs.
13. Emergency procedures should be consistent with a variety of equipment in a variety of configurations.
14. Programs of refresher training should be established to maximize practical re-learning and updating of basic emergency skills. This is needed particularly after an individual's equipment has been modified.
15. Self-rescue and buddy-rescue procedures should be compatible with the equipment used and the environmental conditions.
16. Training of rescuers should include the procedures for recovery of the victim from the water into a boat and transfer of the patient from the deck of a boat to a helicopter or some other emergency transport vehicle.
17. Hand signals and basic procedures used in diving emergencies, whether at depth or on the surface, should be standardized and promoted through rescue and diving agencies throughout the world.

18. Rescuers must be made aware that the treatment of drowning in a diver might be complicated by other medical conditions such as carbon monoxide poisoning, envenomation and omitted decompression arising from that same dive.
19. National and international standards of medical care should be written for all medical emergencies in diving by suitable academic bodies.
20. Drowning is mostly a diagnosis of exclusion and often is a presumptive diagnosis based on purely circumstantial evidence. All diving-related deaths should be thoroughly investigated, including a complete autopsy, evaluation of the equipment and a review of the circumstances surrounding the fatality by knowledgeable investigators with appropriate training and experience.
The post-mortem examination of a drowned diver should be conducted by a pathologist who is knowledgeable about diving (or who is advised by a doctor who is knowledgeable about diving).

Bookmarks

Last fall, the committee voted to develop bookmarks for distribution material for summer 2003. The bookmarks are here today for pickup from each chapter. We spent \$1,993.02 (\$6.98 under budget). We received a total of 50,000. 42,000 of which are in English, with the remaining 8,000 in Spanish. The Spanish was decided on at the last Executive Board Meeting. Please pick up your chapters before leaving today.

Public Education Marketing

We worked a little with a CSUF marketing class this past fall. With the limited time, they concentrated on Spanish speaking ideas in Orange County. I have the proposal that they came up with if anyone is interested in looking at it. This semester, we were not able to have students work with us since the professor was out on a medical leave. She has promised that she will devote more time to us next fall.

Grant Money

We did not receive the Pacific Life Grant that we applied for last fall. I was planning to submit the proposal again this summer. I am also looking into other possible grants that would help us in funding some projects. I will welcome all help in this area.

Public Education with SHP

I have a meeting set up on Saturday with SHP to discuss possible projects that could be funded by sponsorships. I gave a preliminary wish list to SHP; however, I would like to have some more items from the committee to discuss.

OC Fair and Youth Expo

It is again time to commit your chapters in the staffing of these booths. (I am speaking mainly to the Orange County chapters, however, all are welcome to visit or help) The Youth Expo is next weekend, May 2nd - 4th. The OC Fair is July 11th - August 3rd. These are great public education and community involvement for lifeguards and lifeguarding in general.

COMPETITION COMMITTEE REPORT April 25, 2003

2003 Southwest Regional Championships

It was announced that the location of the 2003 Championships has been changed. The Lifeguard Championships will take place at Zuma Beach on Saturday, July 26, 2003 and the Junior Lifeguard Championships will take place at Dockweiler Beach on Friday, July 25, 2003.

2004-2005 Southwest Regional Championships

An offer by the Long Beach Lifeguard Association to serve as host of the 2004 and 2005 South-west Regional Championships was accepted.

A request to reconsider the issue of changing the day of lifeguard competition from a Saturday to a Thursday beginning in 2004 was raised by Eric Sandy of Del Mar. It was agreed that the Competition Chair and the President of the CSLSA will discuss the issue with the events sponsor.

Beach Run Distance and Configuration

The beach run is to be a 1 lap, 2 K event.

2003 USLA National Championships

The 2003 USLA National and Junior Lifeguards Championships are scheduled to take place in Cape May, New Jersey, August 7-9, 2003. Repeated efforts to obtain more information about the Championships from the Cape May Host Committee have proved fruitless and there was some concern expressed regarding the events status.

A San Diego Surf Lifesaving Association spokesman announced that their club has rooms reserved in Cape May for the Nationals which may be available to CSLSA competitors in need of a place to stay. Equipment transportation was also discussed.

2004 USLA National Championships

The 2004 National Championships are scheduled to be hosted by the Northwest Region of the USLA. In the event the honor is declined, the County of Orange Lifesaving Association has offered to stage the event. During discussion it was suggested this could be a collaborative effort on the part of several Orange County lifeguard agencies. COLA's offer to host the 2004 National Championships will be presented at the 2003 Spring USLA meeting in the event the Northwest Region declines.

5 Year Plan Proposal

The Committee discussed a proposal made at the 2002 fall USLA National Board of Directors meeting to change competition age group categories from 10 year to 5 year increments. The following feedback from the Committee's discussion on the issue will be presented to the National Competition Committee.

Background:

The majority of sports which have age group competitions use 5 year categories. This is done, in part, as an effort to minimize the impact aging may have on competitors and thus make for a more level playing field. The ILS Masters Individual World Lifesaving Championships are conducted in 5 year age categories beginning with age 30.

Proposal:

- Open age group to remain as is.
- The 5 year plan would begin with the current Senior age group and extend to accommodate all competitors; 30-34, 35-49, 40-44, 45-49, 50-54, 55-59, 60-64, 65-69, 70-74, etc.
- Awards and points to top three finishers in each 5 year age group.
- Replace current age group descriptions; Senior, Master, Veteran and Super Veteran, with age group numbers; 30-34, 35-39, etc.

Impact:

Number of Awards

Awarding medals to the top three finishers per 5 year group instead of the current practice of the top five finishers per 10 year group, would increase the number of medals issued per gender by one every 10 years. This would result in an increase of up to eight medals per event.

Number of Points

Currently, points are scored in age group categories, Senior and above, as follows: 1st - 7pts, 2nd - 5 pts, 3rd - 3 pts, 4th - 2 pts, 5th -1 pt, for a total of 18 points per 10 year age group.

Under the 5 year plan, 1st would receive 5 pts, 2nd - 3 pts, 3rd -1 pt, for a total of 9 points per 5 years, no change from the current number of 18 points available per 10 years.

Number of Races

Because heats are already used in some Senior events to accommodate the large number of competitors, it may not be necessary to add additional races to accommodate the 30-34 and 35-39 categories.

For the most part, categories 40-44 and 45-49 could continue to race as one group, as would categories 50-54 and 55-59, and categories 60-64 and up, thus no increase from the current number of races.

Recommendation: The Competition Committee of the Southwest Region supports the 5 year plan proposal as presented above.

Re: TRAINING COMMITTEE REPORT

It is my pleasure to report to the Board and members of the CSLSA. Our group of training officers met this past week.

Recent developments include appointment new co-chairpersons for this group- Terry Murphy from the State of California and Ross Pounds from the City of Seal Beach. One other development is the termination of the college partnership contracts with Santa Ana College. It is our hope that the budget setbacks will eventually improve and these agreements can be reinstated.

With the help of Terry Murphy, a curriculum approved by the college enabled us to teach USLA approved training as well as advanced recurrent and full-time training courses. Although reimbursement has been terminated, the goal of the Southern California Training Officers is build upon this framework and gain recognition from the CSLSA and possibly the USLA, for the purpose of further standardization of advanced training.
