# PRESIDENT'S REPORT TO THE BOARD OF DIRECTORS October 12, 2006

Welcome to the Fall 2006 Board of Directors Meeting in Morro Bay, and many thanks to Herb White for inviting us to the beautiful central coast and for hosting the meeting.

Wow, what a difference a year makes! The summer of 2005 was the summer that never was, with little surf, lousy weather, but lots of stingrays, jellyfish and red tide. The summer of 2006 was quite the opposite with great, record setting weather, the hottest July in history, some good surf, tropical water conditions (heard Huntington City recorded a water temperature of 81° in July). I felt like I lived in the tropics quite a few days this summer. I haven't seen any official statistics yet, but I would wager that 2006 will go down as one of our busiest summers of all time.

Following our Regional Board of Directors Meeting hosted by Huntington City last April, most of the members of your Executive Board attended the USLA National Meeting in Annapolis, Maryland at the end of April. USLA National meetings were moved to the last week in April, from the first week in May to better accommodate summer preparedness. At the meeting our very own Mike Bartlett, Executive Delegate from Huntington Beach was awarded the Medal Of Valor. On March 3, 2005 Mr. Bartlett performed an impressive rescue of three persons near the Huntington Pier. The individuals were swept off a sand bar and caught in a dangerous rip current. Mike grabbed a rescue buoy and fins, swam out to the first victim and then proceeded to tow the first victim with him to rescue the second victim. Now with two people in tow, Mike swam out to the third swimmer who was going under water when he arrived. Witnesses in Tower Zero said it was one of the greatest rescues they had ever witnessed and that Mike's efforts undoubtedly saved three lives that day. Another highlight of the meeting was that I was honored with a Life Membership in the USLA to go along with the CSLSA Life Membership that was presented to me at the Spring Meeting in Huntington. I am truly honored to be among such esteemed members of both organizations. Also honored with Life Memberships at the Annapolis meeting were Jerry Gavin, USLA Vice President from the Great Lakes Region and Buzz Mogck of the Mid Atlantic Region. Other highlights of the meeting included a tour of the U.S. Naval Academy and the adoption of the revised USLA Bylaws. A proposal was approved to upgrade the USLA membership process by entering into a contract with Interfuse, the company currently doing our USLA Nationals results. The goal is to have membership and renewals done electronically via the Internet. Kevin Sweat was appointed manager of the USLA National Team for Rescue 2008 in Germany.

Beginning in April and running through the first week of June, Huntington City's Steve Reuter organized and ran a series of "Big Wednesday" fundraisers in conjunction with Duke's Restaurant. During a photo op in August, I accepted a check for almost \$8000.00 from Duke's to be used for a new Public Education poster. Great work Steve, and thank you very much.

On July 22 I attended the Long Beach Lifeguards' Centennial Celebration, aboard the Queen Mary, commemorating 100 years of lifeguard service. The organizers did an outstanding job and it was a gala event, highlighted by a spectacular lightning show, courtesy of Mother Nature, and a rescue boat parade with boats from most of the Southern California lifeguard services. They also produced a very nice program detailing some of the history of lifesaving in Long Beach. The *Eliminators* surf band entertained the crowd with their classic surf music, and *Art The DJ* provided dance music. All and all it was a magnificent event, and I'm sure a good time was had by all in attendance.

The 2006 California Lifequard Championships were held at Redondo Beach in conjunction with the International Surf Festival on August 5. Once again, we are indebted to Scott Hubbell and his company SHP, Inc. for providing funding not only for our Regionals and Nationals, but also for our membership kits. If not for his support, our regional treasury would be much poorer. Patagonia was one of the lead sponsors and provided a \$1000.00 check to our region for support. Gary Crum and the members of the International Surf Festival committee are owed our gratitude for including us and helping make our Regional Championships a success. Special thanks are due to Dick Douglas, voice of the Surf Festival, for coming down early in the morning, on his own time, to set up the sound system. In spite of a delayed start, due to a combination of factors, the Regional Championships went very well. The weather was good, there was enough surf to make things interesting, and the competition was keen. It was the closest team points contest in quite a long time, with LACOLA beating out second place Cal State Parks by only 68 points. Huntington City, lead by Micha Burden, finished third, their best results in recent memory. It was good to see Surf City represented so well, I hope it will continue! The other top teams, as well as individual results are available for viewing on our website at www.cslsa.org. Without the generous donation of the time and resources of your Executive Board and other volunteers, the Regional Championships would not be possible. In addition to current Executive Board members, if you competed, you should take the time to thank Bill Richardson the starter, Jay Butki and Scott Diederich for setting the course, former Executive Board member Vince Lombardi for officiating, Tracey Crothers of L.A. County for her excellent work at the Recorders Table, and Gordon Gray for his efforts at the Registration Table. If I've forgotten anybody else, I apologize. Next year's Regionals are still somewhat up in the air . . . Huntington City has expressed an interest, but they are not confirmed. If your Chapter or agency is interested, please bring a proposal to our next Board of Directors Meeting in Morro Bay in October.

The Junior Lifeguard Regional Competition was hosted by Santa Barbara City on July 21. Although I was not able to attend, from all reports I heard, the event was excellently organized and very well run. Good job Santa Barbara, and thank you. Results are available on the Junior Lifeguard page of our website.

The 2006 USLA National Lifeguard Championships were hosted by Huntington State on August 10 through 12. Gus Avila, Herb White and Craig Lumb did an excellent job of heading up the organizing committee. Once again the weather and surf cooperated and the event ran smoothly. SHP, Inc. came on board and provided some great sponsors including Bud Light, Patagonia, Scion, Arrowhead Water and Wet and Wild Cosmetics. Other sponsors included Court TV, the California State Parks Foundation and Ingram. There were also over a dozen vendors that contributed to the success of the National Championships. The U.S. Navy Seals performed two outstanding skydiving exhibitions, one of them dedicated to the memory of Ronnie Tassin, a former Huntington State Lifeguard that all of us that knew him will greatly miss. When the dust settled, LACOLA took the large team "A" title by probably the largest margin in USLA history. They outscored second place Volusia County, Florida by over 400 points. Cal State Parks took third, San Diego was sixth and Huntington City place seventh. In the small teams division Laguna Beach placed fourth and Del Mar came in ninth. As always, the USLA Corp of Officials did a great job and I was delighted with the opportunity to be the event announcer. Congratulations to Blaine Morgan of LACOLA and Micha Burden of Huntington City for winning the overall Men's and Women's points titles. The "after party" featuring the Tijuana Dogs was one of the best ever, even Bob Moore enjoyed it! Complete results can be found at www.uslanationals.org.

The California / New Zealand Lifeguard Exchange interviews were held on September 7, 2006, and I would like to congratulate Ryan Steele of California State Parks - Crystal Cove, and Doug Leach of City of Huntington Beach for being selected for the 2006 – 2007 exchange. They will be traveling to New Zealand at the end of the year. Congratulations to Cavan Cuyler of the City of Newport Beach, the first alternate, and many thanks to the interview panel Mike Scott of Lake Mission Viejo, Joe Bailey of the City of Seal Beach, and Bob Moore of L.A. County (retired), and to the City of Newport Beach for allowing the use of its headquarters for the interviews.

The next USLA National Meeting is being hosted by the Pacific Northwest Region at the Ridge Tahoe Resort on Lake Tahoe's south shore on November 2 through 4. SUBJECT: CONFLICT OF INTEREST POLICY

# A. Purpose

The purpose of this conflict if interest policy is to protect the interests of the California Surf Life Saving Association (CSLSA) when it is contemplating entering into a transaction or arrangement which might benefit the private interest of an officer or director of CSLSA or might result in a possible excess benefit transaction. This policy is intended to supplement but not replace any state and federal laws governing conflicts of interest in nonprofit and charitable organizations.

### B. Definitions.

- 1. "Interested person" means any director, principal officer, or member of a committee with governing board-delegated powers, who has a direct or indirect financial interest, as defined below.
- 2. A person has a "financial interest" who has, directly or indirectly, through business, investment or family:
  - a. An ownership or investment interest in any entity with which CSLSA has a transaction or arrangement,
  - b. A compensation arrangement with CSLSA or with any entity or individual with which CSLSA has a transaction or arrangement, or
  - c. A potential ownership or investment interest in, or compensation arrangement with, any entity or individual with which CSLSA is negotiating a transaction or arrangement.
- 3. "Compensation" includes direct and indirect remuneration as well as not-insubstantial gifts or favors.
- 4. A financial interest is not necessarily a "conflict of interest." A person who has a financial interest may have a conflict of interest only if the governing board or appropriate committee decides, pursuant to Section C-2 of this policy, that a conflict of interest exists.



### C. Procedures

- In connection with any actual or possible conflict of interest, an interested person must disclose the existence of any financial interest and be given the opportunity to disclose all material facts to the governing board and members of committees with governing board-delegated powers considering the proposed transaction or arrangement.
- After disclosing the financial interest and all material facts, and after any discussion with the governing board or committee, the interested person shall leave the governing board or committee meeting while the determination of a conflict of interest is discussed and voted upon. The remaining board or committee members shall decide whether a conflict of interest exists.
- 3. If a conflict of interest is determined to exist,
  - a. An interested person may make a presentation to the governing board or committee, but after the presentation, he/she shall leave the meeting during the discussion of and voting upon the transaction involving the possible conflict of interest.
  - b. The chairperson of the governing board or committee shall, if deemed appropriate, appoint a disinterested person or committee to investigate alternatives to the proposed transaction or arrangement.
  - c. After exercising due diligence, the governing board or committee shall determine whether CSLSA can obtain with reasonable efforts a more advantageous transaction or arrangement from a person or entity which would not give rise to a conflict of interest.
  - d. If a more advantageous transaction or arrangement is not reasonably possible under circumstances not producing a conflict of interest, the governing board or committee shall determine by a majority vote of the disinterested directors or committee members whether the transaction or arrangement is in CSLSA's best interest, for its own benefit, and whether it is fair and reasonable.
  - e. In conformity with the above determination it shall make its decision as to whether to enter into the transaction or arrangement.
- 4. If the governing board or committee has reasonable cause to believe a member has failed to disclose an actual or possible conflict of interest, it shall inform the member of the basis for such belief and afford him/her an opportunity to explain the alleged failure to disclose.



5. If, after hearing the member's response and after making such further investigation as may be warranted by the circumstances, the governing board or committee determines the member has failed to disclose an actual or possible conflict of interest, it shall take appropriate disciplinary and corrective action.

#### D. Records

The minutes of the governing board and all committees with board-delegated powers shall contain:

- The names of all persons who have disclosed or who otherwise were found to have an actual or possible conflict of interest, the nature of the financial interest actually or possibly giving rise to the conflict of interest, the action taken to determine whether the conflict of interest existed, and the board's or committee's determination.
- 2. The names of the persons who were present for discussions and votes relating to the transaction or arrangement, the content of the discussion, including any alternatives to the proposed transaction or arrangement, and a record of any votes taken in connection with the proceedings.

# E. Compensation

- 1. A voting member of the governing board who directly or indirectly receives compensation from CSLSA for services is precluded from voting on maters pertaining to that member's compensation.
- 2. A voting member of any committee whose jurisdiction includes compensation matters and who directly or indirectly receives compensation from CSLSA for services is precluded from voting on maters pertaining to that member's compensation.
- No voting member of the governing board or any committee whose jurisdiction includes compensation matters and who directly or indirectly receives compensation from CSLSA for services is precluded from providing information to any committee regarding compensation.

### F. Annual Statements.

Each director, principal officer and member of a committee with governing board-delegated powers shall annually sign a statement which affirms that such person:

- 1. Has received a copy of this conflicts of interest policy,
- 2. Has read and understands the policy,
- 3. Has agreed to comply with the policy, and
- 4. Understands that CSLSA is charitable and in order to maintain its tax exemption it must engage primarily in activities which accomplish one or more of its exempt purposes.



- G. Periodic Reviews; Use of Outside Advisors.
  - To insure that CSLSA operates in a manner consistent with its charitable purposes and does not engage in activities which could jeopardize its tax-exempt status, periodic reviews shall be conducted, including at a minimum:
    - a. Whether compensation arrangements and benefits are reasonable, based upon competent survey information, and the result of arm'slength bargaining.
    - b. Whether partnerships, joint ventures and arrangements with management organizations conform to CSLSA's written policies, are properly documented, reflect reasonable investment or payments for goods and services, are in furtherance of CSLSA's charitable purposes and do not result in inurement or impermissible private benefit or in an excess benefit transaction.
  - In conducting these reviews, CSLSA may, but is not required to, use outside advisors. If outside advisors are used, their use shall not relieve of the governing body of its duty to ensure that periodic reviews are conducted.

# Delegate/Certification Activity Report April 6, 2006

**Proposed Television Contract.** I participated in discussions with six (6) regional USLA reps regarding a proposed television contract for the USLA 2007 National Championships.

**ISSUE:** Should the USLA Executive Committee enter into a proposed television contract without bringing it to the entire Board of Directors? For discussion and resolution.

**RESULT:** The issue of the proposed television contract negotiations will come before the National Board of Directors at its next meeting in November.

**Communications.** I have fielded many inquiries on various association subjects either through telephone or by e-mail contacts. All inquiries have been answered or referred to appropriate contacts for additional information or resolution.

**Certification.** The CSLSA Vice President was contacted by the City of Del Mar Lifeguards regarding a certification problem that has existed between that agency and the USLA for some three (3) years. Ms. Graham referred the issue to me.

I contacted the Del Mar representative. We had an extensive conversation on the issues and Del Mar's prior challenges in seeking recertification. After the discussion, I asked Del Mar to complete a new application and forward it to me. Del Mar did complete a new application. I have their submission here for further review.

As I understand the certification problem, there were two (2) issues with the prior submission. One issue dealt with the number of hours dedicated to First Aid training, and the second appears to be some confusion over Del Mar's classification of "Student Lifeguard." After reviewing the new application, the issue dealing with hours dedicated to First Aid training seems to be addressed and is no longer a problem for certification. On the second issue, that of "Student Lifeguard", I will ask Reenie Boyer and Charlotte Graham to review this Del Mar classification. It appears that the Del Mar "Student Lifeguard" classification parallels what many other agencies refer to as a "Cadet Classification". If Boyer and Graham agree with my assessment, I will ask the CSLSA Board to support the recertification of Del Mar with the intent of taking the Del Mar application to the National meeting with affirmative support from CSLSA.

**New Certification Level.** I am continuing to explore a concept of adding a new and higher level of certification than currently exists. This new type of certification would mirror one which is used by many fire departments across the nation. The new level would be a "Class One Lifeguard Service". This would be the highest level of certification that a lifeguard agency could receive within the USLA. We have many agencies that far exceed the requirements for Advanced Certification. As an organization, we should be able to properly recognize these agencies.

# Brian Knorr – Heroic Act Submission

We will be reviewing a submission by Mike Bartlett from HBSLSA to honor Brian Knorr of the Huntington Beach Police Department, for his rescue of 83-year-old Eleanor Smith, a female driver who lost control of her car and was trapped in the almost completely submerged vehicle in a storm drain containing 4-6 feet of running water.

Knorr's timing was critical to the successful rescue of Smith as moments after he extricated her from the vehicle it became almost completely submerged, with water well over the driver's compartment.

Officer Knorr then had to remain in the water with the victim until fire personnel arrived to help remove he and the victim from the storm drain due to the extremely steep side of the channel. All personnel involved in the rescue concurred that had Knorr not acted immediately, Smith very likely would have drown.

# Alternate Executive Delegate Report to CSLSA Board of Directors

# October 12, 2006 Morro Bay, California

Subcommittee Chair for Legislation and Statistics

To All,

We have just concluded a summer that will be a benchmark in years to come. Although most programs have not compiled their 2006 end-of-the-year aquatic safety statistics, it is safe to say that records have been broken. With documented water temperatures from San Diego to Los Angeles counties reaching the 70's by mid-June and continuing until late August, and water temperatures as high as 76 degrees recorded off of Orange County beaches during July, lifeguards along California's coastal and inland water areas have been challenged to meet the demands of the job during record heat waves.

Meanwhile the surf seemed to come in weekly waves from both our neighbors south of the border and south of the equator. Record inland temperatures combined with warm ocean temperatures, phenomenal crowds, surf, rip currents, Lifeguard Nationals in California, yellowtail and dorado by the score in the Channel...all the ingredients were there. It was truly a summer to remember! I would anticipate that California will have record setting rescue statistics when we report in to the USLA.

On June 1, 2006 I attended a meeting that I helped to coordinate between the Orange County Lifeguard Chiefs Association and Charley Hurley, Deputy Chief with the State Office of Emergency Services, Fire/Rescue Branch. A good dialog was established to discuss the issues surrounding the establishment of codified requirements for California's open water lifeguards.

Regarding statistics, at the request of CSLSA President, Rob McGowan I have contacted the USLA Statistician, Rick Gould about the feasibility of conducting a training class on gathering USLA aquatic safety statistics at the USLA Board of Directors Meeting at Lake Tahoe. Included in this would be a presentation on the rescue card scanning query program that California State Parks currently uses. As President McGowen has said, "We need to know more about rescues!"

We have entered the new legislation period in California. Some of the issues that I am currently aware of include:

- Dept. of Boating and Waterways conducted a series of two public meetings to discuss vessel operators licensing/training requirements. USLA President, Chris Brewster attended the meeting in Los Angeles and advised that there is a serious obstacle in passing such legislation due to recreational boating vendors groups and some owners.
- California State Parks is seeking a legislative remedy for so that we may regulate the possession of alcohol on State Park property.
- A recent California Supreme Court decision concerning liability stemming out of a case involving a drowning of a 14-year old boy in a designated swim area at a man-made lake near Oakland, California. The case, involved the East Bay Regional Park District in action by plaintiffs for negligence and wrongful death, arising from the drowning death of Jason Perry, the 14-year-old. On appeal, plaintiffs contended the court erred when it found defendants were immune from liability, pursuant to Government Code section 831.7,1 and granted defendants' motion for summary judgment.

The immunity for the East Bay Regional Park District was upheld by the Supreme Court. However, there are some interesting points made in the decision and programs with man-made lakes and designated swim areas (especially if they charge a fee for swimming) are well advised to review this court decision.

I will be conducting a Legislative sub-committee meeting during our board of directors meeting, if you have any updates on pending legislation, or suggestions concerning statistics, please attend.

## Public Education Committee Report - Fall 2006 October 12, 2006

Over the past 6 months, the Public Education Committee has been working on the following projects/issues:

- 1. Duke's Big Wednesday Fundraiser was a tremendous success raising nearly \$8,000. A big "Thank You" goes out to Steve Reuter of Huntington Beach for not only suggesting the program, but implementing and coordinating the entire series of events. Steve apologizes for not being able to attend today's meeting. Thanks to all the chapters which provided host members at the 8 events.
- 2. Melissa Murphy has designed the CSLSA's "Be Seen, Be Safe" poster design, which will be printed using the funds generated by the Big Wednesday event. Payment is pending a written agreement allowing CSLSA to right to use the design as determined by the Public Education Committee. Thank you to Melissa for her hard work and great design, which was approved by committee members via email during the summer.
- 3. National Beach Safety Week (NBSW). Last spring, I reminded chapters of the importance of promoting NBSW through local governmental proclamations. Sample proclamations are available on the USLA website. Unfortunately, participation in this program is very limited. Our goal is to increase participation in this process, in order to reach more people with the important messages regarding beach and water safety. ### Training Officers Report Fall Meeting 2006

As reported in the Fall meeting of 2005, the Orange County area training officers have been working on a three tier certification program for full-time lifeguards. The certification will be based on years of experience as a full time lifeguard, certifications, and abilities to apply gained knowledge. The goal of this process will be to have both the OCTOA and the Orange County Chiefs Association sanction each certification. The process for certification will involve the following steps:

- Completion of a particular level's requirements and acquisition of that levels certifications
- Agency Training Officer reviews applicants file
- Agency Chief writes a letter of approval for certification
- Orange County Training Officers Chair reviews applicants file
- Orange County Chiefs Association Chair reviews applicants file
- Certification

Each lifeguard's agency will retain the original file and OCTOA will retain a copy of the file. The three levels of attainment will be titled "Basic, Intermediate, and Advanced Professional Lifeguard". The attached page outlines the discussed parameters of each certifications requirement.

#### **Future Training and Meetings**

Although mutual aid dives have been the bread and butter of training for the past few years, it has been expressed that a broader level of training be explored. As full time lifeguards, we are sometimes asked to perform tasks that may be agency specific and not something we may be necessarily familiar with or have recently performed. With that in mind, 2 out of 3 of the next training events have been planned to address this concern and all agencies are encouraged to participate. These trainings will be designed to give guards a basic level of awareness.

- Talk with Jay Butki regarding recouping costs and the procedures for recouping costs for equipment set-up and materials.
- Gave details of event management
- Advised that all national issues relative to operation of the event must be given to the local planners no later than six months in advance.
- All Junior Guard issues must be addressed through Tom Daly.

Recommended core officials be selected for the Junior events and must be made familiar with individual division event rules and general operation procedures.

- 100 medals are still unclaimed from the 2006 championships. They will be taken to the National meeting in Lake Tahoe for distribution to the regions.
  - ✓ Recommended distribution of awards immediately following the event.
  - ✓ Discussion needs to follow at the national meeting for the best methodology to accomplish this.
- Gus expressed the feeling that the \$7,000 required to be paid by the host is ridiculous in the face
  of having no sponsors. This forces the host to be \$7,000 in debt before even starting the
  process.

Recommend that this be conveyed at the national meeting.

#### 2. Location for 2007 Regional Games

- It was agreed by the Committee with concurrence from Santa Barbara Chapter that the Junior Regionals will be conducted at Santa Barbara as recommended by the Junior Guard Committee. The event will be conducted on Friday, July 20<sup>th</sup>, 2007
- Huntington Beach SLSA asked for and was granted permission to host the California Surf Lifesaving Championships between City towers 19 and 17 (Beach Blvd.) on Saturday, July 28<sup>th</sup> 2007.

Santa Barbara Chapter agreed to be the back-up for Huntington if they are unable to host the event. However the date would then change to Saturday, July 21<sup>st</sup>, 2007. Huntington will provide as much lead time as possible for this eventuality.

### 3. Proposals from Jay Butki for revisions to the USLA Competition Rules so as to mirror ILS whenever possible.

MSC to support Mr. Butki's proposal to USLA. MPU

#### 4. Requests by Jay Butki

A. For CSLSA to donate \$1,000 to the LACOLA Trust Fund to assist the California Lifeguard Team in getting to Melbourne, Australia for the 19<sup>th</sup> Wieland Shield competition.

MSC to make the donation as requested. MPU

B. Request monies budgeted and allocated toward the CSLSA competition trailer be spent to reimburse Jay Butki for over \$3,000 used to purchase stock items for the trailer with all items necessary to host the 2006 nationals and all future USLA sanctioned competitions in the Southwest Region.

Mr. Butki will submit the receipts to the CSLSA Treasurer. The USLA Competition Committee has pledged to reimburse Mr. Butki \$500 for some of these expenditures.

MSC to reimburse Mr. Butki for receipts submitted to the CSLSA Treasurer. MPU

Discussion ensued regarding seeking approval for future expenditures in advance with a cap on such expenditures.

#### 5. 2008 National Championships

Asked for all Chapters to consider the possibility that the 2008 games may come to the Southwest Region and asked for interest.

#### 6. Competition Trailer

It was explained that the trailer has been stored at LA County since it was purchased. It must be moved within the next month. The original procedure was to have the next host of the Regionals to store the trailer at a location in their area.

Huntington will look into this. Mission Viejo advised that they may have a location as a back-up to Huntington.

#### Legislative Sub-Committee Meeting Report 10/13/06 Morro Bay, California

We conducted a short meeting at the beginning of the general meeting on Friday the 13<sup>th</sup>. The following items were discussed. Action items are identified below each item.

• Item I: Dept. of Boating and Waterways has conducted a series of two public meetings to discuss vessel operators licensing/training requirements. USLA President, Chris Brewster attended the meeting in Los Angeles and advised that there is a serious obstacle in passing such legislation due to recreational boating vendors groups and some recreational boaters associations.

Action Item: Continue to monitor this issue.

• Item II: California State Parks is seeking a legislative remedy for so that we may regulate the possession of alcohol on State Park property.

Action Item: None

• Item III: A recent California Supreme Court decision concerning liability stemming out of a case involving a drowning of a 14-year old boy in a designated swim area at a man-made lake near Oakland, California. The case involved the East Bay Regional Park District in action by plaintiffs for negligence and wrongful death, arising from the drowning death of Jason Perry, the 14-year-old. On appeal, plaintiffs contended the court erred when it found defendants were immune from liability, pursuant to Government Code section 831.7,1 and granted defendants' motion for summary judgment.

The immunity for the East Bay Regional Park District was upheld by the supreme court. However, there are some interesting points made in the decision and programs with man-made lakes and designated swim areas (especially if they charge a fee for swimming) are well advised to review this court decision.

**Action Item:** Alex Peabody to forward Bob Moore a copy of the PDF document on the court decision for posting on the CSLSA website.

### MEMBERSHIP WORKSHOP REPORT OCTOBER 12, 2006

- A "Membership Committee Chapter Representative Contact List" was circulated, and the chair will coordinate with the Recurrent Rep and the Secretary to get additional chapter representative information, in order to compile a definite contact list for distributing information before meetings and contacting chapters throughout the year about membership and other issues.
- Discussion ensued about future membership registration under the Interfuse system, and committee members expressed various features they would appreciate in order to make collecting and recording of membership more user-friendly. The committee strongly feels that membership needs to go from chapter to region to national, in order to maintain span of control.
- Before full implementation of the Interfuse system, our region will utilize new
  application forms to begin to gather new information requested by the national
  membership committee. These include gender, date of birth/age, ethnicity, and
  email addresses. It was again stressed that collecting this information would be
  voluntary. New membership data lists would include columns for these categories,
  if it was collected.
- Unsold membership kits were collected from Newport Beach, Camp Pendleton, LA
  County Lakes, and Long Beach. Kits for chapters with more members than
  estimated at the Spring Meeting were distributed, including Cal State, Imperial
  Beach, Laguna, Oceanside, and San Clemente. Additional kits still owed to LA
  County, Huntington City, and San Diego.
- The committee discussed kit ideas for 2007. We will request one larger item from SHP, Inc., per our contract (?), and will also purchase an additional 2 items for the kits. Our top request from Hubbell will be towels, and several committee members will get quotes from their vendors to present to him. Our 2<sup>nd</sup> request would be long-sleeve T-shirts, and 3<sup>rd</sup> choice is short-sleeve T-shirts. The committee would like to use the artwork designed by Melissa Murphy for the Public Education poster if we get the T-shirts instead of towels.

In addition to CSLSA window stickers, still available for 2007 kits from our previous purchase, the committee would like to get a new mug for next year's kit, and a lanyard lip balm. The committee chair will also check with SHP, Inc. on the possibility of sunscreen for next year's kits.

The membership chair will request a \$5000 line-item allocation for the 2007 fiscal year for purchasing membership kits items during new business on Friday.

#### NEWSLETTER COMMITTEE ACTION REPORT – FALL 2006

In Committee, two major topics were discussed: 1) printing the CalSurf in color vs. black and white; and 2) problems with soliciting advertisers. While the Committee supported the concept of color printing, it was suggested that the less expensive option of a color cover (essentially four pages) and black and white inner pages would be more palatable to the Board, and that this should be recommended for at least the next two issues. It was noted that providing a color cover might help attract advertisers, thereby possibly helping to resolve the second major issue. It was also recommended that the cost for advertisement be increased for color ads, while keeping a less expensive black and white option for those advertisers that can't commit to a more expensive ad. If demand for color ads was high, an option of a color centerfold was discussed. The additional cost would have to be offset by the ad revenue. While discussing advertising, it was suggested that vendors that support CSLSA and provide discounts for members be given consideration for ad space at reduced or no cost. The dilemma would be that these sponsors would take space from revenue producing ads and there might also be contractual conflicts. It was noted that there were few vendors that offered discounts to recurrents, and that perhaps "recurrent-friendly" vendors should at least be given recognition by providing a list of such vendors in the CalSurf.

Another topic discussed was direct mailing to members, rather than bulk shipping to chapters. The cost difference would be relatively small, and the Committee recommended that this be done starting with the next issue (Spring 2007). During this discussion, a recommendation was made to research the possibility of eliminating printing altogether and produce an electronic newsletter. While potential problems with this method exist, it was agreed to research it and possibly poll the members through a notification in the next issue.

Finally, the issue of a budget for the CalSurf was discussed. It was decided to ask the Board for an annual budget of \$7300 to design, print and mail the newsletter. This budget would be utilized at the discretion of the Committee Chair, with input from Committee members and the Board, with many costs being potentially offset by revenue from advertisers.

#### Public Education Committee Minutes - Fall 2006 October 13, 2006

The following was discussed at the Public Education Committee meeting on October 12, 2006:

- 1. Duke's Big Wednesday Fundraiser was a tremendous success raising \$7,905.14.
- 2. The committee allocated \$600.00 for payment to Melissa Murphy for her "Be Seen, Be Safe." Poster design. The payment is pending a written agreement allowing CSLSA the right to use said design as determined by the Public Education Committee. Follow up by Gus Avila and Mike Beuerlein. Note: Subsequent to the committee meeting, further discussions with Steve Reuter revealed that the agreement with Melissa (who was not present at the meeting) was for \$400 for all work. An agreement was developed by Gus Avila and Mike Beuerlein and presented to Melissa. Melissa signed the agreement and was paid \$400 for the use of the artwork.
- 3. The Committee has allocated up to \$1,100.00 to be used for the purchase of 17 framed posters to distribute as thanks to the sponsors of "Big Wednesday." Of the allocated moneys, two framed, matted posters are to be purchased in addition to the 17 others as special gratitude toward Duke's and Steve Reuter. Follow up by Mike Beuerlein and Doug Leach.
- 4. The Committee allocated \$5,000.00 of the remaining funds towards the production of the "Be Safe, Be Seen "posters. The Committee would like to see 600 posters of higher quality (possibly laminated) to be distributed to the chapters for display purposes, window displays, and classroom displays, etc. The remainder of the posters will be of lower quality intended for give away purposes.
- 5. The remaining \$1,205.14 will be held over for reprint or any unforeseen costs. Melissa Murphy presented the committee with two educational poster designs that could be purchased at the cost of \$1,000.00 each. The committee is interested in the idea of the posters, however is not willing to purchase the designs at this time. Melissa Murphy is encouraged to attend the spring meeting and "pitch" the idea again at the Public Education committee meeting. Doug Leach Follow up.
- 6. The committee has a line item budget of \$5,000.00 dollars. \$4,000.00 allocated to Pub Ed. and \$1,000.00 from Junior Guards. The Committee requests \$2,500.00 to purchase book cover featuring the Junior Guard Poster contest winner's artwork. Mike Silvestri will follow up.
