  - 3. Ryan Gates from CA State Parks initiated a discussion regarding the ongoing recruitment challenges and how the CSLSA could assist in salary negotiations.
  - 4. Mr. Sholl stated that the California Marine Safety Chief's Association has a cadre working on the recruitment issue which includes a professional marking company that has made themselves available to all agencies. Contact Mr. Sholl for more information.
  - 5. Mr. Avila stated that CSLSA can support a position taken by a third party but cannot be involved in union or collective bargaining issues.

While other regions are showing an increase in younger volunteers, the Southwest is not. We need more officials and there needs to be a means of supporting their travel and lodging expenses. Mr. Beuerlein wanted it stated in minutes that the Lifesaving Sport Committee will take this issue to the national meeting in Redondo Beach. Mr. Richardson commented that the USLA should have enough money to assist and that our region needs to have more representation from our officials at the event.

- Mr. Carey for working with the individual chapters and agencies, serving as a liaison between the CSLSA and the agencies, serving as a liaison to the California Marine Safety Chiefs association, and continuing to work to improve professional standards.

#### Continued Goals for the CSLSA

As mentioned at our fall meeting, some current goals of mine for the organization are to:
1) improve and enhance relationships between the CSLSA, agencies, and Chapters; 2) assist new and existing committee chairpersons and committee members; and 3) look to ways enhance funding opportunities for our organization so we can better serve our members and the public.

To help meet these goals, the following are three specific areas of focus for the CSLSA:

- Continue to build and refine a liaison program to bridge between chapters, agencies, and the CSLSA. This is a continuation of a project we are working on. Although we are a member/chapter-based organization, it is critical that we stay in close contact with leaders in each agency in order to better serve them.
- Continue to refine and finalize the Committee Guidance Document. The goal is to systematically document systems that work, modify and improve those that need improvement, and not leave it up to someone to start from scratch to figure it out on their own.
- 3. Continue to search for fund-raising ideas for our association, via our newly formed fundraising committee. We need some creative people to attend who may be able to help us with this. This is an area where the USLA is doing very well as compared to our region, with multiple income sources ranging from an online store, to a separate non-profit foundation for soliciting donations, and various sponsorships.

Finally, I'd like to reiterate how inspiring it is to see all of you here at this meeting. You all are here because of your dedication to *Promoting Beach Safety awareness and Professional Lifeguard standards* – which is our mission. Please keep this mission in mind over the next few hours to ensure a successful and fruitful meeting. Thank you.

I would like to thank Long Beach Marine Safety Chief Gonzalo Medina for supporting this meeting. I would also like to recognize Skip Prosser and his crew for all their hard work in organizing this meeting. Finally, I would like to thank CSLSA Secretary Jim Hughes for his dedicated work as CSLSA Secretary and CalSurf News Editor.

#### Fall 2022 United States Lifesaving Association Board of Directors Meeting

I represented CSLSA at the Fall 2022 USLA Board of Directors Meeting in Orlando, FL and participated in the Executive, Certification, Bylaw, Fundraising and Meeting/Educational Conference Planning Committee Meetings.

#### Spring 2023 United States Lifesaving Association Board of Directors Meeting

Since the last USLA Meeting in Orlando, I have represented CSLSA at 4 meetings of the USLA Conference Planning Committee. We have recently made the following selections for the 2023 Spring USLA Meeting at the Sonesta Redondo Beach and Marina on April 27-29: 1) Banquet Site, 2) Educational Conference Speakers and 3) Location for our Post-Educational Conference Activity on Friday, April 28th. Please go to the USLA website for more information and to register for the meeting. If you can only make one day, we recommend the Educational Conference on April 28th. The \$50 registration fee for that one day includes continental breakfast and lunch, and features a great line-up of current Lifeguard-centric speakers and subject matter. All of you are encouraged to go on the USLA website and register for the Whale Watching Picnic/Hike on Friday and the Banquet on Saturday if you are bringing a significant other. If you are planning to attend and would like to volunteer to assist, please let me know. We can use all the help we can get.

#### 2023 California Surf Lifesaving Championships

The Newport Beach Ocean Lifeguard Association (NBOLA) offered to host Regionals for 2023 & 2024. They have a beautiful beach and an outstanding Lifeguard Operation. Newport Beach also has municipal ordinances that prohibit alcohol sponsored events on the beach. This is problematic for CSLSA Marketing Agent Scott Hubbell (beachsport.org), whose largest client is Anheuser-Busch. In addition, NBOLA would like to use Hoag Hospital as a sponsor. This is in conflict with Cedars-Saini Kerlan-Jobe Institute, who are currently a CSLSA sponsor. NBOLA has yet to sign the 2023 Host Agreement. So, we are hopeful that NBOLA will use Hoag Hospital to sponsor events other than the 2023 or 2024 CSLSA Regionals and that NBOLA will sign the 2023 Host Agreement at this meeting. In the event that we do not reach agreement on these critical, time-sensitive elements at this meeting, the CSLSA Executive Board has a contingency plan to recommend to the CSLSA Board of Directors. We are hopeful that these issues can be worked out in the Sport and Junior Lifeguard Committee Meetings today. Those Committees are advised to solicit backup hosts in the event that resolution is not met. After committee reports on Friday, the CSLSA Board

of Directors will have to determine if the 2023 CSLSA Regionals are on track or if adjustments need to be made to get the event back on track.

#### USLA Agency Recertifications

Since 2019, I have been assisting CSLSA Agencies up for USLA agency recertification by representing them at USLA Meetings and following up with the agencies and USLA Certification Committee in between USLA Meetings. Since the Fall of 2022, this has included Newport Beach, Long Beach, Huntington Beach, Laguna Beach, California State Parks and Los Angeles County. Most recently, Huntington Beach Marine Safety has revised their Policies & Procedures and their recertification application to comply with USLA recertification requirements. This should pave the way for HBMSD to transition from the Extension List back to the Advanced Agency Recertification List.

#### Capitola

I have been working with CSLSA Certification Officer Rick Gould to assist the City of Capitola with their desire to establish a USLA certified agency. Capitola Recreation Division Manager Nikki Bryant who oversees the Capitola Junior Lifeguard program and administrates their Ocean Lifeguard contracts has informed me that the City of Capitola has entered into contract with City of Santa Cruz for a USLA Lifeguard Training Academy. The City of Capitola has developed a training program for Capitola Beach and USLA policies that will be on an upcoming City Council agenda. Under Santa Cruz's supervision Capitola has begun recurrent training and a new hire academy begins in April. As part of the county-wide regional training, the cadre consists of Capitola Lifeguard Captain Brennan Howard, Capitola leadership, Central Fire and Santa Cruz staff. Capitola will implement a USLA based Lifeguard Operation for summer of 2023 and plans to apply for USLA Lifeguard Agency Certification in September of 2023. The Junior Guard program will operate the same as in the past with the exception that all Capitola Lifeguards will rotate them through Lifeguard Operations and JG Instructor duties to ensure all Lifeguards work at least the minimum required shifts per season. Rick Gould has been in communication with the USLA Certification Chairman on this matter.

#### California Water Safety Coalition

I continue to represent CSLSA at regular meetings as a member of the California Water Safety Coalition, Lifeguard Supervision Working Group. Unfortunately, I will not be able to attend the California Water Safety Summit in San Diego due to my prior commitment to helping host the USLA Meeting in Redondo Beach that same week.

#### 2023 CSLSA x JWCF 250 mile "SoCal PaddleDown for Cancer Relay"


It's a Paddle Up this year- starting in IB up to Cal. St. Santa Barbara. Need to budget, or plan, for 2 new boards.



I paid for the GPS tracking provider service for 2022, which worked pretty well until the one unit fell overboard in the surf and was not recovered by whomever took the boards out at Bolsa Chica for workouts.



We started with 2 GPS trackers-1 purchased by CSLSA, 1 purchased by LACoSLSA to replace a unit that went missing while board was stored at Hermosa LG HQ a few years back

We still have the \$150.00 SPOT GEN4™ satellite GPS messenger which lets family, friends, and colleagues know you are OK, or if the unexpected should happen the unit sends out an SOS and alerts local rescue agencies by utilizing the Globalstar satellite network.

We need to purchase a new \$130.00 Spot Trace satellite tracking device which offers advanced tracking for your valued assets. Basically, an aquatic lo-jack. Instantly sends a text, or email, whenever movement is detected and allows one to follow the Trace unit on SPOT Mapping on phone or computer.

CSLSA Specialized License Plate:

"The California Ocean Lifeguard Beach Safety Specialized License Plate"

I have submitted our Draft Legislation for the "California Ocean Lifeguard Beach Safety Specialized License Plate" and am hopeful the Bill will be introduced in this current session.

Once introduced, I will contact the numerous Agencies and Associations who support our License Plate idea in an effort to obtain letters of endorsement. We will then need to obtain 7,500 "pre-orders" as the Bill moves through its committees and hopefully to a floor vote, and a signature by the Governor. It is still a very long road ahead.

Additionally, a full-size mock-up of the proposed License Plate, along with several smaller static cling decals with the "BE SAFE" public safety message and the tagline of "Always Swim Near A Lifeguard," have been sent to several key CA State Legislators on the various committees whose support we will need moving forward. The reaction to the artwork — and safety message — has been very positive. (Image attached).

#### **Current Legislation**

In the 2022-2023 California Legislative Session there are several Bills proposed that may have an impact on Ocean Lifeguards or EMT's that are being monitored.

All remain in their initial committees, and are still subject to changes or even withdrawal. The Legislation Committee will continue to monitor their progress and report as needed.

SUBJECT: Lifesaving Sport Report

At the Fall 2022 USLA BoD meeting in Orlando I made the following proposals & presentations:

\*1: Proposed boys and girls 3-person Paddleboard Relay in the A B C divisions.

\*2: Event rule proposal changes for Landline Rescue Relay finish to change the finish rules for the Landline Rescue Race so that the finish rules are consistent with, and similar to, the Rescue Race

-2 similar rescue relay races that currently have very different finish rules often causing unnecessary DQs. Both are 4 person "rescue" races but USLA Landline historically requires the rescue swimmer to quickly remove their fins and run up and finish in contact with the team and the victim to maintain contact with the rescue device-despite being high and dry and well up the beach from any water. The ILS Rescue Race simply requires the 2 shore side rescuers to carry or drag the victim across the finish line.

Proposed language change

"the two rescuers, at their discretion, may cross the start line to enter the water and assist the rescue tube swimmer to bring the victim to the beach. Victim must be dragged or carried to the finish.

- d) The Finish is judged on the chest of the first team member crossing the finish line on their feet in an upright position while still in contact with the victim (the rescue can need not be held or attached).
- \*Note 3: While it is not necessary to drag the whole of the victim beyond the finish line teams are requested to immediately move to the shoreward side of the finish line to assist with judging of the event and to enable any trailing teams to finish.

#### \*3: Add IL\$ 90m Beach Sprint to Lifeguard Competition rules as an Open event only

At the request of USLA Coaches in order to better assist with National Team selection the CSLSA proposed to add the ILS 90m Beach Sprint to Lifeguard Competition rules as an Open event only.

No event was proposed to be eliminated/cut from the Nationals schedule should the Beach Sprint be added. Pushback from Officials were that even just the Open event heats for Men and Women would take several hours to conduct and that is a lot of heats when the National Team usually only picks 1 Beach Sprinter from each gender for the National Team.

\*4: Rule change edit proposals for 4.6. 4.7 and 4.8 in USLA LG RulesFall 2022-Southwest Region proposal edits to 4.6 Heat Placement, 4.7 Final Event Qualification, and an addition 4.8 Substitutions--USLA Rules Heat advancement clarification proposed language.

#### 4.6 HEAT PLACEMENT

Competitors will be placed in heats by a draw or random computer placement. As much as is possible, an effort shall be made to have competitors from the same Chapter in different heats.

#### 4.6.1 Draws

The initial draw for heats and beach positions may be conducted by competition management and supplied to teams. Draws for positions in subsequent rounds (e.g., quarter-finals, semi-finals, and finals) shall be made by competition officials. The method used for the draws, including draws for initial heats and seeding of competitors, shall be approved by the Head Official.

- a) The Head Official will be responsible for all draws for quarters, semis, and finals where heats have taken place.
- b) Vacancies created by the disqualification of a competitor or team shall only be filled by the next place getter participating in the same race. Vacancies created in qualifying to further rounds of an event due to the withdrawal of a competitor or team shall only be filled by the next place getter who participated in the same race.

#### 4.6.2 Competitor Limitations

The Head Official or Course Referee shall decide whether events shall be conducted in heats, rounds, quarterfinals, semi-finals, or straight-out finals. Only the Head Official may authorize changes to these maximum numbers with due consideration for effective judging, environmental conditions, safety considerations and fairness for all competitors.

Note: Technical Officials should be mindful of confirmed entries when determining the number of heats/rounds required to conduct an event through to a final and to, as far as practicable, have an equal number of competitors in each heat/round. The Head Official may change the number of competitors in remaining heats, after one or more have been run, if safety conditions warrant, providing that the number going through to the next round/heat, quarter, semi, or final do not compromise the number of qualifiers from earlier heats.

- a) To assist with the fair conduct of competition if there is an even number of competitors in a heat, wherever practicable, at least half the competitors who correctly complete the course should progress to the next round of the event (e.g., if there are 16 starters in a race at least 8 who correctly compete the course should qualify for the next round of the event).
- b) If there is an uneven number of competitors in a heat, wherever practicable, at least half the competitors less one who correctly complete the course should progress to the next round of the event (e.g. if there are 9 starters in a race at least 4 who correctly compete the course should qualify for the next round of the event) (e.g. if there are 7 starters in a race at least 3 who correctly complete the course should qualify for the next round of the event)

#### 4.7 FINAL EVENT QUALIFICATION

- Equal numbers of top finishers from each heat will be placed into the Final.
- Where necessary Quarterfinals and Semi-Finals will be run.
- c) The numbers taken to reach a final should not exceed the following, taking safety into account:

Rescue Relay, Board Rescue, Landline, Beach Relay = 10 Teams Surf Boat Races= 16 Teams

Board Race, Surfski Race, International Iron, American Iron, Taplin Relay, Board Relay= 16 Individuals or 16 Teams

Beach Flags= 16 Individuals

Surf Race, Run-Swim-Run= 32 Individuals

d) The Quarter and Semi Finals can be less than ten competitors per heat to comply with the mathematical formula necessary to accommodate the ultimate goal of reaching 10, 16, or 32 competitors for the Final.

- A maximum 50%, or roughly half of the field in each heat, chould advance to the nextround. \*(This confusing heat advancement statement that is currently 4.7 e) is deleted from 4.7 and clarified in 4.6.2 a) and b)
- f) Only competitors who appear and register for the heats of an event shall be eligible to compete in the event's Quarter Finals, Semi Finals or Final.
- g) Once a Chapter or Team has participated in the first qualifying heat, Quarter, or Semi final of an event, it is not possible to change the composition for the root of that particular event. No changes to the Team composition can be made after it has competed in the first qualifying round of an event. \*(see proposed language in 4.8)
- h) When one or more competitors or teams withdraw from a final of 16 or more competitor/team, up to a maximum of four competitors or teams shall be called forward from the reserves list. Reserves will come from the same qualifying race as the withdrawn competitor or team. The final shall not be reseeded.
- i) Where one or more competitors or teams withdraw from an A-Final of 10 competitors' alternate competitors up to a maximum of four competitors or teams shall be called forward from the heats. Reserves will come from the same qualifying race as the withdrawn competitor or team.

#### 4.8 SUBSTITUTIONS IN TEAM EVENTS

Substitutions are permitted in any round of team events.

Only the manager or coach may substitute members in a team event with other members of the same club. Managers or coaches must notify the appropriate officials of the substitution(s) no later than 30 minutes prior to the start of the first round of the team event or 30 minutes prior to the commencement of marshalling in subsequent rounds whichever occurs first.

SUBJECT: USLA NATIONAL TEAM MANAGER AND COACH APPOINTMENTS

The USLA Team Manager and Coach shall be appointed by the USLA President and confirmed by the Board of Directors as necessary. These policy and procedures are intended to define the process for the selection of USLA National Team and USLA Youth National Team Managers and Coaches.

#### A. SELECTION COMMITTEE

 The USLA President shall appoint a selection committee comprised of at least two USLA Board of Directors, or appropriately qualified subject matter experts, and at least one non-National Team candidate member of the USLA Lifesaving Sport Athlete's Panel (if no currently elected Athlete Panel members qualify then the panel will recommend a nominee to the President), to accept and review USLA National Team and Youth National Team Manager and

Coaches position applications. At least one selection committee member shall be of a different gender.

- The USLA National Team Manager and Coach Selection Committee shall notify all applicants of scheduled interviews for open positions.
- 3. No member of the Selection Committee may be an applicant for current selections.

#### B. APPLICATIONS

- Individuals who apply for any USLA National Team Manager or Coach positions must be current USLA dues paying members.
- No application for any USLA National Team Manager or Coach positions will be accepted after the established application deadline.
- 3. All applications must include a Lifesaving Sport resume.

#### C. INTERVIEWS

- The USLA National Team Manager and Coach Selection Committee selection process will be consistent for all applicants, including interviews.
- No applicant for any position may take part as an interviewer, or selector, during the interview or selection process.

#### D. RECOMMENDATIONS

 The USLA National Team Manager and Coach Selection Committee shall recommend individuals to serve as USLA National Team Managers and Coaches to the USLA President based on a review of all applications submitted by the established deadline and all interviews conducted by the selection committee.

#### E. APPOINTMENT

 The USLA National and Youth National Team Managers and Coaches shall be appointed by the USLA President and confirmed by the Board of Directors as necessary considering the recommendations of the USLA National Team Manager and Coach Selection Committee following these policies and procedures.

#### F. BACKGROUND CHECKS

 All USLA National Team Manager and Coach appointments will be subject to passing a background check as determined by the USLA President.

#### 26th Wieland Shield Tour

Wieland Shield exchange concept was created by Bob Burnside and is an exchange between CSLSA & Life Saving Victoria (LSV) in the early 1960s.

I have had multiple communications and virtual meetings with Life Saving Victoria employees and volunteer staff including new General Manager for Sports Participation Ryan O'Connor, new Senior Sport Manager Chris Schleusener, Aquatic Sport Director Aaron Green, new LSV Team Manager Jono Holt, new LSV Coach Jamo Porter, and Catherine Greaves, who has replaced Nigel Taylor as the Chief Executive Officer of Life Saving Victoria. All are relatively fresh appointments and many are unsure and unfamiliar with Wieland Shield tour logistics as the last LSV tour of California was in July/August 2015 and the last Wieland Shield tour Down Under by the California Lifeguard team was in January 2018. The overarching sentiment is that while the want and will to "resuscitate" the trans Pacific lifesaving exchange and competition is the finances and logistics are yet to be determined. Current estimate is 60/40 that they are coming this summer.

Life Saving Victoria has over 500 employees and 37000 volunteer members. LSV works under the umbrella of Emergency Management Victoria (EMV) as part of the State's emergency management services and is recognized by the Victorian Government as a core agency that plays a role in delivering EMV's strategic emergency action plans. Our other key links with government are in the areas of health and sport, and recreation.

If they do come over the LSV Team would probably arrive in LA for a tour of So Cal Lifeguard Agencies approx. July 19 to August7, 2023 and the actual Wieland Shield Competition will take place August 3-5, 2023, as part of the International Surf Festival.

Need to establish the 2023 LSV WS tour plan logistics, local area hosts, tour events, and team accommodations as they tour So Cal.

The Touring Lifesaving Team is traditionally 7 men, 4-5 women, plus Coaches, Manager, and Educational Staff so could be 16 persons or so.

From LSV:"...per our conversation, we may have a few Victorian Lifeguards that could be interested in Lifeguard opportunities in California. I have been asked by several guards to investigate what options may be available in California. I understand other Lifeguard groups in Australia may have links with Long Island, New York, and Florida. It would be great if the same opportunity existed in California for Victorians. Could you please identify a few options that may exist and I will present these to LSV for consideration?" LSV has a long history of hiring Californian Lifeguards interested in working as Lifeguards in Victoria.

#### INTRODUCTION:

Final adult membership for the Southwest Region reached 1427, well above our normal average of 1300. With a late submission of the Santa Cruz JGs, we reached 1282 Junior Guard members.

#### MEMBERSHIP REMINDERS:

- Any chapter that is able to drive individual member registrations or renewals through the USLA website is encouraged to do so. Online membership registrations processed after April 1st of each year are automatically enrolled in the next upcoming membership year so your springtime recruits and requalifying guards can enroll as of this Saturday for the 2023-24 member year at www.usla.org. Please also encourage annual automatic renewal.
- Chapters who collect member dues through payroll deductions or chapter enrollment in order to submit bulk member registration will be provided a template for member renewals and addition of new members to your list. This method will also be used for any Agency wishing to bulk register their Junior Lifeguards. Target due date for receipt of bulk member rosters is July 10th if you have guards who will be competing at Regionals or Nationals, so that individuals can go online to register for the event. Alternatively, the USLA is able to provide codes to Chapter representatives for member dues and/or event dues so that guards or JG parents can register online and the chapter/agency is billed for the total.
- <u>Two-Tier Junior Guard Membership</u>: The dual levels of JG membership was approved by the
  USLA and goes into effect for this year. All Junior Guards registered with a USLA-affiliated JG
  program will be eligible for a free introductory membership in the USLA. There are several ways
  parents and/or program coordinators can register kids for the free membership, which will
  include an electronic member card and access to online discounts and programs via the USLA
  website.

The premium JG membership is now called JG GOLD membership, and it costs \$20.00 per year. Gold membership includes a custom printed membership card, embroidered USLA patch, USLA window decal, three issues of *American Lifeguard Magazine* and eligibility to compete at Regional and National Lifesaving competitions, in addition to all the benefits of the free membership.



#### Open Water Safety Webinar

On February 16, I participated in an Open Water Safety Webinar hosted by Will Koon of the California Water Safety Coalition. It was a very informational one hour presentation. Will talked about fatal and non-fatal with morbidity drownings from 2005 to 2019. He had a lot of great information. Will was followed by Ryan Aylward, Warning Coordination Meteorologist with the National Weather Service. Ryan discussed open water drownings in Northern California. He was followed by Melissa Miranda and Sara Kennedy from California State Parks Boating and Waterways Education and Outreach Program. They discussed some of their programs, life vest education and messaging especially for rivers this upcoming spring. The final presentation was by Pono Barnes, Los Angeles County Fire. Pono had a great presentation on Technology in the Towers. All were great and you can see the program in its entirety on You Tube (Webinar Open Water Safety).

#### Project Wipeout Advisory Committee (PWAC)

Samantha Dieterman has been doing a fantastic job working with PWAC. I am sure she will fill you in on this year's Project Wipeout Lifeguard Educational Conference (Live!!). Great job!

#### San Diego Lifeguard Advisory Committee (SLAC)

SUBJECT: MEMBERSHIP COMMITTEE ACTION REPORT

Thank you to all the delegates who attended and participated in the Membership Committee. Here is a summary of the topics discussed.

- \* Reviewed the kit item coming for this summer the insulated lunch bag and discussed the delay once again of its arrival. Committee members strongly suggest an earlier selection and ordering of the annual gift item, so the Chair will advocate for 2024 kit item discussion at the upcoming Spring USLA meeting, with final decision at the Fall USLA meeting and ordering no later than December 1st each year. We have to get the process moved back to a timeline that allows the gift items to arrive regionally by early Spring, ideally for distribution to Chapter representatives at the CSLSA Spring Board meeting.
- \* The suggestion was made that perhaps it would help the USLA to put favorite items into a regular rotation for ordering, and also to alternate annually with a mail-able item and then a larger item that must be shipped to Regional reps. It was noted that the recent Challenge Coins which were mailed out to each member ensured that everyone received their gift item, and took some of the burden off the Regional reps to get kit items out to Chapters. As an example, the kit rotation might be: Towel, Challenge Coin, Bag, Key Chain, Custom Socks, Luggage Tag, and then back to Towel, with the variable being what type of towel or bag is selected in alternating years. CSLSA members would like to see a golf towel/shammy in an upcoming kit, and we liked the idea of a keychain Challenge coin. Socks, hats and bags continue to be popular.
- \* The member gift item cost-share is set to continue between USLA and the Regions, but there will now be additional charges to each Region to share the rest of the member kit and shipping costs. Since it is still unknown how much these additional costs will reduce our Membership Committee budget, the Chair will reach out to SHP to see if he might be able to provide an item for CSLSA members this summer, such as a trucker hat, through his various sponsors.
- \* Due to the ever increasing costs of doing business, the USLA is considering raising the cost of Professional member dues. They asked the Regions to discuss the idea and bring back proposals to the Spring Board meeting. We had a robust discussion regarding the topic. It was noted that it has been approximately 30 years since the Professional dues were raised to

the current \$30.00 - so it's quite clear that a fee increase is needed. Delegates noted that whatever decision is made, it will be very important to provide good communication to USLA members about the need for a higher fee, the many areas supported by member dues and an emphasis on how long it has been since the last increase. Committee members indicated that the CSLSA may see a slight decline in total members in the first year of a fee increase, but it was unlikely to cause much of an issue.

- \* Committee members made several valid suggestions for the increase to Professional dues: many believed that raising it to \$40.00 was the most logical idea. A few members suggested setting it at \$50.00 so we do not need to seek another fee increase for many years, like before. However \$50 is a 67% increase, which seems excessive. The last suggestion was to announce an incremental increase in member dues, \$2.00 per year for 5 years, until it is \$40.00. This might be most beneficial to the many Chapters who also charge members a local chapter fee, and who might be faced with reducing fees or absorbing the increase in USLA dues if it goes up \$10 in one year.
- The Chair looks forward to carrying these fee increase suggestions from CSLSA delegates to the national Membership Committee next month.

6 individuals - three Lifeguards & three citizens

#### Incident Description:

The incident occurred of Cortez Avenue in the City of Encinitas. The water temperature was 54-56 degrees with 4-6 foot surf. Lifeguard Adam Wraight was off-duty and intending to go surfing. He entered the beach at 1690 Seacoast Drive and observed a boat about 50 yards outside the surfline traveling northeast at a slow rate of speed, about a quarter mile north of his location. The vessel appeared to be Panga with approximately 8-10 individuals on board. As the vessel continued moving northerly it was also moving closer to shore. A large set of waves obscured his view of the vessel, however an unnamed citizen above Wraight said that the vessel had flipped over in the surf.

54-56 degree contaminated water in 4-6 foot surf; 10 persons on board an overturned Panga vessel transporting illegal aliens attempting to enter the USA. Four of the victims self-rescued, three were rescued by surfers and lifeguard personnel; there were three fatalities (two recovered at the time of the incident, one was recovered a week later.

Upon recognizing that the vessel was upside down in the surf, Wraight ran north to the scene, just south of Cortez Avenue, and entered the water on his surfboard. Wraight also observed two surfers and several victims being carried off-shore in a large rip current. As Wraight entered the water he observed two other surfers assisting unconscious victims.

#### Narrative A - Panga Rescue

Reporting Lifeguard: Sgt. Adam Wraight

location of Incident: Cortez Ave

Date of Incident: November 26, 2022

On Saturday, 11/26/2022 at approximately 0600, I entered the beach at 1690 Seacoast Drive to surf. I noticed a boat about 50 yards outside the surf line travelling northeast at a slow rate of speed. The vessel was about a quarter mile north of my location off of Cortez Ave. The vessel looked to be a panga with a large group of 8-10 people on board. As the vessel continued moving closer to shore, a large set of waves followed behind it. Due to the large surf, I lost visual of the vessel and people on board. A citizen on the rocks above me said that the vessel had flipped in the surf.

I started running north toward the scene with my surfboard. I entered the water just south of Cortez Ave. The overturned vessel, several victims and two surfers were sucked out in a large rip current near Cortez Ave. As I entered the water, I noticed another surfer (Nick Kubarych) paddling out to assist.

Once past the surf, I saw debris, fuel cans, a surfer (Kevin Defoney in his boxers) with an unconscious victim, two unconscious victims face down in the rip current and a second surfer (Andrew Carter) with three conscious victims on his surfboard. Two of the victims with Andrew were fully clothed females without PFDs on top of his surfboard and a male victim in a PFD hanging onto to the rear of his surfboard. I paddled over to assist Andrew. One of the victims he had pulled up from 2-3 feet below the surface. We transferred one of the female victims to my surfboard and Kevin tended to the male in the PFD. Andrew paddled one female victim into shore. Kevin and Nick pulled in the male with a PFD, while I paddled in the other female victim on my board.

Once on shore there were several Border Patrol agents (CBP) and San Diego Sheriff's Deputies (SDSO). I requested a ride to HQ from Community Service Officer (CSO) Abasso. On Seacoast Drive I saw LG I Harrison Cannon and LG I Samantha McNall, I requested them to meet me at HQ. At HQ we launched our Rescue Watercraft (RWC) R-1. LG I Cannon and LG I McNall respond to the scene in Unit 603. LG I Cannon ran out of the unit to crew the RWC.

Within minutes we found our first victim floating approximately 50 yards outside the surf. We got her on the rescue sled and transported her to the beach. LG I McNall helped extricate the victim from the water and up the beach for Fire and Medics with the help of Border Patrol Agents. The second victim was near the vessel approximately 100 yards outside the surf. We transported the second victim and handed her over to LG I McNall, Border Patrol and EMS on the beach.

LG I Cannon and I went back out to search for the last missing victim. LG I Cannon free dove the overturned panga checking for any entrapped victims. The search was difficult due to low visibility, ropes, gas, and debris in the water. Later we spoke with San Diego Harbor Police (SDHPD) divers and received confirmation from their dive team that the vessel was clear.

Lifeguards continued to search for the missing victim from the RWC and the shoreline for hours. Due to hazardous conditions; large surf, long shore current and contaminated water, Lifeguards switched to a land-based search.

SUBJECT: TRAINING COMMITTEE ACTION REPORT - SPRING 2023

Updated the Training Officers contact list.

**Requested** a Lifeguard Historian contact from each agency to assist with the History of Women in Lifeguarding project.

**Requested** an agency contact to collect electronic copies of agency training manuals, handbooks, and training day outlines.

<u>Open Discussion</u>: We had an awesome and incredibly informative round robin update from each agency on recruiting, retention, testing, training, and the overall health of the lifeguard operations. Here is a summary:

**Long Beach** – Successful recruiting year by using current seasonal guards (heavily into East Los Angeles, JG's and High Schools); 70 at swim test; 40 into backgrounds; 30 for academy; Starting pay \$25; ESPN filmed tryouts and followed applicants through the process (airing in 2024).

<u>Seal Beach</u> – 2022 only had 8 applicants at swim test; Had two test this year; Tasked current guards to bring in at least one candidate; Beefed up their social media footprint; Tagged surf teams; Big event was hosing an open house for all their recruits and their families; Hosted two ocean orientation days (pre-swim); For those that attended they got free swim passes and freed training programs (29 candidates participated); Starting pay \$19.08.

Newport Beach — Used social media for years; started an August outreach program for the High Schools; HR posted job info early; QR codes in the field crated an automated mail list; Hosted an informational night which had standing room only; Hosted workouts; They had a bigger variety of candidates; 84 applicants with 50 to tryouts and 43 in training; Hiring 35 with 14 women; 8 wage increase steps.

<u>Carlsbad City</u> – New in 2017 for ¼ mile stretch of beach in north Carlsbad; 2 new perms that are firefighter/medics; 4 towers; 8 people a day; Pools guards pay help justify a raise for the ocean guards who could do both; Pay \$20-\$28 with cola's every year; Working on getting USLA accredited once they establish a training program; Recruit 5-10 lifeguards a year with almost all very experienced guards and EMT's; Battling a 5 year old budget model.

<u>Capitola</u> – They now have their own budget; They started their program with JG's first and then have followed it up by creating a lifeguard service so they can be USLA accredited; Contracting with Santa Cruz/Central Fire to certify their lifeguards (young 17-22 years old); Created an equity swim program to candidates on board; Provide training and development on lifeguards

skills; Brutal recovery from storms; 2 towers over ½ mile of beach but they also have 3 miles of cliffs.

Oceanside – Big change this year in that they took over operating the Harbor Marine Safety Unit (Fire); They went live on February 3, 2023; Operate 3 rescue boats; They have their own academy (2); 3 personnel on 24 hour shifts with 3 shifts; Lifeguards, Fire and Medics; Going from 11 to 18 permanents; hiring 13 new seasonals; 80 hours academy with 40 hour EMR; They provide the group with a National, State and Regional Standards paper they prepared regarding training guidelines.

<u>Coronado</u> – 2 new permanent lifeguards; trying signing bonuses to recruit lifeguard; major water quality issues this year; their guards attend the Regional Lifeguard Academy.

Huntington Beach City – They picked up Sunset Beach and Huntington Harbor (4 towers); 4 new positions at ¾ time; Having recruiting problems like everyone; Have 5 test starting in October; 31 recruits this year (usually 400-50); Hire at 16 if they come from the JG's as an A Captain; Big attrition from current guards (losing ab out 20-30 a year); New contract is helping; Their do a task book model for training (RWC, Quad, Dispatch, etc.); Working more and better with Fire since 2019; They need 36 JG Instructor for the season; There is 120 hours which includes an EMR course.

<u>Laguna Beach</u> – Not present but reported that they have a knock-on door policy for recruiting; knock and test; provide a winter and a spring training session.

<u>Los Angeles County</u> – They now hare at 16 years old; Working on how to navigate age differences in the field and some of the problems it creates; Host a parent day for young recruits and guards.

<u>San Clemente City</u> – Losing people to other job offers; Working on change in pay scale and pay; Losing 14-15 year old JG's as recruits.

<u>Imperial Beach</u> – Horrendous water quality issues; Trying to raise the pay from \$18.05 an hour; IB Pool guards start at \$22 an hour; Candidates attend the Regional Training Academy (80 hours lifeguard and 57 hours EMR on their own); Only had 2 people tryout and they dog paddled; Before they got a lot of locals who were very loyal to the program; Trying to get a rescue boat and 24 hour shift; Right now 2 towers and 2 trucks.

<u>State Lifeguards</u> – Having trouble recruiting and retaining enough guards for the field and the ever-expanding JG Programs; Pay starts at \$19 an hour but there are only 3 steps and it takes about 3-5 years to get a raise; Training about 200 a year due to huge attrition numbers; On average only retaining a guard for about 2 years; Slated to train 170 guards this year.
