

 Subject: **President's Activity Report**

I continue to keep very busy with the business of the CSLSA and USLA. Correspondence has increased greatly and specifically E-Mail correspondence. The following are the highlights of activities or issues I have worked on this last six months.

### Executive Board Replacements

Mike Halphide resigned his Delegates position on the Executive Board due to personal reasons, primarily the birth of twins, which he is occupying much of his spare time. With the passing of A.J. Summers, that leaves two open positions on the Board.

The Executive Board has appointed Kai Weisser as the Recurrent Representative to replace A.J. due to his vast experience in this position. I will be entertaining a motion under New Business to accept this appointment. This will then leave two openings in the Delegate position.

My recommendation to this Board is to elect Rob McGowan, Chairman of the Competition Committee and the next vote receiver in the last election, and Reenie Boyer, Chairperson of the Junior Guard Committee. Both are very active members who regularly attend Executive Board Meetings. The action on this issue will be taken under New Business as well.

### CSLSA Regional Championships

#### Millennium Omnimedia

As many of you know this issue was an ill-conceived agreement for sponsorship and acquisition of television presentation of the USLA National and Regional Championship Series. Because of inactivity and continued whining on the part of Millennium, the USLA Board authorized cancellation of the contract.

While this was good for USLA it meant that the regions and the Chicago Chapter (the host of the Nationals) were on their own to get sponsors for their respective events. This was difficult for Chicago and Huntington Beach who host events that required sound funding to put on a good event.

Thanks to the Chicago Parks District personnel and Dick Colosi, the National Games were put on with a shoestring budget, but with class. Thanks to HBSLSA's Kai Weisser, Dave Simcox, CSLSA's Dick Colosi and Eric Bauer, for their work on obtaining Sol Cerveza as a sponsor the Regional games were a great success, even with the day change.

#### 1999 CSLSA Championships

The Executive Board agreed to HBSLSA hosting the 1999 games. A letter of Agreement will be drawn up with HBSLSA to set the parameters including any potential profit sharing, income and expense reports, etc.

#### 2000 and 2001 RFP's

The Executive Board is seeking RFP's from Chapters interested in hosting the 2000 and 2001 Regional Games. Rob McGowan will address this issue in the Competition Committee.

### **Ingram Licensing Agreement**

While I was in Chicago for the Nationals, Mr. Colosi and I had the opportunity to sit down with Ben Kato of Ingram Company, Ltd. We are negotiating a licensing agreement for use of the USLA logo. The agreement, which is still in the works gives guaranteed minimum payments to USLA, with increased payments based on the success of the program. The minimums per year to USLA would be:

1st year	\$15,000
2nd Year	\$25,000
3rd Year	\$50,000

The agreement is still pending due to some reorganization on Ingram's part. We had hoped to have a contract ready for signing for the meeting next week.

### **Ocean Beach**

As you may have heard or seen in various media, USLA has been very involved in attempting to improve the level of safety at Ocean Beach, just outside of San Francisco. There were three drowning there the beginning of summer. Mr. Brewster will undoubtedly report more on this issue in his report.

As the President of USLA I assigned Rick Gould to head the committee working with the Golden Gate National Recreation Area. Also assigned were Carl Drake from CSLSA and Bob Fennel of the Pacific Northwest Region.

### **Membership**

With the resignation of Mike Halphide from the CSLSA Executive Board, we need someone to take responsibility for the Membership Committee. This job entails assisting the Treasurer with reconciling the number of members and the amount of dues obtained and to chair the committee meetings which normally establish what, if any, additions to the national membership kit are appropriate.

In Mike's absence I have taken the responsibility to create a list of members in a format that we can use to verify names, chapters and voting issues. I will be distributing this list at this meeting for your review and correction.

### **Public Education Booth**

### CSLSA Hosting the Spring USLA Board Meeting.

There was a good response with regards to the funding efforts on behalf of the CSLSA as host of the USLA Spring National Board Meeting. Approximately twenty four requests were sent to potential meeting sponsors and exhibitors. Ten sponsors were acquired for a total of \$7,400.

It was a sad situation, but good to visit with the many Seal Beach guards while there. The Seal Beach crew is great. Thanks!

As a CSLSA delegate I was quite busy with a variety of projects since the last meeting. I expect my schedule will become somewhat more busy in five weeks when my first child (little Bud Weisser) arrives. Briefly, some of my accomplishments and ongoing projects include:

# Past President's Report

Fall 1998 Board of Directors Meeting

## Legislation

- **Boating Safety** – SB 545, which was sponsored by the City of San Diego and supported by CSLSA, was signed by the Governor in 1997. It increased the minimum age to operate a motorboat over 15 horsepower (unsupervised) to 16. It also mandated formation of a California Boating Safety Advisory Committee. I served as a member of that committee, which recommended, among other things, a mandatory boater education program in California. The City of San Diego is expected to sponsor legislation to enact the committee's work into law and CSLSA support will be sought.
- **Surfing Legislation** – It is anticipated that the City of San Diego will sponsor state legislation next year aimed at surfer violence (localism and the like). CSLSA support will be sought.

## USLA Website – USLA.ORG

- As editor of the site, I am happy to report that it continues to enjoy strong support. We are hoping for USLA Board of Directors approval to sell advertising on the site.
- Since the last CSLSA Board meeting, we added the rip current and spinal injury brochures (in an amended format) which were developed by TREF, California State Parks, and CSLSA.
- With the untimely death of AJ Summers, there is a need to ensure continuity of the CSLSA website. One alternative is to contract with the USLA technology firm, Adtell, and have a CSLSA member act as site editor.

## San Diego Regional Lifeguard Academy

- Session #2 was conducted beginning on May 30, 1998. Seven lifeguard agencies participated and four lifeguards from Brazil were included in the training. This concept appears to be quite successful.
- The Regional Academy is now branching into personal watercraft rescue training and expects to add additional curricula in the future.

## Australian Exchange

- The second half of the Australian professional lifeguard exchange went well. Dean Wilson, a paid lifeguard from Australia, worked in San Diego as a regular lifeguard for four months. He completed the Regional Lifeguard Academy and did an excellent job, providing a variety of insights on lifesaving in Australia. As a result of his recommendation, the San Diego Lifeguard Service intends to evaluate use of a smaller (10'6") and lighter (27 pound) rescue board. Dean pointed out that the majority of rescues in his area, that are not effected with IRBs, are handled with these smaller rescue boards and suggested that we consider using them.

## Certification Program

- At the national Board meeting in May of this year, some modifications were made to the program. One major change was to extend the certification period to three years and increase the cost to \$250.
- Interest in the Certification Program continues to increase, with new applicants. Port Hueneme is a new applicant from our region. Unfortunately, Santa Barbara and Los Angeles County have yet to submit applications for recertification this November.

- Considering the number of organizations presently involved in training public safety personnel to operate PWC, it is my belief that a national certification system similar to that used for lifeguard agencies might be of value. I have made preliminary inquiries to the Personal Watercraft Industry Association, which has indicated a willingness to help fund the effort. I intend to discuss this further at the USLA Board of Directors meeting.
- All CSLSA affiliated agencies are currently certified or in the process of certification except for the following: City of Capitola, Avila Beach - Port St. Luis Harbor, Morro Bay, San Luis Obispo, Coronado, Del Mar, Seal Beach, Tucson, and Ventura County. These agencies are encouraged to apply for certification.
- I was asked to check the California Lifesaving Association's application for certification more carefully after the last USLA Board meeting. This agency is a nonprofit organization that provides contractual lifeguard services. After several letters back and forth, it is clear that, based on the agency's assertions, they meet certification requirements. I have issued a certificate.

## Coronado Lifeguards

- The City of Coronado has recently created its first two year-round, permanent positions. One is for a sergeant and the other a lieutenant. They report to an hourly captain.

## International Life Saving

- I attended the ILS Board meeting in Bad Nenndorf, Germany in September. One of the most important results was approval of the first two statements by the ILS Medical Commission. They involve sun protection for lifeguards and the Heimlich drowning maneuver. These have been sent out via email and posted on the USLA.ORG Guard to Guard bulletin board.
- Rescue 2000 was discussed in great detail. It will take place in Sydney, Australia in March 2000. Extensive information on this event is available on the Surf Life Saving Australia website. For a link to this site, visit USLA.ORG

## New Zealand Exchange

- Considering that the majority of lifeguard agencies within the Southwest Region are now certified, or in the process of applying therefor, I suggest that consideration be given to limiting applications for the New Zealand exchange to members of USLA certified agencies. CSLSA has a vested interest in assuring that those we send on the exchange provide information consistent with USLA standards and in encouraging agencies to become certified. I realize that some may see this as penalizing the lifeguards for failings of the agencies, but I think it may provide some further incentive to improve standards and ensure that our representatives meet those standards.

## Ocean Beach

- On the first day of this summer, three persons drowned at Ocean Beach in San Francisco. I was asked by Francis Smith to help him shed some light on the issue. We held a press conference at the beach the following Sunday (June 28), with high attendance from the media, and called for lifeguard protection. I spoke as President of the Americas Region of the International Life Saving Federation, as I have done throughout this matter.
- The National Park Service, which controls this beach, did little in response to the initial drownings and press attention. When another drowning occurred, Mr. Smith and I held a second press conference at the beach on August 15, again with high press attendance.
- A variety of other persons have contributed extensive time to the matter including Rick Gould, Professor Bernard Nietschmann, Ralph Goto, Bob Burnside, Congressman Bryan Bilbray, and others.
- USLA President Bill Richardson wrote a letter to the park manager offering assistance, and when it was accepted, appointed Rick Gould, Carl Drake, and Bob Fennell to lead a group to meet with park management. They are currently drafting a report to deliver to park management.

- Numerous articles and letters have been published in local papers and at least one Associated Press story was run. The National Park Service continues to maintain that the water is so hazardous that no one should swim at this beach, therefore, to place lifeguards would be to encourage use of a hazardous area. Many of us believe that while Ocean Beach is hazardous, it is manageable with standard life-saving techniques employed elsewhere.
- On September 17, a hearing was held by a San Francisco City Council committee. Testifying against lifeguards were the assistant park director, the head ranger, a NOAA oceanographer, and Russ Albano of San Francisco Fire (a USLA certified ARRT agency). Testifying in favor were Professor Bernard Nietschmann, Francis Smith, Bob Burnside, Scott Tye, Henry Taylor (the uncle of a drowning victim), Rick Gould, and me. The sentiment from the committee was strongly in favor of providing lifeguards and the Board of Supervisors subsequently issued a resolution supporting provision of preventive measures, including water rescue personnel and a lifeguard tower.
- Park management continues to contend that placing lifeguards at the beach would be reckless because it would invite swimmers. They want to place non-lifeguard water rescue personnel (i.e. probably park rangers with rescue training) on the beach.
- Extensive information on this issue, including various newspaper articles, can be found on the USLA.ORG Guard to Guard bulletin board. All funds I have used in this effort to date (predominately airfare) have been personal.

## American Lifeguard Magazine

- Considering the unfortunate hiatus in publishing ALM, I have been making some preliminary inquiries to determine if a professional publisher would consider taking over responsibility for ALM. The current editor, Tim Gallagher, has taken on the duties of Town Manager for his town, in addition to running the lifeguard service and has experienced time availability problems for the magazine.

# Proposed law is a stand against 'localism' idea

*"The state of California hereby declares that the ocean along California's coastline and the waves which strike it are an invaluable asset which is owned by no person and available for equal use by all."*

*"... No person, regardless of residence, lineage, social status or other reason may lawfully claim the right to a wave, waves or wave break area along the California coastline."*

The inevitable has finally happened. The above words form the preamble of California's Open Waves Act, a proposed state law that would stiffen criminal penalties for surfers who practice "localism."

Localism can be as mild as flashing someone stink eye, a haughty stare filled with disdain, or as extreme as turning a surfboard into a weapon to spear or cut another surfer.

Typically, the purpose of such intimidation or harassment is to keep outsiders from overwhelming a surfing spot. Asserting territorial rights over a specific surfing spot is done as both a method of crowd control and to give priority to those who surf nearly every day at the same locale.

While he's never surfed, the author of the Open Waves Act, San Diego lifeguard chief Chris Brewster, has heard many complaints from surfers about the hassles they encounter from unfriendly locals.

The issue captivated Brewster's interest after one of his lifeguards, 31-year-old Michael Peugh, was attacked in May during an off-duty surf session at one of the more obscure, hike-in surfing reefs along the Sunset Cliffs area of Point Loma.

Brewster was outraged when one of the surfers who pleaded guilty to the assault against the lifeguard was sentenced to a mere 20 days of community service work. The light punishment was especially galling given that the perpetrator was already on probation for his involvement in a similar beating in 1996.

Judges need to get a clue regarding the insidious nature of localism, which for many is ruining the sport, Brewster reasons. The Open Waves Act would also serve notice that such behavior will no longer be tolerated.

"The bottom line is that no one should feel intimidated to use the waves off the California coastline," Brewster says.

The Open Waves Act calls for minimum penalties of 30 days in jail for anyone convicted of using threats or intimidation to deprive someone from using the ocean to surf, swim, fish or dive, and a minimum of 60 days in jail if the harassment escalates to physical violence.

In addition, bullies who go ballistic can be banished for up to a year from the surfing spot where they went berserk.

But will jail time for the troglodytes who lose their tempers in the water really solve the problem?

"I can't say yet if this legislation is the answer," said Pierce Flynn, executive director of the Surfrider Foundation, which has an in-house legal team that's reviewing the Open Oceans Act.

Surfrider has been adamantly opposed to violence or intimidation in the surf.

Surfrider's South Bay chapter in Los Angeles County recently went on record to condemn the "terrorist-like activities of local Lanuda Bay surfers" in Palos Verdes. Speaking as an individual surfer, Flynn said he finds the idea of banning wave tyrants from their favorite breaks an "intriguing" way to ding such despots.

While he's adamantly opposed to violence in the lineup, Flynn worries that shallow, over-hyped media coverage of such legislation will only reinforce stereotypes of the low-brow mentality that much of the public ascribes to surfers.

Could the Open Waves Act skew the public's perception of what's really happening among surfers, the overwhelming majority of whom have never taken a swing at each other?

"I've seen only a few altercations," said Flynn, 45, "and I've surfed all my life."

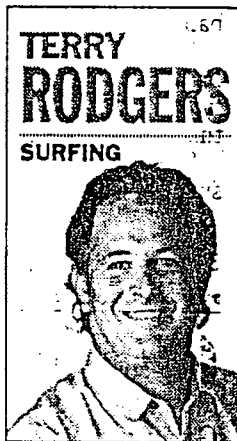
Steve Hawk, editor of *Surfer* magazine, was consulted about the new law, which he endorses in principle.

"I like the idea on its face because I hate localism in surfing," says Hawk. "It's totally unjustifiable."

But Hawk also has serious doubts that any law can eradicate the more subtle forms of localism that don't break the law but merely make outsiders feel uncomfortable enough to stay away.

Brewster has submitted his Open Waves Act to the city's intergovernmental affairs experts. A City Council committee eventually will review the proposed law and recommend whether or not to seek a state representative to sponsor the proposal and introduce it before the state Legislature.

The proposed law is certain to generate a lot of discussion about surfing and its future. The day of reckoning may have arrived.

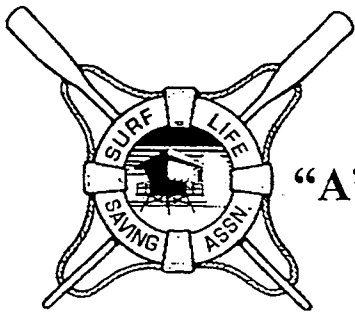

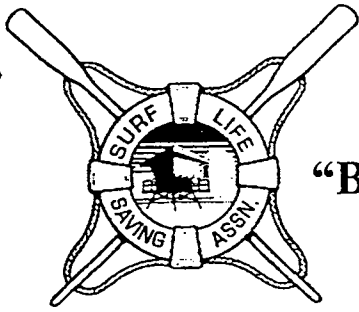

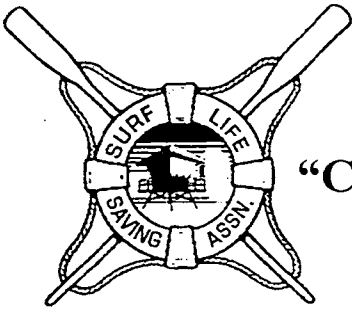

# HEROIC ACTS COMMITTEE

## CSLSA FALL MEETING 1998

On behalf of the USLA, CSLSA presented six Medals of Valor to Laguna Beach Lifeguards Kevin Snow, Tom Trager, Ormand Tegland, Mark Sproull, Patrick Quigley and Christian Corbo for multiple rescues performed in extreme mud slide conditions on the night of February 23rd, 1998. Awards were presented by USLA President, Bill Richardson, in a special ceremony at this fall meeting.

Committee considered one Medal of Valor nomination from Laguna Beach for lifeguard Patrick Quigley, for a multiple victim rescue performed on May 10, 1998 at Diver's Cove, Laguna Beach. Quigley entered a small rocky channel known as "Giggle Crack" in large surf conditions, rescuing three victims, a child and two adults. Quigley and victims were submerged for a multiple wave hold down and battered repeatedly against the rocks. Despite Quigley's urgent need for air, he refused to lose his grip on the ankle of the submerged child until several waves had passed and he was able to surface with the victim. Rescue meets criteria for Medal, and approval was recommended.

\_\_\_ additional nominations were presented for consideration in committee.

Committee recommends that a letter of commendation describing the rescue event be added to the Medal of Valor award. Currently recipients receive only the medal with no written documentation of the award. This proposal will be forwarded to the USLA Heroic Acts Committee at the Fall '98 meeting.
