

BOARD OF DIRECTORS MEETING PRESIDENT'S REPORT October 18, 2001

In spite of a relatively slow summer, weather-wise and rescue-wise, your Executive Board has been quite busy the last six months.

As you may recall from the Santa Cruz meeting, we entered into an agreement with Professional Event Solutions (PES) of San Diego to obtain sponsorship for our region last December. I wrote PES in June 2001 asking for an update on the progress of their efforts on our behalf. At that time, I was informed by Joan Ewing, of PES, that they had been unable to procure any sponsorship for us and that they were suspending their efforts. Fortunately, the contractor that we turned down in favor of PES, Scott Hubbell, of SHP, Inc. of Malibu was still interested in working with the CSLSA. We entered into an agreement with Mr. Hubbell on August 1, 2001 and we now have an offer on the table to sponsor our CSLSA Regionals, as well as our membership kits. This sponsorship package took considerable effort to bring to fruition, and would not have been possible without the help and hard work of Don Rohrer and the USLA Development/Sponsorship contractor, Dick Colosi. It was refreshing to see the spirit of cooperation between the USLA and our region, and between potentially conflicting national and regional sponsors. This sponsorship deal will be of great benefit to our region financially, and hopefully in terms of increased membership.

Imperial Beach did an outstanding job of hosting the CSLSA Regionals and Junior Lifeguard Regional Championships. The events were held on July 12 and 13 at the Imperial Beach pier. The weather was much more cooperative than last year, the surf was up again, and the water was cold again, but I think all competitors and spectators had a great time. Kudos to Hans Fernan and all of the Imperial Beach crew for a job well done. Thanks are also due to Bill Richardson, Bob Moore, Vince Lombardi, Don and Bev Rohrer, Chris Brewster, Gordon Gray, Russ Elwell, and the volunteer staff from Imperial Beach for running the adult event; and to the title sponsors Foster's and Sun Glass Hut, as well as the numerous local sponsors that helped make the event a success. LACOLA captured the team title, followed by San Diego City and Cal State Parks. Laguna, Del Mar and US Ocean Safety rounded out the top six. Complete results can be found at www.cslsa.org. The Junior Lifeguard Instructors ran the JG event in an equally exemplary fashion.

The USLA National Lifeguard Championships, hosted by the Miami Beach Chapter also went very well. It was well organized and well run, and our region did well, with LACOLA picking up the "large team" championship and San Diego taking third place. Heidi Hannenian was the overall high point scorer and winner of the Women's high point award. Anthony Vela came in second in the Men's division. Despite the heat and humidity, I believe that all in attendance will remember it as an outstanding event. Thank you Miami Beach. Marshall Parks is the new Competition Committee chairman, having graciously taken over the helm of the committee from me when I was elected President at the Santa Cruz meeting. Los Angeles County has stepped up with an offer to host the 2002 Regionals at Venice Beach next July.

If you have not checked out our website lately, you should. Vince Lombardi has done an excellent job in his position as Webmaster, and Pat Francis of RFP Consulting, has performed all of the maintenance and updates flawlessly. The website looks great and it includes links to almost everything you could ever need. You can even download past issues of *Cal Surf News*. Thanks for the good work Vince. Vince is also the co-editor, with Eric Sandy, of *Cal Surf News*, and your Recurrent Representative. Speaking of *Cal Surf News*, all current members should have recently received the latest issue, the best and biggest yet, featuring retired San Diego Chief Chris Brewster on the cover. The Summer 2001 edition of *American Lifeguard Magazine*, published and edited by Mike Bartlett, was also a new high water mark for our national publication. The submission deadline for the next issue was October 1, 2001(?). Keep up the good work Mike.

The New Zealand exchange program continues to be a great success, due in no small part to the leadership efforts of Chris Graham. The Kiwis toured our beaches this summer, taking in our Regionals and the International Surf Festival and much, much more. The selection committee interviewed four men and four women in one of the most competitive selection processes to date. Thank you to the members of the committee, Scott Deiderich of Laguna Beach, Vince Lombardi of Camp Pendelton and Eric Sandy of Del Mar. I will leave it to Chris to disclose the winners.

We have been busy on the international front as well. The USLA team picked up fourth place in the Goodwill Games Lifesaving competition. Six of the nine members of the team came from our region. Congratulations to Blaine Morgan, Rob Pelkey, Anthony Vela, Paige Gallas, Diane Graner-Gallas, Heidi Hannenian, to and the three members from other regions, Tim Green, Tim Harris and Alyse Mullon for representing us so well. Rescue 2002 is just around the corner in Daytona Beach. Our own Mitch Kahn has been selected as coach, and team selection is being finalized. Chris Brewster and Marshall Parks should be filling in the details on these events.

The Junior Lifeguards had another good year, and aside from some minor issues involving "soft" paddleboards at the Regional Championships, that I believe have been resolved, they have continued to grow both in membership and productivity. The Poster Contest went very well and I understand that we have some excellent new artwork that can be utilized in future public education campaigns. Reenie Boyer will be presenting the Poster Contest winners and giving us an update on Junior Guard happenings.

The most recent membership update I received from Chairman Don Rohrer was somewhat disappointing, with most of the chapters reporting a decrease in membership compared to last year. Membership is one of our most important concerns and I hope we can start turning things around, and work towards a 50% increase for next year. An attractive membership kit will be a real plus in this regard. Mr. Rohrer will elaborate in his membership report.

Steve White, the Public Education chair, accepted a promotion within the State Parks System to Superintendent of the Topanga Sector. Unfortunately, his workload in his new position prevents him from continuing as chairman of the Public Education Committee. He also will not be seeking re-election to his position on the Executive Board. I have a report from Steve that I will present during committee reports. I will be looking to appoint a new chair of the Public Education Committee at this meeting, so please let me know if you are interested. I am also interested in establishing a Statistics Committee that would work on standardizing reporting and compilation of statistics among all of our agencies. Anyone interested in serving on, or chairing this committee, please talk to me.

This is an election meeting. We will be choosing the members of the Executive Board that will serve you for the next two years. At the Spring meeting in Santa Cruz, President Pro -Tem Bill Richardson suggested that you elect an individual that you would want to be President for the next full term. You elected me, and I am now seeking your support for my first full term as President. I believe we have accomplished a great deal in the last six months and look forward to serving you in the next two years. There is still much to be accomplished, both regionally and nationally for our organization. I know several of the current members of the Executive Board are interested in continuing on, but I will let them speak for themselves.

We recently lost two members of our lifesaving family from Florida. Erin Alkema of the Palm Beach County Beach Patrol passed away while on a swim workout, and Tom Renick of Volusia County, succumbed to cancer on October 1. The CSLSA sent our condolences to both families and contributed \$100.00 to the Tom Renick Fund to help Tom's wife and children. Finally, I would like to thank the members of the Executive Board and you, the members of the Board of Directors, for your support and advice over the last six months. **INDEPENDENT CONTRACTOR CONSULTING AGREEMENT
FOR MARKETING SERVICES**

[REDACTED]

This Independent Contractor Consulting Agreement for Marketing Services ("Agreement") is made on this 1st day of August, 2001, by and between California Surf Lifesaving Association, ("CSLSA") and Scott Hubbell Productions, ("SHP, Inc.").

RECITALS

1. CSLSA retains the services of SHP, Inc. to market the CSLSA to corporate sponsors. SHP, Inc. shall provide these Services to CSLSA, as an independent contractor. CSLSA's retention of SHP, Inc. to provide marketing services on behalf of CSLSA is an exclusive relationship and CSLSA shall not enter into any other marketing contracts with others during the term of this Agreement.
2. As part of this Agreement, CSLSA and SHP, Inc. shall hold each other free and harmless from any liability, losses, claims, damages, costs and attorneys fees arising from any third party claims.

COVENANTS

For mutual and valuable consideration, receipt of which is hereby acknowledged, CSLSA and SHP, Inc. hereby agree as follows.

1. SERVICES OF SHP, Inc.

- (a) SHP, Inc. agrees to meet the minimum obligations described in Exhibit "A" (the "Services") attached to this Agreement, but shall not be limited to these goals and objectives. SHP, Inc. and CSLSA will determine the method, details, and means of performing the Services.
- (b) SHP, Inc. understands that CSLSA is a party to a contract with Foster's for the year 2001 and that sponsors sought by SHP, Inc. cannot be in conflict with the agreement between CSLSA and Fosters for year ending December 31, 2001.
- (c) SHP, Inc. understands that CSLSA is a party to contract with Panama Jack Sun Care Products and Sun Glass Hut through CSLSA's relationship as a Region of the United States Lifesaving Association. CSLSA agrees to provide information regarding limitations such contracts may impose upon CSLSA.

2. COMPENSATION

- (a) In matters relating to provision of "in kind product", CSLSA and SHP, Inc. shall mutually agree upon the product on a case-by-case basis before such agreements are made on behalf of CSLSA, and SHP, Inc. agrees to obtain such agreements at no cost to CSLSA.
- (b) Sponsorship marketing services will be provided to the CSLSA for no up front charges.

- (c) SHP, Inc. will not charge the CSLSA a percentage of gross revenues as part of the compensation for their services. SHP is free to negotiate compensation packages with potential sponsors.
- (d) SHP, Inc. agrees that the CSLSA Executive Board must approve all potential sponsorships.

3. TERM OF AGREEMENT

The term of this agreement shall commence upon the effective date of the Agreement and shall continue through December 31, 2002 (the "Initial Term"), unless extended in the manner hereinafter provided.

4. EXTENSION OF TERM

Notwithstanding the above, in the event that during the Initial Term of this Agreement, SHP, Inc. obtains \$60,000 in product and cash on behalf of CSLSA from sponsorships, advertisements and endorsements of products, services and ideas and also from sponsorship and advertisements relating to the Events, including the 2002 Regional Championships, then the Initial Term of this Agreement shall be extended for an additional two year period, through December 31, 2004 (the "Extended Term"). SHP, Inc. will acquire a minimum of \$200,000 in product and cash for the Extended Term. Once SHP, Inc. reaches this performance the Extended Term will be continued an additional two years through December 31, 2006. The Initial Term, the Extended Term and any additional extensions are sometimes collectively referred to in this Agreement as the "Term."

5. CANCELLATION CLAUSE

CSLSA and SHP, Inc. mutually agree that either may cancel this agreement with thirty (30) days written notice to the other based on violation of the agreement which cannot be remedied during such 30 day period.

6. GRANT OF RIGHTS

CSLSA hereby:

- (a) grants to SHP, Inc. the right to act as the exclusive representative of CSLSA to solicit and negotiate arrangements and agreements for sponsorship, advertisement and endorsement of products, services and ideas utilizing the Name and Rights during the Term of this Agreement and also to solicit and negotiate arrangements for sponsorship of the Events;
- (b) engages SHP, Inc. to produce, promote and solicit sponsorships and advertisements for the 2002 Regional Championships;
- (c) engages SHP, Inc. to manage and administer and act as the exclusive representative of CSLSA to solicit and negotiate arrangements and agreements for sponsorship, advertisement and endorsement of products, services and ideas utilizing the Name and Rights during the Term of this Agreement and also to

solicit and negotiate arrangements for sponsorship of the Events. Notwithstanding the above, however, SHP, Inc. agrees and understands that any and all sponsorships, advertisement or endorsement agreements negotiated by SHP, Inc. will be subject to the approval of the Board of Directors of CSLSA (the "Board") and shall be signed only by the President of CSLSA or his designee.

7. DUTIES OF SHP, INC.

SHP, Inc. shall do all of the following:

- (a) Subject to Board approval, develop proposals for sponsor and advertiser categories and areas of involvement of sponsors and advertisers, as well as develop sponsorship and advertiser packages;
- (b) Initiate and develop contracts with sponsors and advertisers, and potential sponsorships, advertisements and endorsements, in an effort to maximize revenues therefrom;
- (c) Negotiate all sponsor, advertisement and endorsement agreements on behalf of CSLSA, on terms and conditions approved by the Board.

8. RELATIONSHIP OF THE PARTIES

SHP, Inc. enters into this Agreement as, and shall continue to be, an independent contractor. Under no circumstances shall CSLSA be construed as an employer, partner, agent, or principal of SHP, Inc. CSLSA shall not be liable for any benefits provided to SHP, Inc. employees including worker's compensation, disability insurance, vacation or sick pay.

SHP, Inc. agrees to devote such time as SHP, Inc. deems necessary to the performance of the Services. Consistent with this requirement, SHP, Inc. may represent, perform services for, or be employed by any additional persons, or companies as SHP, Inc. sees fit, provided such employment will not result in a breach of any obligations of SHP, Inc. as stated herein, or present any conflict of interest which would have any detrimental effect on CSLSA.

SHP, Inc. agrees to submit quarterly activity summary reports to CSLSA, in writing, outlining activities of SHP, Inc. on behalf of CSLSA.

9. INTELLECTUAL PROPERTY, CONFIDENTIALITY AND NON-COMPETITION

- (a) The expressions whether oral, written, printed, graphic, or electronically recorded materials furnished by SHP, Inc. for use by CSLSA are Proprietary Information and the property of SHP, Inc. Proprietary Information also includes, but is not limited to, ideas, promotional concepts, strategies, specific customer profiles and information, customer and potential customer lists, client billings and accounting information, SHP, Inc. books and financial records, and information concerning SHP, Inc. employees, agents or divisions, and pricing information.
- (b) CSLSA will maintain in Confidence and will not, directly or indirectly, disclose, copy or use, either during the term of this Agreement or for a period of two years

thereafter, any Proprietary Information or confidential information or know-how belonging to SHP, Inc., whether or not it is in written or permanent form, without the express written permission of SHP, Inc.

(c) CSLSA shall continue to observe all obligations of existing contracts obtained by SHP, Inc. until such contract(s) have expired.

(d) In the event of any breach of these obligations by CSLSA or SHP, Inc., in addition to any other remedies available to either party, such party shall be entitled to injunctive relief to enforce the covenants stated in this section.

10. NO ASSIGNMENT

CSLSA may not assign any of its rights or delegate any of its duties under this Agreement without the prior written consent of SHP, Inc.

11. ARBITRATION

Any disputes between the parties relating to the enforcement or interpretation of any provision of the Agreement shall be submitted by the parties to final and binding arbitration in Los Angeles, California and shall be decided pursuant to the rules and procedures of the American Arbitration Association. Any award rendered in conjunction with such arbitration shall be enforceable in a court of competent jurisdiction and said court shall issue a judgment pursuant to the ruling in any such arbitration. This Agreement shall be governed by and construed in accordance with the laws of the State of California, as if made by and between California residents and as if to be wholly performed within said State.

12. ATTORNEY FEES

In any action, arbitration, litigation, or other proceeding by which one party either seeks to enforce its rights under this Agreement (whether in contract, tort, or both) or seeks a declaration of any rights or obligations under this Agreement, or in any other action, arbitration, litigation or other proceeding arising out of this Agreement, the prevailing party shall be awarded reasonable attorney fees, together with any costs and expenses, including expert witness fees, to resolve the dispute and to enforce the final award and any resulting judgment.

13. GOVERNING LAW AND SEVERABILITY

This Agreement shall be governed by and construed in accordance with the laws of the State of California applicable to agreements between California residents entered into and to be performed entirely within California. If a court or other Tribunal of competent jurisdiction holds any provision of this Agreement to be unenforceable, the remaining portions of this Agreement shall remain in full force and effect.


15. COUNTERPARTS

C.S.L.S.A. 2001 EXECUTIVE BOARD MEETING VICE PRESIDENTS REPORT OCTOBER 2001

I. Agency Contacts

I.A. Communicated with a number of agencies and their representatives on several topics that concerned our state and national organizations and professional lifesaving and public safety in general.

I.B. Invited to address the Annual Hawaiian Lifeguard Association Conference as Keynote Speaker in September. After interacting over two days with Hawaiian lifeguards and lifeguard management, it definitely appears that lifesaving and the lifeguard profession on each of the major islands are receiving much more positive attention from their governmental agencies and the public in general. Maui, Kauai, Hawaii and Oahu have increased the personnel on their crews. Maui doubled its numbers. All areas of personnel, public relations and safety education are moving forward at an unprecedented pace. Maui is requesting certification by USLA at the November national meeting. One major influence may be that of Baywatch Hawaii. I have made my outlook on this topic known in the past.

II. CSLSA Membership

Continued work on CSLSA membership with membership coordinators in all state chapters, the CSLSA treasurer, national membership chairman and national treasurer. To date, we have a total membership approximately the same as Year 2000 (1000 professional members). Some chapters have not submitted to me, as of this date, any membership applications or dues (may have submitted to nationals

and we have not received that complete roster). Other chapters have recorded fewer members than last year while a few have more members. A report on Yr 2001 membership is attached. I recommend that the President or his designee contacts the chapters that have dropped significantly in numbers or that have no membership at all. The contact would be to determine (1) the reason(s) for the change in or lack of membership and (2) if we are suggested as the possible cause, seek suggestions on how CSLSA can better serve its members and chapters and/or how to bring more lifeguards to the organization. Thanks to all who worked with their chapters to bring this to a near completed task. We still have some procedural areas to correct particularly as they relate to processing applications that are received by National and to more timely access to their database. However, overall, it appears that the changes instituted are helping to provide more accurate records on our membership.

III. Tax Exemption Status

I was under the impression that CSLSA never had a tax-exempt status. This is not completely true, as I previously reported. We are nonetheless without a tax-exempt status at this time. As I now understand past events, at one time, CSLSA did apply for and receive tax exemption as a non-profit 501 3 © organization. Then, when the California "SLSA" became national and added other Regions across the country, CSLSA relinquished its status to the new national USLA. As a result, CSLSA no longer qualifies as a 501 3 © organization for tax purposes. This puts us at risk when we collect funds from contributors and/or apply for grants. Contributors cannot legally use their donations to CSLSA for tax write-off purposes unless we are a non-profit organization recognized by state and federal governments. And, even more of an issue could be that when we do generate funds without this status, we could possibly have to pay taxes to these governments on our "earnings". In light of all that is occurring with the growth and expansion of CSLSA, it is recommended that we form a subcommittee as soon as possible to review our by-laws and other documents needed to qualify CSLSA as a 501 3 © organization and to acquire our own tax-exempt number as soon as possible. This may require the services of an attorney, but the costs should be minimal.

IV. Errors and Omission Insurance and Risk Management

As our Region continues to grow in members and financially through dues, fund raising and other contributions (in kind and monetary), we are possibly placing ourselves, as an organization and as individual members of the Executive Board, more at risk for lawsuits and/or other types of legal actions. The Executive Board should be made aware of what legal protections are available for their collective and individual actions while serving on behalf of CSLSA (i.e. errors and omission insurance, etc. and to what limits). If we are insured, do we need to review the policy to insure that the limits as a result of our growing financial position and other exposures are adequate? The Executive Board also may want to look at the requirements for liability insurance (i.e. listing CSLSA and its officers as additional insured and to what limits) when sponsoring or co-sponsoring activities where injuries by participants in these activities could be a possibility. As an example, during the 2000 national competition held in San Diego, a competitor injured his leg. He is pursuing legal action as a result of the injury. Is CSLSA covered? Are we, as an Executive Board, covered? Typically, in incidents, such as this, there is a long list of defendants (deep pockets). Our pockets may not seem deep to us, but to others, who knows. I would recommend that the President appoint a subcommittee to investigate all of these areas and report back at the next executive meeting on the results of their investigation and recommendations, if any.

V. CSLSA Web site.

Vince Lombardi has done an excellent job with our website. I have received many positive comments on the content and its appearance. The materials are current and accurately reported. I am sure you will all agree that the site is something we can be proud of and most useful as a tool to advance the organization. I would recommend a commendation on behalf of the Executive Board to Vince and any other contributor he feels worthy. This was a major goal that has been accomplished, and we should recognize those who made it happen.

VI. Public Relations

After being contacted by MSNBC on the production of "Danger Beach", I worked closely with its producer and the Lifeguard agency involved. It was filmed almost entirely on the North Shore of Oahu. There are always major concerns, when asked to assist with such a project. It is important that our profession be represented in the most professional and realistic manner possible and this does not always happen when dealing with "entertainment". In this case, however, the producer and her assistant did an outstanding job of presenting lifeguarding in a positive manner. After the airing, I made contacts with the MSNBC staff to offer congratulations and express a personal opinion that what was portrayed in the show was accurate and responsible reporting. If anyone in our Region had an opportunity to see the show, I hope they would have concurred. In the future, it may be appropriate that when we see such a show or read "good press" on lifeguarding, we could report this to the secretary. He or she then would have a "more or less" form letter signed by the President that could be sent in appreciation to the responsible party or parties. This could not only help to reinforce the accuracy of their reporting but, in addition, contribute to the visibility of CSLSA, and our profession.

Report to the CSLSA Board of Directors

B. Chris Brewster

October 18, 2001

It has been my continued pleasure to serve the members of CSLSA, USLA and the Board of Directors. The following are some items of information, along with projects on which I have been working on your behalf:

- USLA Textbook – I am working to edit a second edition of The United States Lifesaving Association Manual of Open Water Lifesaving. Work has been delayed due to unforeseen circumstances, but work continues. We hope to have a new manual by this time next year.
- Central and South America – In my role as Liaison Officer for USLA and President for the Americas Region of ILS, I have been working to help support lifesaving development in Central and South America. In early November, a team of two volunteer lifeguard trainers will travel to Bolivia to train some 20 persons in lifesaving. Their airfare is paid by ILS. The American Red Cross has provided extensive support. I am also in communication with two organizations in Costa Rica, one in Venezuela, and one in Chile. When combined with the well-organized lifesaving groups in Brazil, Uruguay, and Argentina, it is evident that we are moving forward in Latin America.
- Goodwill Games – For the first time ever, lifesaving competition events were placed before a truly international audience as lifesaving was featured in the Goodwill Games. The competition was beautifully conducted, with great pageantry. My compliments to all of the competitors, the coach, and the USLA Medical Advisor for their extensive work to make this a historic event.
- Rescue 2002 – Preparations for Rescue 2002, May 7 – 19 in Daytona Beach continue. This promises to be an extraordinary event. Please visit www.rescue2002.com for details. A new international rule-book has been completed and will be available for download from the ILS and Rescue 2002 site within a couple of weeks.
- USLA National Championships 2002 – San Diego – The nationals return to San Diego on August 9, 10, and 11, 2002. An organizing committee including Marshall Parks, Clyde Fuller, and I are working diligently, with the strong support of Byron Wear, to ensure that this event better our previous effort.
- Rio 2003 – After Rescue 2002, in Daytona Beach, the next meeting of the International Life Saving Federation Board of Directors will take place in Rio de Janeiro. This meeting will include a lifesaving conference and a sport development event. It is hoped that this meeting will help to further develop lifesaving in Central and South America.
- Lifeguard Efficacy – Some years ago, at the suggestion of Ralph Goto, Christine Branche, PhD. of the Centers for Disease Control and Prevention (CDC) convened a meeting of experts to discuss the efficacy of lifeguards. These experts included Bill Richardson, Rick Gould, Carl Martinez, and me. The goal was to evaluate the effectiveness of lifeguards in reducing the incidence of drowning. The result is a publication of the CDC, which will be published within a week, and which has enormous potential for justifying the provision of well trained and equipped lifeguards to eliminate drowning. This report, using very valuable USLA statistics compiled by Rick Gould and statistics on the cost of deaths, shows clearly how valuable to a community a lifeguard force can be and the devastating consequences of diminishing or eliminating one, as well as the value of creating one. Considering this comes from the internationally respected CDC, it should be of tremendous value to lifesaving, and to protecting lifesaving budgets. Dr. Branche will make a presentation on this report at the USLA Board of Directors meeting in Idaho. The report will be posted on the CDC website and the USLA website for download.

- WHO – The World Health Organization is publishing Guidelines for Safe Recreational Water Environments. Initially, this publication included only minor reference to lifeguards. The International Life Saving Federation intervened and has asked me to edit the publication to include reference to the value of lifeguard protection. I am working on that project presently.
- Assembly Bill 663 – The San Diego Municipal Employees Association has successfully sponsored a bill, carried by Assemblymember Juan Vargas, to expand workers compensation benefits to California lifeguards. In a nutshell, this legislation creates a rebuttable presumption that skin cancer in a lifeguard was caused by the lifeguard's employment. This extends to lifeguards who have worked more than three consecutive months in a year and, after termination, extends three calendar months for every year the lifeguard worked, up to 60 months. The primary benefit of this legislation is that it creates a presumption that skin cancer was caused by the lifeguard's employment, rather than the lifeguard having to prove that to be the case.
- World Congress on Drowning – I continue to help organize The World Congress on Drowning 2002, which will take place in June 26 – 28, 2002 in Amsterdam, The Netherlands. This conference will include a very wide range of the latest information on rescue, resuscitation, prevention, and so on. It is highly recommended. The location is a beautiful European city. For details, see www.drowning.nl.
- Australian Tour – A group of Australian lifesavers from North Sydney Beaches toured the US in August. As Liaison Officer for USLA, I arranged contacts and some tours. In San Diego, they toured the San Diego Lifeguard Service, Camp Pendleton, and Imperial Beach. This tour had a strong research element and all hosts reported that the lifesavers were particularly keen to learn about the lifeguard agencies they toured.
- Lifeguard Agency Certification Program – The USLA Lifeguard Agency Certification Program now has 101 lifeguard agencies and four Aquatic Rescue Response Agencies certified or in the application process. In June I visited Panama City Beach, Florida and, based on my observations, recommended that the USLA Board of Directors revoke certification of Beach Watch, which was first certified in November 2000 in Newport Beach. The Executive Board of USLA concurred. My thanks to the Certification Officers from our region -- Bill Richardson, Eric Bauer, Rick Gould, Ralph Goto, and Max Bowman -- for all their work on this important USLA program.
- USLA/ILS Websites – I continue to manage the websites of both organizations. Over the next year, upgrades are planned to improve the look and usability of each. I welcome comments and suggestions.

An act to add Section 3212.11 to the Labor Code, relating to workers' compensation.

LEGISLATIVE COUNSEL'S DIGEST

AB 663, Vargas. Workers' compensation: lifeguards.

Existing law provides that an injury of an employee arising out of and in the course of employment is generally compensable through the workers' compensation system. Existing law provides that, in the case of certain law enforcement officers and firefighters, the term "injury" includes heart trouble, hernia, pneumonia, and other injuries and diseases.

This bill would provide, with respect to active lifeguards employed, for more than 3 consecutive months in a calendar year, by certain local agencies and the Department of Parks and Recreation, that the term "injury" includes skin cancer that develops or manifests itself during the period of the lifeguard's employment.

This bill would further create a rebuttable presumption that the above injury arises out of and in the course of the lifeguard's employment if it develops or manifests during the period of the employment.

THE PEOPLE OF THE STATE OF CALIFORNIA DO ENACT AS FOLLOWS:

SECTION 1. Section 3212.11 is added to the Labor Code, to read:

3212.11. This section applies to both of the following: (a) active lifeguards employed by a city, county, city and county, district, or other public or municipal corporation or political subdivision, and (b) active state lifeguards employed by the Department of Parks and Recreation. The term "injury," as used in this division, includes skin cancer that develops or manifests itself during the period of the lifeguard's employment. The compensation awarded for that injury shall include full hospital, surgical, and medical treatment, disability indemnity, and death benefits, as provided by the provisions of this division.

Skin cancer so developing or manifesting itself shall be presumed to arise out of and in the course of the employment. This presumption is disputable and may be controverted by other evidence, but unless so controverted, the appeals board shall find in accordance with it. This presumption shall be extended to a lifeguard following termination of service for a period of three calendar months for each full year of the requisite service, but not to exceed 60 months in any circumstance, commencing with the last date actually worked in the specified capacity.

Skin cancer so developing or manifesting itself in these cases shall not be attributed to any disease existing prior to that development or manifestation.

This section shall only apply to lifeguards employed for more than three consecutive months in a calendar year.

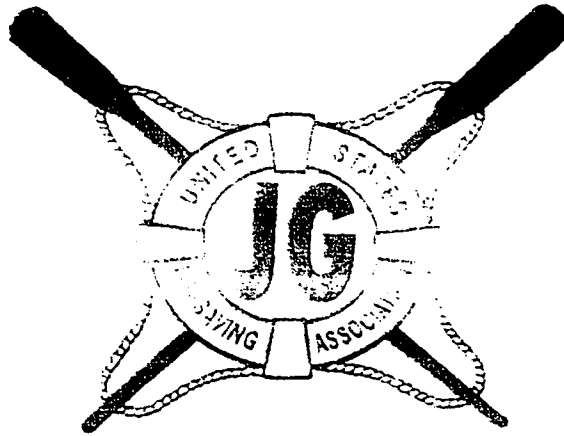

Regional Competition

COMPETITION COMMITTEE REPORT OCTOBER 19, 2001

2002 Southwest Regional Championships

The 2002 Championships will be hosted by the Los Angeles County Lifeguard Service at Venice Beach on Saturday, July 27, 2002. The Junior Guards will compete at the same location on Friday, July 26, 2002.

Future Southwest Regional Championship Sites

After discussion, it was decided to continue requesting agencies to host the event for two consecutive years. Los Angeles County has agreed to host the event in 2003

Awards

Do to fiscal concerns, it was decided that host agencies will continue to determine the type of awards to be provide participants at Regionals. In recent years this has included T-shirts, towels, mugs and medals.

Rescue 2002

It was announced by USLA National Competition Committee Chair Rob McGowan that Mitch Kahn has been designated as coach of the 2002 USA National Team. Mr. McGowan also reviewed the selection process and makeup of the team, which will represent the USA at the World Lifesaving Championships hosted by Daytona Beach, May 7-19, 2002.

2002 USLA National Championships

The team championship at Nationals is now divided into two categories based on the number of chapter employees. Agencies were encouraged to take advantage of this and field a winning team at the 2002 Championships in San Diego.

The 2002 National Championships will be hosted by San Diego, August 8-10, 2002. The competition site is South Pacific Beach, the same venue as in 2000.

USLA Competition Rule Change Proposals

The Committee reviewed the proposed rule changes which were presented at the USLA Spring Board of Directors Meeting. These included:

1. Eliminate the 24-hour volunteer requirement for former employee competitors.
2. Change course distances to match those used in international competitions.
3. A proposal to implement changes designed to expedite the USLA National competition.

The Committee agreed to support proposals one and two. After reviewing the merits of the third proposal, it was decided not to support it.

Suggestions for the 2002 National Championships

Don Rohrer has provided the USLA National Competition Committee Chair with several recommendations regarding the 2002 National Championships. In summary, they are as follows:

- Officials should wear uniforms provided when they are serving in an official capacity
- Officials have the responsibility to know the rules of competition and must abide by them without fail.
- Have a cordless drill and auger at each course.
- Have two sets of start/finish flags available on each course.
- Provide a portable copier at the recorder's tables.
- Provide a kit to each recorder's station containing all necessary materials.
- Have a special area designated to meet the needs of master, vets and super vet competitors.

Other suggestions by the Committee for future events included:

- Provide a source of water on the beach for competitors
- If competitors are required to wear rash guards while competing, ensure that a variety of sizes are available.
- Official's uniforms should come in a variety of sizes and be appropriate for anticipated environmental conditions.

(All soft Boards approved as of Fall 2001 are: Doyle, BZ, Nipper) Any other new style/manufacturer of all soft boards must be approved at the Fall CSLSA Junior Lifeguard Committee meeting to be used at the Regional Competition the following summer.
- There will be a Meet Manager position added to the Regional Competition Rules. The meet manager will appoint a committee of three to solve any issues that arise at the Regional event. The idea is that this position will remain consistent even when the venue changes every two years. Dave Simcox, Huntington City Beach Junior Lifeguard Coordinator, has volunteered to act as the Meet Manager for the Junior Lifeguard Regional Competition.

Old Business

Public Education Booth

The booth is currently at San Clemente. Mr. Humphreys stated it is in very poor shape. It will be brought to Newport Beach and inspected for repairs. We will make the repairs necessary with the \$300 that was previously allocated for a spinal display. We will re-address adding information (e.g. spinal display) at the spring meeting. I will also look into the current checkout program and develop an accountability of usage for the booth.

I will also follow up on the purchase of a canopy (similar to an "Easy-Up") that \$600 has been allocated for and yet to be purchased.

Grant Money

The committee has decided to table any application for the "Whale Tail Grant" until the spring meeting. The reason is the due date for the application is October 31st and there will not be sufficient time to put it together. Mr. Silvestri will invite outside representatives to the spring meeting on how to fill out the paperwork and the best way to approach funding from grants.

We have asked the board for ideas that the grant monies could be used for to be brought to the spring meeting.

Temporary Tattoos

This is a subject that has been tabled for two to three meetings. It was redressed and decided not to go further with the idea. We understand that it would be well received by the children, however, the subject of body art/tattoos is a concern for parents/guardians. We might not portray a positive message in the minds of some. Individuals, if interested, may put this as a new item for a future meeting.

USLA Posters

Mr. Humphreys will send me the most recent promise letter from Mr. McKenna (USLA Public Education Co-Chair). I will address this issue with Mr. McKenna and Mr. Williams at the USLA meeting in Idaho.

Public Service Announcement

Mr. Rohrer has asked me to look into getting funding for a PSA by working with Mr. Hubbel. I will work with Mr. McGowan to address the possibility of this idea.

New Business

Coastal Challenge

The public education committee has given our support to assist Mr. John Anderson, Cal State Parks, with his coastal challenge, similar to the old coastal crusade.

Its purpose is to promote water safety and beach education. The 8-day event will coincide with the national beach safety week May 20th – May 27th.

He is currently working with Mr. Kramer in organizing the event, and will correspond with Mr. McGowan to possible get sponsorship from Mr. Hubbel. Mr. Anderson is looking for involvement from each chapter/agency when he is in that municipality or park.

More will follow at the spring meeting.

Age Targeting

We have decided to address at the spring meeting an age appropriate target for public education handouts. The time frame will be either 6 months or a year depending on funding and status of current handouts/information. With the current implementation of either book covers or bookmarks using the JG picture winners, it appears this year we will target elementary age children.

New Public Education Handouts

The committee voted to use the Junior Guard poster winners as a design for new handout information. The new handout information will be in the form of either bookmarks or book covers, depending on which will be more cost effective. The board has approved up to \$1500 to come out of the Junior Guard funding to use for this project.

Mr. Silvestri will solicit bids by November 16th, 2001. The committee will then decide which will be more cost effective and better received.

Mrs. Boyer and myself will investigate into the copyright aspect of using the pictures.

Mrs. Boyer will also obtain written permission from each winner to use their poster for an educational handout.

Lecture in Ventura

Mr. McGowan has promised Jackie Eldridge from Tetra Tech, Inc. a lecturer to attend and give a presentation on May 16, 2002 from 7:00pm – 9:00pm. Mr. Silvestri, Cal State Parks, will look into assigning one of his employees for this assignment.
