PRESIDENT'S REPORT TO THE BOARD OF DIRECTORS April 12, 2007

Welcome to Los Angeles County and the Spring 2007 CSLSA Board of Directors Meeting. I would like to thank LACOLA for hosting the meeting and Charlotte Graham for doing the majority of the work to get the meeting organized. Not only did Charlotte arrange the details of the meeting, as membership chair she has been very busy putting together our membership kits which should be a big hit with our members. I would also like to thank our lifeguard management and the County of Los Angeles Fire Department for their continued support of our involvement in the USLA.

The lifeguard community and the USLA lost one of our founding fathers when retired Newport Beach Chief Kendall "Jake" Jacobsen passed away on March 24, 2007. Jake was instrumental in the formation of the USLA and he will be missed. My condolences go out to his family and friends. Memorial Services will be held at the American Legion Hall Post 291, at 15th St. in Newport Beach on the Peninsula at 4:00 pm, next Tuesday, April 17th, and I would like to dedicate this meeting in his honor and memory.

As anyone who has been to the beach over the last few months is well aware, our season is off to an early start. We've already had a good half dozen weekend days with air temperatures in the eighties at the beach this year, bringing summer-like crowds to Southern California beaches. Our lifeguard services are getting ready for spring, holding swim tryouts, training academies and preparing for another season of Junior Lifeguards. With some pretty decent winter swells over the past few months, the bottom is cut up enough that it should be a busy rescue season for us once the water warms up a bit.

Following our last CSLSA Board of Directors meeting in Morro Bay (thanks Herb White), the Pacific Northwest Region hosted the USLA National Meeting at Lake Tahoe last November at the Tahoe Ridge Resort. It was a great venue on the mountainside adjacent to the Heavenly Valley ski area. It wasn't quite ski season yet, but it did snow one of the days we were there. At the meeting Joel Gitelson of Los Angeles County was presented the Medal of Valor for his heroic actions involved in the rescue of three fishermen whose boat went aground on Santa Barbara Island on a cold, stormy winter night. His account of the event was featured in the Winter 2006 issue of American Lifeguard Magazine. Vic Maceo of the Galveston County Sheriff's Office Beach Patrol was presented a USLA Life Membership for his many years of service to the organization. Dr. Peter Wernicki, USLA Medical Advisor, discussed the U.S. Lifeguard Coalition comprised of the USLA, American Red Cross and YMCA. The focus is on research concerning many lifeguard related topics including scanning, breaks and training standards. The Educational Conference featured "The Making of a Beach Patrol Episode," "Everything You Wanted to know About Trauma Assessment," a presentation by the Douglas County Nevada Search and Rescue team, and a report on "Vamos a Nadar (Let's Go Swimming) - Drowning Prevention in Sonoma County, California." The next USLA Board of Directors Meeting and Educational Conference will be at the Best Western Inn of Chicago on April 26 through 28.

On the international front, the first International Life Saving World Water Safety (WWS) Conference will be held on September 27, 28 and 29, 2007 in Porto, Portugal. The hosts of WWS 2007 are the Instituto de Socorros a Náufragos (ISN) and the Associação de Nadadores Salvadores (ASNASA), both member federations of ILS. According to the *ILS News*, "WWS 2007 follows on the resounding success of the World Congress on Drowning 2002 in Amsterdam and the ILS International Medical Rescue Conference in 1997 in San Diego. The purpose of WWS 2007 is to bring together the world's foremost experts, systems and information for exchange, debate and further development that will lead to reduction of death and injury in all aquatic environments worldwide. The WWS 2007 will have two major events associated and simultaneous, one is the

Conference and the other is the International Water Safety Exhibition of lifesaving products, services and information."

In January a team of California Lifeguards went to Victoria, Australia to compete in the 19th Wieland Shield Competition at Torquay, celebrating 40 years of the biannual Wieland Shield competition and Lifesaving exchange between California and Victoria, and the 50th anniversary of the first international lifeguard competition, the 1956 Olympic Surf Lifesaving Competition at Torquay Beach. The team members included Manager Jay Butki (L.A. County), Coach-Athlete Scott Diederich (Laguna Beach), Chad Carvin (Laguna Beach Lifeguard and 2000 Olympic Silver medalist), Micah Carlson (L.A. County), Kyle Daniels (L.A. County), Blaine Morgan (L.A. County and Cal State Parks), Tyler Morgan (L.A. County), Brian Murphy (L.A. County), Mike Murphy (L.A. County), Micha Burden (Huntington City), Renee Locarnini (L.A. County), Tandis Morgan (L.A. County) and Bridget Rome (L.A. County). Accompanying the team as Educational Officers were Jamie Orr and Sean Kennedy both from L.A. County. Although the team did very well in the swimming events, they were unsuccessful in their attempt to become the first Californian team to win the shield in Australia. Micha Burden won the Women's Division of the Lorne Pier to Pub Swim, the largest ocean swim in the world. While in Victoria the team was set up with tickets to the Australian Open and a flight on the Life Saving Victoria Coast Watch Airplane.

In competition closer to home, the *California Surf Life Saving Championships* are scheduled for July 28 in Huntington Beach. Hosted by the HBSLSA, the venue will be at the south end of the beach between Towers 17 and 19, in the Beach Boulevard area, adjacent to the site of last year's Nationals. The Junior Lifeguards will be returning to Santa Barbara for their regional championships on July 20. The *USLA National Lifeguard Championships* are going to be in Myrtle Beach, South Carolina on August 9 through 11. The Crown Reef Resort has been selected as the host hotel and contact information is available on the USLA website Events Bulletin Board. The USLA Competition Committee has adopted ILS competition rules for the Nationals and the addition of the Oceanman relay as a point-scoring event. The updated rules will be available on the USLA website at http://www.usla.org/events/rules.asp. The Nationals return to our coast in 2008 hosted by Los Angeles County.

The CSLSA Executive Board meets monthly between Board of Directors Meetings. At our recent meeting Chris Graham, First Executive Delegate and Exchange Committee Chair, advised us that due to increased responsibilities at work, he would have to step down as the Exchange Committee Chair. I would like to thank Chris for his years of service in that position and thank Jon Mitchell of Newport Beach for stepping up to take over the Exchange Committee. Jon will chair the committee at today's meeting.

The City of Del Mar is seeking financial assistance from the California Conservancy to rebuild its slightly past its prime Lifeguard Headquarters. On behalf of the organization, I wrote a letter of support to the chief of the Coastal Conservancy. Good luck with the project Del Mar.

Thanks again to Steve Reuter for the outstandingly successful Public Education fund raiser "Big Wednesday" last summer. The fruits of his labors have been realized in the form of the "Be Safe Be Seen" poster designed by Huntington City recurrent lifeguard Melissa Murphy that will be distributed today. Melissa is also one of the primary organizers for this summer's California Surf Life Saving Championships

The long awaited *Patagonia* Pro Program is finally ramping up and should be available to all members in the very near future. The company is very sensitive about preventing abuse of this program. They offer their goods at extremely discounted prices to Pro Sales Program members and if they find you abusing the account by purchasing for non members, the account will be canceled and you will never be able to order through the program again. Bill Richardson and I met on March 14, 2007 and reviewed the CSLSA Policy and Procedures and the USLA Policy and Procedures. Bill as always had done a tremendous amount of work prior to my arrival. After about 8-9 more hours of hard work, we feel that we have addressed the new Bylaws of both organizations and have aligned the proposed P & P's for presentation and committee review where necessary at the respective Board of Directors meeting for approval.

If approved at both levels then each organization will be current with new Bylaws and P & P's that align. From that point on, as a working document, it will be a matter of upgrading based on Board of Director meeting actions.

It has been a while since the USLA and the CSLSA has been current and I want to personally thank Bill Richardson for his continued dedication and behind the scenes work that enhance the operations of both organizations.

I will be available for committee, review, explanation, or whatever the President and/or the Executive Board desires at this CSLSA Board of Directors meeting. I have respectively requested through the President and Secretary that the proposed CSLSA P & P's be placed on this Spring Board of Directors meeting agenda for adoption.

With the permission of the Executive Board and the Board of Directors, I propose that I be allowed to represent the CSLSA at the USLA Board of Directors meeting to make the USLA P & P's proposal in committee for adoption at the Spring USLA Board of Directors meeting.

On another matter, it has been brought to our attention that our treasury has been in the red as of late. Our Treasurer has been forthright with the financial situation. There are many things to consider regarding this fact.

Over the past few years, SHP has been the vehicle that has allowed us to get ahead on some of our projects. We have been able to increase our membership, which increases our income as well as our outflow. Our allocations have mounted and that depletes our general fund monies available to fund other items such as national meeting attendance, upgrading our public education display board, support for other projects that occur during the year, just to name a few. The Junior Lifeguard Committee has been generous with their support of Public Education Committee projects, but there are limits on what can be done. In the past when I was the Treasurer, I made a proposal splitting the JG income

received from the USLA, which would allow more general fund decisions and focus JG monies on JG items. That proposal was defeated. As promised, I said that I had learned my lesson and would not propose it again. I am however suggesting that the Junior Lifeguard Committee revisit the topic now that they have a significant allocation in the budget. If the JG Committee believes it is a relevant item then they can make a proposal i.e. from this year forward or temporarily or time specific to be revisited at a future date, etc. Or the JG Committee after discussing can say that the system in place is sufficient and no proposal is warranted.

Another reality is the fact that the CSLSA has for years been trying to get the USLA to contract with SHP to realize the benefits that are possible. The CSLSA has suffered over the years with the USLA regarding our relationship with SHP, to the point of suspending two of our members and possibly a split between the CSLSA and USLA. These rough times have been smoothed out a bit and as a result of the hard work of the different regions coming together to revise the USLA Bylaws. An element of trust has developed between the regions and currently the USLA is working with SHP on a national scope. Why do I mention this? By the CSLSA supporting the involvement of SHP and the USLA, the CSLSA has diluted it's potential income derived from SHP. This was expected. The CSLSA must look at ways to increase the membership allocation, which is currently \$5 per member in addition to support from SHP. That dollar figure was based on 1,000 members. Thanks to our earlier relationship with SHP we have surpassed 1,000 members so that the \$5,000 allocated for membership is currently less than \$5 per member. The CSLSA has gladly sacrificed for the betterment of the USLA. It is our hope that over time the entire USLA will be much healthier financially and be able to achieve more of it's goals which is our goal. And in turn, each region will benefit. Having brought this to your attention, please realize that the CSLSA believes in the USLA and our relationship with SHP and hopes that the USLA will also enjoy a fruitful relationship with SHP. If the CSLSA weathers the 'growing' period, which may take a few years, I believe we will benefit in the long run. So as the Past President/Advisor, I am asking, please be patient and assist with ideas on how we can reach our goals on a regional level. Whether the Cal Surf News be placed on the website to save money or get more sponsorship/advertisement to cover the cost of printing and mailing or scale back on what we are expending, we need to come together and make the CSLSA the best it can be. Our relationship with SHP remains positive and if there is any avenue for additional enhancements to our membership kits in addition to the work he is doing with the USLA it would greatly help the CSLSA meet it's membership obligations. Otherwise we need to look at how to do more with less.

Think about it! Let's have a great meeting and continue building our membership.

19th Wieland Shield Tour of Victoria, Australia-Jan 2-Jan 17, 2007

Celebrating the 40th Anniversary of the Wieland Shield and 50 years of International Competition. The Wieland Shield represents a long-standing relationship between the Los Angeles County Lifeguard Association (LACOLA) and Surf Life Saving Association Victoria (LSV). The exchange of ocean lifesaving knowledge, skills, and techniques has continued unbroken for the past five decades. The educational exchange has fostered many new and improved ocean rescue techniques, and equipment. Beach management and funding have also benefited. The ongoing relationship developed between Australia and the USA continues to serve the public these Lifeguards so heroically protect.

Our Competition started on day 3 of the Tour with the 27th Lorne Pier to Pub 1200 meter swim. Lauded as the biggest ocean swim in the world, 4300 swimmers, the online registration maxed out in 4 days.

Chad Carvin, Micah Carlson, Renee Locarnini and Micha Burden all qualified for the superfish category, the fastest 20 men and 20 women in the event. The racing wetsuit manufacturers were fighting to get wetsuits onto Chad and Micha, as the water temps were in the low 60's with scattered showers and whitecaps.

Men and Women superfish final was run together as one heat. Chad led most of the race from the gun by a body length and approached the surfline with one other. Unfortunately behind Chad and last year's winner Nick Cordner, was ex-Aussie Olympian and surf racing champion Daniel Kowalski in third place. Kowalski shot past on an outside wave from 10 body lengths back, Chad was not able to hang onto the broken wave, and Daniel body surfed it to knee deep, and Chad came running up the beach in a clear second.

Kowalski thrilled more than 25,000 fans to catch "a wave from God" and snatch the lead from Chad. Kowalski last won the Pier to Pub in 1996, the year he upstaged Kieren Perkins in the national titles. "It was a very big surprise (to win the title again)," Kowalski said, knowing his rivals had been training solidly. "I've got to thank the wave gods (for giving me a lucky ride). This event is amazing - until you've swum it, you don't know how good it is, with the crowd and all its colour." Kowalski said he was "hurting so bad" at one point, but he persevered to finish strongly.

In the women's Superfish event, Californian lifeguard Micha Burden clocked 15mins 28 secs to take out the sought-after title. Burden snatched the honours from six-time winner Naantali Marshall. Micha Burden crushed the women's field and beat seven of the guys, for her efforts she won airfare and hotel for 2 in Vanuatu, Tahiti for a swimming race there and \$1000 cash for her efforts. She also suffered a bloodied eye due to a male competitor kicking her in the goggles in frustration of being overtaken by a woman. Micha's comment was "I hope it gets a good colored bruise so I look vicious for the Shield!"

The Victorian were ready to bubble wrap the Shield for travel after that introduction to our swimmers but unfortunately at the Wieland Shield at Torquay, the Home team, Life Saving Victoria, beat us 74-54. California decisively won the Surf Teams, Surf Rescue Relay, and Men's Run Swim Run. Micha Burden won the Women's Swim, and the Women's Run Swim Run. But local knowledge, surf skills and home team advantage proved insurmountable.

The California Team was hosted by Ocean Grove, Anglesea, Torquay Surf Life Saving Clubs and was then hosted in Melbourne at the palatial head quarters of Life Saving Victoria and given complimentary tickets to the Australian Open where we watch Sharapova sweat in the 110 plus heat and 8 of our crew were given plane flights on the daily Coast Watch patrol flights.

A hearty "Thank You" goes to LACOLA, LACOLA Trust Fund, CSLSA, and SDSLA for their donation, and to Surftech, Surftech Australia, Xcel, and Bennett Surfboards for

their assistance with the tour. Surftech Australia set us up by delivering a 10 board quiver for our use, 5 longboards, 5 shortboards, so with all our 12 Surfboards, 8 paddleboards, and 6 surfskis we had quite a road warrior caravan.

Agenda Items for the 2007 Spring USLA National Board of Directors Meeting Southwest Region USLA Competition Rule Change Proposals- (listed in order of importance):

- 1. Add ILS Open Women's Board Rescue-maximum of 4 Teams per Chapter-this is an ILS event and raced everywhere else and our Women have been disadvantaged as it is not practiced by the USLA-Event to be held after the Men's Open Board Rescue on Day 2. Pre-lim heats as necessary on Thursday.
- 2. Add ILS Open Men and Open Women 3 person Surfski Relay-maximum of 4 Teams per Chapter-Open only held on Day 1-Friday. Prelim heats as necessary on Thursday.
- 3. Add ILS Open Men and Open Women 3 person Board Relay-maximum of 4 Teams per Chapter-Open Only held on Day 2-Saturday. Prelim heats as necessary on Thursday.
- 4. Establish an Open Point Score Championship-a second category in addition to the Overall-where points are accumulated only through Open events-no age groups. This would mirror ILS, and other Surf Life Saving Countries Championships.

Issues / Agenda items for the Competition meeting:

Discuss the required changes to the current course set up in order to meet agreed upon ILS Standards.

Competition Caps- Current USLA rules state "no numbers, writing or letters" -however we have Chapters that have writing on their current caps. ILS allows writing on the caps, but no advertising. We need to adopt ILS standards and get all our chapters caps in a data base. I've been asked by the ILS and SLSA to get a final list of Competition Cap designs from all the USLA chapters. The goal is to get them all the Cap designs from all the Chapters / clubs in the ILS member nations so they can be recognized and up on the web site. After this summer there will be no more duplication of design, only original designs / colors will be accepted by the ILS.

It's been a pet peeve of mine and I've tried over the past few National BoD meetings to get the regions to submit their Comp Cap designs, so we can set up a cheat sheet to aid the announcers at Nationals. We need to get this done and raise our game. I have a presentation to show when this topic comes up.

Discuss the Rescue Race changes-ILS Rules make this event into a 4 person open Men's and Open women's event adding two Rescuers on the beach to bring the victim on shore and across the finish line. All the other International Countries and the ILS use a Rescue Tube for this event clipping the victim in on the offshore side of the flag / buoy line, USLA currently uses a "Mini or maxi Rescue Can. Which should we be using at USLA events? Also discuss merits of adding ILS Rescue Tube Race for the Age Groups to replace the USLA Rescue Race.

Legislative Sub-Committee Meeting Report April 12, 2007 Redondo Beach, California

At the beginning of the meeting the Fourth Executive Delegate, and subcommittee chair, Alex Peabody led the group in a quick review of currently active legislative issues. The following legislative bills were discussed:

AB 124 Meal Breaks (Price) has been amended by the bills author and specifies that this legislation would only affect pool lifeguards and stage assistants:

226.8. (a) Notwithstanding any other provision of law, *pool* lifeguards and stage assistants employed by the state or any political subdivision thereof, including any city, county, or special district, may not be required by their employer to work during any meal or rest period provided for in Section 512 *required for non-exempt employees by Section 512 or by an order of the Industrial Welfare Commission*.

Recommendation: CSLSA to be neutral on this bill.

• AB 1458 Vessel Operator Certificates and Funding (Villines) has been amended, but continues to remain problematic for California State Parks and the funding the department receives to support is vessel recreation facilities and operations throughout the state park system. The appeal for most public safety agencies that deal with vessel operations on reservoirs and along the coast is that the bill would require a vessel operator certification for vessel operators.

Recommendation: Due to the negative fiscal impact on member organization, California State Parks, the CSLSA should be against this legislation until such time as the fiscal impact is eliminated from the bill

• AB 1355 County Sheriff Duties and Authority (Houston) would give the sheriff of each county, "the sole and exclusive authority to provide security and safety for the coastlines, harbors, and inland waterways, if any, as specified, except in counties that, prior to July 1, 2008, have vested the duties associated with the security and safety of the county's coastlines, harbors, and inland waterways to a law enforcement or public safety entity other than the sheriff." Under current law, the "sheriff of each county is required to give all possible aid and assistance to vessels stranded on its coast, and to the persons on board."

The proposed legislation seems intent on extending the authority of the county sheriff as identified in the following from the bill:

It is the intent of the Legislature that the sheriff of each county in this state, as the chief law enforcement officer of the county, **shall have the sole and exclusive authority** for the security and safety of the county's coastlines, harbors, and inland waterways.

The legislation may be problematic for some agencies in that is does not cite nor recognize the authority extended to the some agencies in situations where there may be concurrent jurisdiction.

It was brought up during the meeting that there were a number of California police agencies against this bill and that it is believed that the bill will not be successful.

Recommendation: CSLSA to remain neutral at this time and continue to monitor the bill.

The remainder of the meeting was devoted to reviewing statistical gathering forms and techniques of the agencies in attendance. Rick Gould, who developed the USLA statistics program was present to discuss his views of the challenges in gathering national lifeguard statistics. Carl Drake, retired from California State Parks and experienced in statistics issues was also present.

The following areas of concern were identified by the sub-committee:

- The importance of a national data base of aquatic safety statistics that is accurate and verifiable
- Variations in attendance calculations
- Variations in definitions of statistic criteria
- Lack of data on aquatic rescues and documentation
- Agencies (nationally) that fail to report drownings
- The need to incorporate statistics training into the educational conference portion of the USLA Board of Directors meeting
- The need for the USLA to post statistical forms on the USLA website

Action Items:

- Mr. Peabody to review the submitted forms and report back to the CSLSA executive board.
- That the CSLSA recommend at the USLA Spring BOD meeting:
 - Post statistics forms on the USLA website
 - Request a statistics training component at the next BOD meeting

Meeting adjourned.



Agenda Items for the 2007 Spring USLA National Board of Directors Meeting

Southwest Region USLA Competition Rule Change Proposals-

- 1. Add ILS Open Women's Board Rescue-maximum of 4 Teams per Chapterthis is an ILS event and raced everywhere else and our Women have been disadvantaged as it is not practiced by the USLA-Event to be held after the Men's Open Board Rescue on Day 2. Pre-lim heats as necessary on Thursday.
- 2. Add ILS Open Men and Open Women 3 person Surfski Relay-maximum of 4 Teams per Chapter-Open only held on Day 1-Friday. Prelim heats as necessary on Thursday.
- 3. Add ILS Open Men and Open Women 3 person Board Relay-maximum of 4 Teams per Chapter-Open Only held on Day 2-Saturday. Prelim heats as necessary on Thursday.
- 4. Establish an Open Point Score Championship-a second category in addition to the Overall-where points are accumulated only through Open events-no age groups. This would mirror ILS, and other Surf Life Saving Countries Championships.

Discuss the required changes to the current course set up in order to meet agreed upon ILS Standards.

Competition Caps- Current USLA rules state "no numbers, writing or letters" - however we have Chapters that have writing on their current caps. ILS allows writing on the caps, but no advertising. We need to adopt ILS standards and get all our chapters caps in a data base. I've been asked by the ILS and SLSA to get a final list of Competition Cap designs from all the USLA chapters. The goal

is to get them all the Cap designs from all the Chapters / clubs in the ILS member nations so they can be recognized and up on the web site. After this summer there will be no more duplication of design, only original designs / colors will be accepted by the ILS.

It's been a pet peeve of mine and I've tried over the past few National BoD meetings to get the regions to submit their Comp Cap designs, so we can set up a cheat sheet to aid the announcers at Nationals. We need to get this done and raise our game. I have a presentation to show when this topic comes up.

Discuss the Rescue Race changes-ILS Rules make this event into a 4 person open Men's and Open women's event adding two Rescuers on the beach to bring the victim on shore and across the finish line. All the other International Countries and the ILS use a Rescue Tube for this event clipping the victim in on the offshore side of the flag / buoy line, USLA currently uses a "Mini or maxi Rescue Can. Which should we be using at USLA events? Also discuss merits of adding ILS Rescue Tube Race for the Age Groups to replace the USLA Rescue Race.

Judges / Referee Clinic-only 5 officials currently from Southwest Region

4.7 GROUPS

All Open Men's, Open Women's and Masters age groups events will be run independently of each other.

Masters age groups may be run together and are run as FINALS IN THE MORNING. Other groups can be combined only with the consent of the affected competitors, or when two groups combined total no more than 16 competitors for craft events, and 42 for Surf Race or Run-Swim Run. (see 4.4 "Heats / Finals Competitor Limits"). All groups will always be placed and scored separately.

The usual order will be: Open Men first, Open Women second, 30-34, 35-39 Men third, 30-34, 35-39 Women fourth, 40-44, 45-49 Men sixth, 40-44, 45-49 Women seventh, etc."

2.) Edit USLA Comp rules 4.3 definitions and insert the proposed verbage:

HISTORY:

Competition Caps-

Current USLA rules state "no numbers, writing or letters permitted" -however we currently have Chapters that have writing on their caps.

ILS allows writing on the caps, but no advertising.

We need to adopt ILS standards and get all our chapters caps into a USLA Competition Cap data base.

I've been asked by the ILS and SLSA to get a final list of Competition Cap designs from all the USLA chapters. The goal is to get them all the Cap designs from all the Chapters / clubs in the ILS member nations so they can be recognized and up on the web site. After this summer there will be no more duplication of design, only original designs / colors will be accepted by the ILS.

It's been a pet peeve of mine that the USLA has no record of Chapter Competition Caps and I've tried over the past few National BoD meetings to get the regions to submit their Comp Cap designs, so we can set up a "cheat sheet" to aid the announcers at Nationals. We need to get this done and raise our game.

CURRENT VERBAGE:

4.3 BEANIES/HELMETS/JERSEYS" -- Each individual Chapter will be responsible to designate a color that will represent their Chapter. The Chapter's designated beanie must be worn on the head of the competitors at the start and finish of each event. Competitors must wear their current OFFICIAL Chapter's beanie, not that of any other Chapter. Beanies will be required in every event except the Surfboat event. In the Surfboat event helmets MUST BE WORN, color not important, due to boat identification. Designation of Chapter beanies, colors and design shall be subject to approval of the USLA Competition Chairman. Chapter beanies shall have no numbers, writing, or letters. Exception is made for chapters that wish to number beanies on the back with a height of no more than one inch. Competitors must wear their respective Chapter's beanie. All finalists must wear competition jerseys, if provided, in all events except the Surf Swim, Run-Swim-Run, Rescue Race and Landline swimmer.

PROPOSED NEW VERBAGE:

4.3 COMPETITION CAPS / HELMETS

Competition cap colors and designs must be approved and registered with the USLA Competition Committee. Designation of Chapter Caps, colors and design shall be subject to approval of the USLA Competition Chairman. Only registered colors and caps shall be permitted to be worn.

Competitors shall wear identical official Chapter competition caps in each event. The use of such caps assists in identification of competitors and teams and in event judging. In ocean events, caps are securely fastened under the chin and must be worn on the competitor's heads at the start of each event.

In all Surfboat events, competitors must wear safety helmets with the same conditions as Competition caps. Helmets may be of the same color and design as the Chapters competition cap and must be worn throughout any Surfboat event.

A competitor shall not be disqualified if the cap is lost after the start of an event provided that officials can identify that the competitor correctly completed the event.

Competition caps must not be removed from the head of the competitor until finish placings have been recorded, or permission is given by the Referee of the finish of the event.

In relay events this paragraph applies only to the final competitor of each team."

3.) Edit USLA Comp rules 4.4 definitions and insert the following:

4.4 Heats / Finals Competitor limits

The referee shall decide whether events shall be conducted in heats, semi-finals, or finals providing that the maximum number of competitors in a heat, or final race, shall

not exceed the following while also taking into account safety and the prevailing conditions:

Surf Race - 32 competitors Run-Swim-Run - 32 competitors

Rescue Race - 10 teams of 4 competitors, 40 total per heat Board Rescue - 10 teams of 2 competitors, 20 total per heat Landline Rescue Relay - 10 teams of 4 competitors, 40 total per heat

Beach Flags - 16 competitors

Beach Relay - 10 teams of 4 competitors, 40 total per heat

Beach Run- 2 km - 50 competitors per heat

Surf Ski Race - 16 competitors Surfboat Race - 10 teams of 2 competitors, 20 total per heat Rescue Board Race - 16 competitors

Ironman / Ironwoman - 16 competitors American Ironman / American Ironwoman - 16 competitors Taplin Relay - 16 teams of 4 competitors, 64 total per heat "

4.) Edit USLA Event 5.10 "Surfboat" definitions as defined below:

Recommended Surfboat Rule Clarifications:

Boat Markings
 Current Rules state:

"Boat markings: lettering and numbers on boats are required. Letters and numbers must be placed on the bow of the boat in block style and of a contrasting color. Minimum sizes--16 inches high, 12 inches wide, 3 inches in thickness."

This rule statement needs to either be enforced, or edited, or deleted.

2. Control of surfboats near or at the Finish of the race Current Rules state:

Finish - At the completion of the third lap, the surfboat must pass the last buoy, after which time any member of the crew may complete the lap. One member of the crew must leave the surfboat and run up the beach, and pass through the funnel finish in an upright position."

ISSUES:

No mention is made of control of the surfboat.

In every other surf racing craft discipline, control of the craft and contact are an implicit part of safely and correctly finishing / completing the course.

In the surfboat, both members of the crew can flip the surfboat, abandon ship and let the Surfboat "ghost ride" into the shore break. Safety and control of the craft must be part of the discipline.

The Surfboat Race is historically derived from the old US Lifesaving Service and should mirror their rescue efforts to remain upright, and in control, and safely bring their Surfboat to the Shoreline.

A statement should be added to the Finish rules such as:

One Member of the crew must remain in contact with the Surfboat and attempt to maintain control of the Surfboat until after his/her teammate has passed through the funnel and across the Finish line."

The following was discussed at the Public Education Committee meeting on April 12, 2007:

- 1. CSLSA Display Booth Mike Bartlett from Huntington City currently has the display booth. Mike will evaluate condition of booth and send to manufacturer for repairs if necessary. Committee discussed the creation of a web based "tracking and reservation" page being added to the CSLSA web site. Goal is to create a simple tracking & reservation page that can be accessed and updated by individual chapters. Booth will be stored by the last chapter using he booth until another chapter needs it. Chapters have responsibility of reporting any damages or repairs needed, and noting on the web page that booth has been transferred to another chapter. Transfer of booth between chapters will be arranged by individual chapters involved. Bill Humphreys will work with Bob Moore, Web Committee Chair, to determine feasibility of creation of web based reservation/tracking program.
- 2. Over 6,000 "Be Safe, Be Seen" posters and over 7,000 Junior Lifeguard artwork book covers were distributed. Chapters not receiving posters or book covers can contact Bill Humphreys to make arrangements to pick up materials. Unused materials will be brought to the Spring 2008 meeting for distribution for next year. Thanks again to Steve Reuter and Mike Silvestri for their work on these respective projects.
- 3. Melissa Murphy from HB City presented an offer to sell rights to CSLSA for "biomedical" posters (Jellyfish and Stingray) for \$1,000 each, for use in lifeguard headquarters first aid rooms. Committee recommended that Melissa produce posters on her own, retaining rights and attempt to sell for \$30 or \$40 each directly to agencies. Agency representatives felt confident that most would be willing to pay directly for such a poster, thus preserving CSLSA funds while allowing Melissa's artwork to reach the targeted groups and retain a profit.
- 4. Rob Williams from Newport has met with USLA and NOAA/Sea Grant representatives on joint public education program, initially focusing on rip currents. NOAA is producing posters, banners, and other material which will become available in fall of 2007. Rob will update committee in fall of 2007 regarding project. Some materials are currently available for download at http://ripcurrents.noaa.gov/ or http://usla.org/teachereducation/.
- 5. Public Education Inventory and Needs Matrix Committee discussed the progress on the development of an inventory and needs assessment matrix which will be used to: 1) provide chapters with a comprehensive list of materials available and how to obtain them; 2) serve as a record of projects completed by the committee; and 3) serve as a planning tool to identify areas for potential projects (e.g. create public safety

materials reaching specific groups that may have been overlooked). Bill Humphreys will work with Bob Moore, Web Committee Chair, to determine feasibility of adding this matrix to the CSLSA web site so all chapters will have direct access to materials and contact information for obtaining them. Some materials currently are available for download at http://usla.org/teachereducation/ or http://www.usla.org/ripcurrents/signsbrochures.asp

- 6. Steve Reuter from Huntington Beach showed a DVD regarding a "Robotronics" proposal for a pubic education radio controlled "mascot" that can be used at large public education programs. Committee liked the concept but felt cost was too high (\$10,000) to recommend requesting allocation of CSLSA funding. Suggestion was to look into potential grant funding sources or a specific fund raising event if project is to be considered, in order for project to be funded outside of CSLSA line item budget.
- 7. Committee discussed proposal from LA Riptides Lacrosse team for potential partnership, group discounts to lacrosse games, etc. Committee did not see major benefit to CSLSA in regards to reaching a targeted audience with beach/ocean safety information considering time commitments, etc. Suggestion was made to encourage LA Riptides to take out a paid advertisement in CSLSA magazine offering discount coupons to lifeguards. Bill Humphreys will follow up with LA Riptides to convey the committee recommendations.

Alex K. Peabody Alternate Executive Delegate Lifeguard Titles – Ad Hoc Committee Minutes - Spring 2007 April 13, 2007

An ad hoc committee was formed to discuss the possibility of creating consistent job titles between CSLSA lifeguard agencies. The purpose of the project is to help advance the professionalism of lifesaving in an effort to better serve the public. Consistency in job titles will help improve effective working relationships between departments and various agencies in emergency situations - reducing possible confusion over command roles due to discrepancies between job titles. It is recognized that the Incident Command structure used by public safety helps to alleviate this problem. However, confusion over roles/titles often still exists.

The committee was chaired by Scott Davey, Section Chief for LA County lifeguards and Bill Humphreys, Marine Safety Chief for San Clemente lifeguards. The committee members included all present at the CSLSA Board of Director's meeting on April 13, 2007.

- I. Discussion included:
 - A. Potential difficulties in creating uniform job titles. These include:
 - Difficulty in reaching consensus between agencies.
 - ii. Potential conflicts with union or association members.
 - iii. Differences in agency size and job functions.
 - iv. Differences in structural basis of agencies. For example, some agencies are based on a law enforcement structure (e.g. use terms such as Sergeant which come from law enforcement); some agencies are based on fire structures (e.g. "Battalion Chief"); while many agencies have evolved from a strictly lifeguard structure (e.g. "Marine Safety Officer").
 - v. Difficulty in implementing recommended changes especially with larger departments who have a set job title structure in place.
 - B. It was recognized that uniform, consistent job titles between agencies is a worthwhile goal. However, the committee recognized that changing job titles may need to be a long-term goal due to difficulties described above. Examples were given from fire departments who have overcome these difficulties, establishing consistent job titles that work for large or small departments across the Country. For example, job titles are consistent with a 5,000 person department such as New York City, as well as small departments in the mid-west. Therefore, the committee determined that although difficult, the challenge is not insurmountable.

- C. Suggestions on how to approach this task included:
 - i. Categorization of agencies based on size or current structure. For example, agencies of a certain size or number of personnel could be Category A, smaller sized agencies Category B, and very small agencies Category C, etc. Job titles would be consistent between agencies within various categories. Another option would be to categorize agencies based on either Fire or Police structures based on their current structure. For example, State Lifeguards may stay with a Police structure for titles since their full time lifeguards are POST certified Peace Officers, while other departments may fall more readily under a fire structure especially departments which are already divisions within a fire departments.
 - ii. A decision was made to begin the process by working to reach consensus between agencies for comparable positions - utilizing current job titles. Initially, the process will focus on full time lifeguard positions. For example, the senior administrator or managers of various lifeguard divisions (Chief, Deputy Chief, etc.) would fall under a certain category such as Level 1. This person, regardless of title, is the person in charge of creation of policy and procedures, etc. Level 2 would be the next person, again regardless of title, who may be responsible for assistance with creation of policy or writing procedures, and may be in charge of all personnel matters, etc. Once this consensus is reached, agencies would push for acceptance of comparable job titles as equivalent positions. seeking agreement by their respective City, County, or State governing body, including their respective Personnel or Human Resource departments. It was recognized that reaching full consensus for such a large body of agencies (entire CSLSA) would be problematic. Therefore, the committee opted to work on building consensus between local agencies within certain counties. Once that goal is reached, consensus between counties will be addressed and later expanded to the entire state. For the purposes of this project, initial counties and their representatives will be:
 - (1) LA County Scott Davey SDavey@lacofd.org
 - (2) San Diego County Katherine Jackson KJackson@Sandiego.gov
 - (3) Orange County Bill Humphreys Hunphreys B@San-Clemente.org

Project coordinators for each county will work to create a draft matrix over the next few months showing equivalent job titles by level for their respective county. This will be presented to the Board of Directors at the Fall 2007 CSLSA meeting.

4th Executive Delegate Report on Legislation and Statistics

Statistics! Everyone's favorite I know, but in these days and times in which we may be faced with providing critical, defensible data (quickly) in answer to budgetary, salary, and legal issues, we must look at our own statistical gathering methodology and process for aquatic safety statistics and ensure we are doing it right.

As often as the United States Lifesaving Association is cited for its national statistical data base for aquatic safety statistics, in order for that data base to be a reliable data source, it is critical that all contributing agencies develop a more uniformed and standardized process for their statistics gathering and reporting. For that reason we have asked all agencies attending this Spring meeting to bring their statistics forms so that we may look at how our own agencies and department's gather their statistics. This afternoon we will be conducting a special committee meeting on this subject and ask that all agencies have a representative attend with their statistics forms at the ready. Carl Drake and Rick Gould are planning to be in attendance.

Legislatively, this has been a fairly active legislative season. As always, if you are aware of any proposed, or introduced legislation that may affect California lifeguards, please contact me and give me a heads up and I can begin following the bill. At this point here are the primary active legislative bills that I am following:

- Legislative Bills:
 - AB 124 Meal Breaks (Price) has been amended by the bills author and specifies that this legislation would only affect pool lifeguards and stage assistants:
 - 226.8. (a) Notwithstanding any other provision of law, <u>pool</u> lifeguards and stage assistants employed by the state or any political subdivision thereof, including any city, county, or special district, may not be required by their employer to work during any meal or rest period provided for in Section 512 required for non-exempt employees by Section 512 or by an order of the Industrial Welfare Commission.
 - AB 1458 Vessel Operator Certificates and Funding (Villines)
 has been amended, but continues to remain problematic for
 California State Parks and the funding the department receives to
 support is vessel recreation facilities and operations throughout
 the state park system. The appeal for most public safety agencies

that deal with vessel operations on reservoirs and along the coast is that the bill would require a vessel operator certification for vessel operators.

AB 1355 County Sheriff Duties and Authority (Houston) would give the sheriff of each county, "the sole and exclusive authority to provide security and safety for the coastlines, harbors, and inland waterways, if any, as specified, except in counties that, prior to July 1, 2008, have vested the duties associated with the security and safety of the county's coastlines, harbors, and inland waterways to a law enforcement or public safety entity other than the sheriff."

Under current law, the "sheriff of each county is required to give all possible aid and assistance to vessels stranded on its coast, and to the persons on board."

The proposed legislation seems intent on extending the authority of the county sheriff as identified in the following from the bill:

It is the intent of the Legislature that the sheriff of each county in this state, as the chief law enforcement officer of the county, **shall have the sole and exclusive authority** for the security and safety of the county's coastlines, harbors, and inland waterways.

The legislation may be problematic for some agencies in that is does not cite nor recognize the authority extended to the some agencies in situations where there may be concurrent jurisdiction.

As I have said before, the summer of 2006 was a summer to remember! Warm water, regular southern hemisphere swells, and one of the busiest Julys on record. We look forward to the summer of 2007 and I wish all of you the best this coming summer and keeping the waters of California safe.
