#### **During the Training Officers Committee we discussed the following subjects:**

- 1. San Diego, Orange County and Los Angeles should consider more cross training both in physical trainings and in round table information discussions.
- 2. It was suggested that by-annual trainings be held toggling between San Diego, Orange County and Los Angeles in order to give all agencies in the CSLSA an opportunity to participate in multi-agency drills and discussions.
- 3. Names, e-mails and phone #'s were gathered for participation in future trainings.
- 4. Attendance to the pre-set future Orange County trainings of a navigation dive, PWC training, and rescue boat training were encouraged.
- 5. Nick Lerma from San Diego City Lifeguards discussed their agencies involvement in Evolution Productions "Ocean Force" regarding the production of a safety video that was made pertaining to "Water Observation", "Components of a Rescue" and "Code X". The USLA has this training video in production for mass distribution and will hopefully be available by the training academies of 2009.
- 6. Nick Lerma also informed the committee that he is currently in the production stage of a instructional video addressing safe beach vehicle operations.
- 7. Scott Diederich with the City of Laguna Beach Lifeguards stated that he would be willing to teach both ICS 200 & 300 for lifeguard agencies if there was a need.

### PRESIDENT'S REPORT TO THE BOARD OF DIRECTORS October 16, 2008

Welcome to La Jolla and thank you very much to Mike Silvestri for his hard work in organizing this meeting and getting us the great deals on lodging that he has. Yet another summer has come and gone, and although I don't think it was quite as record breaking as the summer of 2007, the summer of 2008 was a good one for most of us in the CSLSA.

The City of Huntington Beach had another year of *Ocean Force* filmed on their shores that I hope proves to be as good as last year. They also negotiated a deal with Toyota to outfit them with a brand new fleet of vehicles. The State Parks Lifeguards managed to avoid the drastic budget cuts proposed by the governor and were able to adequately staff their beaches. Their proposal to fund their operation through a ten dollar fee for each registered vehicle in California in return for free day use at State Parks, called the *State Park Access Pass* was supported by the CSLSA, but unfortunately did not make it out of the legislature into the budget in this era of no new taxes. Los Angeles County became the first *green* government lifeguard service when they entered into a deal with the Ford Motor Company to supply them with a fleet of Ford Eclipse hybrid vehicles. So we are moving forward in many ways.

For the first time in several years we were able to hold the Junior Lifeguard and Lifeguard Regionals on back-to-back days at the same venue. Thanks to Seal Beach and Joe Bailey and his staff, particularly Lori Walton, Mike Westmoreland, and Chris Pierce for all of their hard work in making this possible. The good news is that we are going back to Seal Beach next year. It was a great venue and we had one of the best turnouts for the Lifeguard Regionals in recent years. I would be remiss if I didn't thank Reenie Boyer, Junior Guard Chair, for her efforts on behalf of the JG's. Charlotte Graham, your Vice President, not only worked the JG day, but was also there for the Lifequard competition and was in charge of registration, not an easy task. The competition would not have been possible without the yeoman efforts of Competition Chair Jay Butki, who not only built and maintained the competition courses, but was also instrumental in their installation, and he even found time to compete in a couple of the races. Other members of your Executive Board that helped officiate the event were Mike Beuerlein, Bob Moore, and Bill Richardson. I helped by being the announcer and typing up the results. Other volunteers that helped out were Gordon Gray, Mike Silvestri, Donna Richardson, Robert Torres, Eric Ching and Morgan McGowan. I cannot stress enough what a labor-intensive effort running a successful regional competition is, and we welcome all the help we can get. Please think about stepping up to help next year.

LACOLA and the County of Los Angeles Fire Department Lifeguard Division hosted the 2008 USLA Nationals at the Manhattan Beach Pier. Once again major kudos are due to Charlotte Graham and Jay Butki as event organizers. Comments I heard included "best ever" and "great venue." All and all, I think it was one of the best Nationals I have attended. We actually had three days in a row of morning to night sunshine, enough surf to make things interesting, and a good turnout in spite of the challenging economic conditions and the high cost of travel. As is the case with most of our events, none of this would have come to fruition without the efforts of Scott Hubbell and his company that provide a majority of the sponsorship for not only our events, but our membership kits as well. Thanks again Scott.

I'm not sure how he finds the time, or the time off, but in addition to the already mentioned events, Jay Butki organized, coached and managed teams that competed in the "Waterman Challenge at Waikiki Beach" where the California team placed first, and the "Sanyo Bussan Challenge" where the US team finished third, our first podium finish in an international competition in quite some time! Way to go Jay. Jay was also the manager, coach, and organizer of the California team that competed against the Victorians in the Wieland Shield, contested in Hermosa and Torrance Beach in early August.

The 2009 USLA Nationals are looking like they will be in Fort Lauderdale and LACOLA is exploring the possibility of hosting again in 2010.

Our next USLA National Meeting is next month in Cocoa Beach, Florida and if there is anything you want us to take back there, now is the time to let us know. Next spring we are hosting the national meeting at Asilomar Conference Center in Monterey. Alex Peabody has been working on this meeting for the better part of the last year, and it should be a good one. If you ever wanted to see what goes on at a national meeting this would be a good opportunity. The dates of the Asilomar meeting are April 23 – 25, 2009.

There are a couple of issues that we need to address at this meeting that may be somewhat controversial. They include the Job Titles Committee and the USOC / USLA affiliation. It is my hope that we can all hear all sides of the issues and arrive at a position on these issues that is acceptable to all concerned and that is in the best interests of the CSLSA, the USLA and all of our members. Here's to a productive and harmonious meeting.

The organization's status and tax identification number was passed along to the United States Lifesaving Association during reorganization. The California Surf Lifesaving Association has applied for a new non-profit under Section 501(c)(3).

There are a few issues that the Executive Board has reviewed and discussed at length since the last Board of Directors meeting. Some of the issues are on the agenda under old business. We need to clarify and keep personalities out of the mix. Often times things are not what they appear. Since its inception in 1964 a vision was incorporated in the State of California as the National Surf Lifesaving Association. Thanks to many contentious meetings and hard work, different agencies came together to try to enhance the profession and educate the public on the hazards of the ocean. Their wisdom to include the local lakes at that time only seemed logical. I am the last active Executive Board member who cast a vote to change the name and focus of our organization in Santa Cruz in 1979. It took years, but the decision was to broaden our goal to include both open water and the rest of the country. This was the impetus for passing our 501(c)(3) to the newly formed United States Lifesaving Association. Our region became the Western United States Lifesaving Association for a few years and then we changed our name to the California Surf Lifesaving Association in hopes of giving us an identity for fund raising. It has been a rough road, but I believe a noble one. The purpose and function of this organization was revisited at length in re-writing our Bylaws both on the National and Regional level. This has taken years and we continue to strive to spread the word of public safety in an open water environment and raise the standards in lifesaving. So in our discussions at this meeting, please understand that we have been through many things over this amazing journey. Things are always up for discussion. Sometimes issues do not go your way and sometimes they do. Just remember, at the end of the day we must put our differences aside and move forward for the greater good. If not, the visionaries in the 1960's would never have started what we believe to be a representation of a common goal of saving lives through the profession and education. Also remember that change is long and hard, i.e. re-acquiring our 501(c)(3). So if you are disappointed, don't give up. Keep volunteering and continue to try and make this organization the best it can be.

I continue to give advice when asked and volunteer advice when not asked. I hope I have continued to be worthy of this and the national organization. I have been a member since 1967 and attending meetings since 1974. This past National Spring meeting in Hawaii was the first National meeting I have missed in 34 years. I have seen many things over the years and still optimistic as to our future.

On a personal note, I am much appreciative of all of the support my wife and I have received over the past few months. It has been a difficult time for our family, but we are on the mend and looking forward to a positive future. I have dedicated my life to lifesaving in many forms, but I had a reminder this year, family comes first!

Thanks to the California State Lifeguard Association for hosting our meeting this Fall. I look forward to good fellowship and positive results at this meeting.

#### Fall 2008 USLA National Board of Directors Competition Committee Meeting

Should the Region and the USLA make the 20% adjustment to the Board of Directors to meet the US Olympic Committee's standards to become the US National Governing Body for Lifesaving? As the CSLSA Competition Chair, I strongly believe we need to pursue the proposal and urge a yes vote by the CSLSA board.

I undertook the task of rewriting our USLA rules in 2006 solely so we could present them to the USOC for consideration to be accepted as the NGB for Lifesaving in the USA. This would finally put the USLA equally on par with every other national team we compete against internationally. Current USLA membership is some 4,000 Lifeguards and 8,500 Junior Lifeguards, so roughly 12% of our Lifequard membership competes at the USLA National Lifequard Championships annually, and I'm not sure what the percentage is for Junior Lifeguards, but on a Regional level I would imagine the percentages are even higher. I see it as a positive step to allow the member athletes both a voice, and the chance to participate is a big step towards improvement of our JG and Lifeguard competitions and I'm sure that every Lifeguard competitor is equally devoted to the primary mission of the USLA. The USOC NGB idea is not to transform the USLA, or for that matter to change it in a hugely significant way, but rather to help strengthen the athletic aspect of lifesaving and to help it stand on its own two feet. By doing so, we may well be able to increase the financial and other support of lifesaving sport, while freeing up USLA general fund monies currently spent on lifesaving sport for other purposes. The association with the USOC is a huge boost to our organizations stature, and having the Olympic rings on our web site sure would be very significant and would assist in defining and lifting our Association's marketing stature. The USLA is the only national Lifesaving Association not already recognized as the National Governing Body (NGB) with their national sport and Olympic committees, the International Life Saving Federation does the same with the International Olympic Committee and has athletic representation on it's board. Lifesaving is now on par with Baseball and Softball in the IOC recognized sports. The World Games for IOC-recognized sports will be contested next year in Taiwan.

Lifesaving is on the short list of possible demonstration sports for the 2012 games in London, just as it was in 1956 in Melbourne when Bob Burnside created the NSLSA in order to represent the US, and 2001 Goodwill Games. The whole goal of the sport side of lifesaving is to increase the fitness and improve the rescue skills of the Lifeguards and Junior Lifeguards that we represent, and a USOC affiliation represents a giant stride towards that aim. The promotional and marketing impact of a nationally recognized and ranked USLA lifesaving team should not be over looked, as it has not been overlooked in our peer nations who use competition to raise both the stature of lifesaving, assist in public education and increase their fund raising and marketing opportunities. This had been ongoing in Australia and New Zealand for decades and we all have witnessed their successes in promotion and marketing. Japan, South Africa, Great Britain and Canada have already surpassed us, both in marketing, fund raising and public education.

If you believe in the concept of USLA, you believe in the concept that all we do is important. If we can find a way to better support an element of our services, whatever it may be, we strengthen the entire organization....nowhere has it been suggested to detour from the primary goal of the USLA. As CSLSA Competition Chair, I am firmly in support of the USOC NGB proposal and consider it long overdue.

#### 20th Wieland Shield -Aug 1, 2 Hermosa Beach & Torrance Beach

The 20<sup>th</sup> Wieland Shield tour began at the San Clemente Ocean Festival and dinner at Mitch Kahn's house overlooking Cotton's point, followed by a pounding on Bruticus Maximus at the Surf House and tours of the USOC facilities at Chula Vista, then continuing with a surf session, a TJ tour hosted by IB's Rich Hidalgo, a Laguna adventure with Lt. Scott Diederich, a 2 day jaunt circling Catalina Island on board Baywatch with Captain Rob Pelkey, a full day of racing at Seal Beach Regionals, and then the main event.

The 20<sup>th</sup> Shield was marked by one significant injury: During warm ups for the surf race, Australia's top swimmer threw an accidental elbow while bodysurfing and partially ruptured the eardrum of their top ironwoman. As only the top woman scores in each of the women's events, that hurt the depth of our California side against the tourists. Along with Victoria's Board & Ski dominance, the combination proved to be our undoing.

Despite winning the Surf Rescue Relay and the Women's Taplin under the lights at the International Surf festival and coming out on top on Day 2, California lost to Victoria and the Shield heads back Down Under until we return to reclaim her in January 2010.

SUBJECT: Special Awards & Presentations Committee Report

The following submissions were taken to the USLA meeting in Kauai this past May, were discussed and approved for national awards. The presentations have been prepared and are available for presentation at this meeting.

Invitations were sent to all recipients. If they are unable to attend, their awards will be given to the Chapters who submitted them to make arrangements for presentation at a later date.

#### <u>Submission by Jim Turner – Newport Beach</u>

Proposed Recipients: Summer Watson and Amy Dochiro

Both are non-lifeguard surfing instructors in Newport Beach with no formal lifeguard training.

On Wednesday, March 12, 2008, at approximately 11:15 AM, a 9 year-old male and 10 year-old female (brother and sister) from San Bernardino were caught in a rip next to the 28<sup>th</sup> Street jetty. Both had been pulled into deeper water and were unable to stay afloat and were screaming for help.

Watson and Dochiro were teaching a surfing class to the left of the jetty when the victims drifted through the surf lesson area and then into the rip current. The instructors saw that the pair was in trouble. Watson responded followed shortly thereafter by Dochiro.

Upon Watson's arrival the children grabbed onto and clung to Watson forcing her under water. When Dochiro arrived and took control of one of the victims. Both girls attempted to utilize the victim's small bodyboard, which was washed away by the surf.

The instructors continually had to pull the victims to the surface, causing them to submerge. Just when the girls were attempting to get a surfer some distance away to help them, Newport Beach Lifeguards arrived on scene and completed the rescue.

Lifeguards Moore and Leeper credited Watson and Dochiro with risking their lives to save the two siblings.

#### <u>Submission by Eric Abma – California State Lifeguards</u>

Proposed recipient: Moses Cuprill, Michael Barrett and Raymond Johnson

All three are non-lifeguards with no formal lifeguard training.

On Sunday, March 9, 2008, Cynthia Schmidt was swept into the ocean while attempting to help her young nephew out of the shore break. Schmidt was fully clothed and was quickly overcome by the powerful surf and currents.

Johnson observed Schmidt floating face down in the water and responded to assist her. At the time the water temp was 53° with a pounding 4-6 foot shore break. Johnson responded without benefit of a wetsuit or any rescue gear.

Both Cuprill and Barrett responded to assist Johnson who was struggling to maintain the unconscious Schmidt on the surface while trying to return her to the beach.

As Lifeguard Sturm was arriving on scene he observed the three surfers making a "heroic" effort at controlling the victim and soon returned her to shore.

Sturm commenced CPR until relieved by Paramedics. Schmidt was transported to the hospital where she fully recovered.

I have received only one submission for an Award of Merit, from Oceano Dunes SVRA. We will discuss and act on this submission at this meeting.

Finally, the Committee has remained well under budget for 2008 and will ask that the appropriation for 2009 be reduced, to \$400, which should cover all of our expenses for 2009 even with some projected increase in activity for other presentations outside of Heroic Acts.

#### Lifeguard Job Titles Ad Hoc Committee Report - October 2008 October 16, 2008

**Background -** In spring 2007, an ad hoc committee was formed to discuss the alignment of job titles and to make recommendations to assist in standardizing job titles. This project is one of many pieces of a larger goal of enhancing and promoting the profession of lifesaving.

Although an ultimate goal for this project would be to help standardize job titles in our region, a first step was developed to create a CSLSA "Job Title Equivalency Matrix". The matrix identifies current titles and structures utilized by various agencies. This matrix will be used to help develop models for job titles that are consistent with other similarly structured lifesaving agencies.

**Project Status** – The Committee has continued working towards identifying existing job titles and structures within lifeguard agencies. The project has been broken into three work groups based on county: Los Angeles, Orange, and San Diego. Following is a breakdown of progress by each county.

Los Angeles County: Work on this project was coordinated by Scott Davey from LA County Fire. LA County's matrix has been finalized and is included in this report as Attachment #1.

**Orange County:** Work on this project was coordinated by the Orange County Lifeguard Chiefs Association (OCLCA). The OCLCA finalized and approved an initial matrix on March 13, 2008. This matrix was presented to the CSLSA on April 10, 2008. However, some members believed the matrix could be detrimental to their agency or may step into "meet and confer" issues. Therefore, the OCLCA re-reviewed their matrix on October 2, 2008 and voted to approve the following changes in order to address these concerns. The revised matrix is included in this report at Attachment #2. Significant changes from the original matrix include:

 In order to clarify that the matrix is solely intended as a structural analysis of current lifeguard job titles and structures in place; and to specifically address concerns that the matrix may be used for compensation purposes or other "meet and confer" issues, the following notation has been added to the matrix:

"This document is a structural representation only. This does not constitute a job classification review for compensation purposes. Job classifications, duties, and responsibilities may and will vary from agency to agency."

(Note: This comment has been added to San Diego's matrix as well.)

 Similarly, to emphasize that this document is not a job or classification analysis, descriptions of structural levels have been removed (now listed by level only). This was designed to specifically address the concern that multiple page job descriptions had been reduced to one sentence job descriptions.

- The OCLCA reiterated that this is a "living" document, subject to change or modification as necessary. The goal is simply to identify existing titles and structures as a first step toward a long term goal of working toward creating unified job titles.
- Numbers designating employees in each position have been added. It should be
  noted that the California State Lifeguards actually operate in two distinct sections in
  Orange County, each as an independent sector: North and South. Therefore, two
  people are identified at level one. The OCLCA will amend their bylaws in the future to
  recognize the North and South sectors within OC as distinct entities (similar to San
  Diego's matrix as shown on Attachment #3).

**San Diego County:** Work on this project was coordinated by Rich Hidalgo from Imperial Beach. SD County's matrix has been finalized and is included in this report as Attachment #3.

**Conclusion -** In addition to serving as a general update, the purpose of this report is to:

- Recommend that the CSLSA Board of Directors accept the three attached matrices as tools to: 1) identify current job titles and structures in place; and, 2) to help develop models for job titles that are consistent with other similarly structured lifesaving agencies.
- Request representation in today's committee meeting from counties not currently addressed in order to create matrices for those counties.
- Request assistance in committee to begin work to develop recommended models for job titles/structures for lifeguard agencies with the CSLSA. The committee recognizes that one model will not fit all agencies. Therefore, two or three models will be developed with an ultimate goal of having these models endorsed and encouraged by the CSLSA.

#### 4<sup>th</sup> Executive Delegate's Report on Legislation and Statistics

#### Legislation:

The fall is the wrap-up for the Legislative season. Bills that were introduced at the first of the year, progress and mutate as they travel through committees of both the Assembly and the Senate before being reviewed by the Governor to either be vetoed, or signed into law.

In the case of the three Assembly Bills I identified at our Spring 2008 meeting as having potential impact for aquatic safety, or to our membership, only one--AB 2917 (Torrico) EMT registry--has survived as originally intended in the political arena.

- SUMMARY of AB 2917: This bill requires the Emergency Medical Services Authority (EMSA) to establish and maintain a statewide registry of the status of emergency medical technician (EMT) licenses and certificates, to be used by certifying entities, as defined. Requires EMSA to develop standards, guidelines, and regulations for certification of specified EMTs. Establishes guidelines for EMT certification and discipline, and for investigation of any conduct which threatens public health and safety, as defined.
- Assembly Bill 2110 (Duvall), which would have required the operator of a vessel
  in California to complete an on-line vessel operation training course and obtain a
  vessel operator card from the Department of Boating and Waterways, died in
  committee.
- Assembly Bill 2426 (Cook), was originally introduced as an amendment to Section 25620 of the Business and Professions Code and would have given the Department of Parks and Recreation the authority to issue a closure order for the possession of alcohol in a state park unit. Violations of this order would have been an infraction.

After an initially supportive start, this bill experienced some push-back and a significant amendment in committee that deleted the section on California State Parks and changed into a bill that would permit a person that operates an out-of-state winery and produces a limited amount of distilled spirits in another state to hold an interest in no more than 12 brewpub-restaurant licenses, provided specified conditions are met. Basically having nothing to do with the original purpose of the bill other than amending the Business and Professions Code. AB 2426 was signed by the Governor on September 27, 2008

As we look to the 2009 Legislative season, please be sure to send me an email if you are aware of any developing legislation that may affect California lifeguards.

#### Statistics:

As we near the close of this calendar year, the time to add up your aquatic safety statistics and report in to the USLA data base draws near. Hopefully our member agencies and departments are using a computer based statistics system that increases the accuracy and efficacy of data collection. This past spring we provided our membership with a Daily Lifeguard Patrol Log and an Annual Lifeguard Statistics forms to assist them in collecting their statistics. The idea was to provide agencies with a tool to better collect their statistics in a more standardized, usable format that can be used to report critical data to both their management and to the USLA data base.

In committee I would be interested in hearing from those agencies who utilized these forms and hear feedback on how they worked for you.

#### Spring 2009 USLA Board of Directors Meeting and Conference:

The Spring 2009 conference for the United States Lifesaving Association will be held at the Asilomar Conference Center in Pacific Grove, California on April 23-25, 2009.

#### **General Information**

Since our spring meeting 2008, due to the summer season, no trainings have been reported. The Golden Guardian 2008 full scale exercise scenario focuses on a simulated, catastrophic 7.8 magnitude earthquake along the southern portion of the San Andreas Fault.

#### **West Coast Regional Lifeguard Championships**

- Friday & Saturday July 24, 25, 2009 Seal Beach Pier
- July 2010-tentative offers to host Junior Lifeguard Regionals and Lifeguard Regionals came from Santa Cruz City, no other chapters have stepped forward at this point in time.
- Discussion and review the 2009 CSLSA Regional Lifeguard Championships
- Improve the time line for the event by increasing pre-registration and USLA membership prior to arrival at the competition venue.
- Add a volunteer official component to each Team entering in to the CSLSA Regionals; for example: 15 Chapter Team members=1 volunteer, 30=2, etc. These volunteers would be used to assist the Corps of Officials in running of the event for both Junior Lifeguard and the West Coast CSLSA Regional Lifeguard Championships.
- Improve the finishing chute and placings results for the 2k Beach Run by creating a funnel finish separated by Open 7 Masters age groups. (Gender not necessary as usually fairly obvious) this will vastly improve our efficiency in keeping the Regionals running on time.
- Add a 4 person Women's Taplin relay, and 3 person Open Men's & Open Women's Board Relay to the Regionals event list.
- Discuss a proposal for the Spring CSLSA meeting to raise Regional entry fees for the 2009 Regionals. Entry fees have remained at \$10.00 for almost 2 decades. Competition income for 2008 was just over \$2000, by raising fees to a very fair \$20.00 we could double the income, and add a \$5.00 fee for a total of \$25 for those who wait and enter as late entries on the day of the event.
- Endeavor to start the first race the 2K beach run on time at 08:00 AM and not wait for late entries.

#### **USLA National Lifeguard Championships**

- August 6,7, 8, 2009 Fort Lauderdale??
- August 2010- Huntington State Beach and LA County interested in hosting the next west coast Nationals
- Raise the fee for Junior Lifeguard Competitors to a maximum of \$20 from the current \$10, as \$10 doesn't cover the current lunch and T shirt requirement.
- Propose that the National Competition Committee look into the possibility of making the current \$7000 USLA National Lifeguard Championship "Licensing" fee in the Nationals Contract a discussion/ negotiation item to remove from the contract as it is a huge stumbling block in getting Chapters interested in hosting the Nationals. Require the USLA to better support and enable the organization and running of their National Championships rather than thrusting all of the burden and all the financial costs onto a local hosting chapter
- Continue the pattern used this year and contest all preliminary heats of Surf Boat and Beach Flags on the Thursday preliminary day, with the exception of the Open Men's and Open Women's Surf Boat and Beach Flags Final races to be contested on Friday.

**New Business:** 

#### **US Olympic Committee National Governing Body Proposal**

 The Competition Committee supports the NGB USOC membership proposal in concept and believes there are many positives to the proposal, especially for Lifeguard and Junior Lifeguard Competition, but has concerns about the implementation options as presented and believes more research is required. Further research is also necessary on the potential pitfalls or negatives, and increased administrative costs to this organization of becoming a NGB member of the USOC.

- regarding the election of athlete representatives and the 20% rule, it was pointed out that both Greg Boyer (husband of Newport Beach's Reenie Boyer) and Ryan Bailey (brother of Seal Beach's Joe Bailey) have served on US Water Polo has a 10 member National Board with 2 Athlete members (1 male, 1 female) elected from the US National Teams annually.
- Propose that the CSLSA Executive Board support the concept but refer the proposal to the Competition Committee for further research and review at the USLA Board of Director's meeting in Cocoa Beach.

#### West Coast Women's Lifeguard Tournament

 LA County is working on a first time Female Lifesaving Competition modeled on the successful east coast tournament and hope this can become an annual event. This event would be held in mid-July prior to the Regionals.

✓ Marie Fukutomi a 16 year-old Jr. Lifeguard Instructor Aide was submitted for her outstanding calm and "professionalism" during the rescue and treatment of a multiple-victim motorcycle accident on Highway 101 near Emma Woods State Beach.

The Committee concurred with approval of a *HEROIC ACT AWARD* for her and to submit the application to the USLA Committee for approval at the national level. Marie's position requires her to receive minimum lifeguard and medical aid training to work in this youth development program.

In committee yesterday, the following was discussed:

- I. Job title matrices have been created by San Diego, Orange, and Los Angeles Counties, reflecting job structures currently in place. Committee noted that there were two errors in San Diego's matrix which will be corrected (matrix should only include full time positions; and, Ca. State lifeguards need consistency between sectors). It was recommended that the CSLSA Board of Directors accept the three matrices as tools to: 1) identify current job titles and structures in place; and, 2) to help develop models for job titles that are consistent with other similarly structured lifesaving agencies.
- II. Committee requested that agencies in counties outside the three above create similar matrices. Those counties include: Ventura, Santa Barbara, and San Louis Obispo.
- III. Committee reiterated that this is a "living" document, subject to change or modification as necessary. The goal is simply to identify existing titles and structures as a first step toward a long term goal of working toward creating unified job titles.
- IV. Committee discussed the "next step" toward job title standardization. It was recognized that this will need to be an individual effort from each agency, subject to their internal constraints. Therefore, the committee will focus on developing "recommended" job structures which can be used as a target goal.
- V. The committee recognized that one recommended structure will not fit all agencies. Therefore, two or three models are being considered. Drafts of these models will be presented in the Spring:
  - A. Fire model for agencies under fire departments.
  - B. Police model for agencies aligned with Peace Officer status (mainly Ca. State).
  - C. Generic lifeguard or military model for independent agencies.
- VI. Suggestions for including overlays to the models were presented. These included: 1) management, supervision, and line level designations; and, 2) ICS training requirements for each level of the model(s). Committee will develop models with and without these overlays for consideration.

# CSLSA Board of Director's Meeting - 10/16/08 Membership Committee Report

**Attendees:** Patty Mackle, Mark Allen, Jon Menzies, Rob Gibson, Ryan Gates, Jeff Hatfield, Ned Hearn, Amanda Calhoun, Tom Atkins, Robert Moore, Richard Godino, Gordon Gray Charlotte Graham - Chair

- The committee chair discussed the revised application forms for 2009-10, which will be posted on the CSLSA website, and which should be used to aid in the proper collection of data.
- The committee discussed the fee increase of the current year and all in attendance agreed that the higher cost had little to no effect on their successful membership drives.
- The committee chair related the many problems that the region and the National body have had with the new membership database program provided by Interfuse of Australia. Due to ongoing glitches the entry of member info into the national database has been severely delayed, but improvements have been made over the past few months, and chapters reps can let their members know that they will get their kits soon.
- The committee discussed potential kit items for the 2009-2010
   Membership year. The chair related our need to be fiscally responsible
   and to gain as much from our sponsor as we can prior to augmenting
   kits with allocated money from the CSLSA treasury. The chair also
   reminded everyone in attendance to bring any potential sponsorship
   interest to her attention in hopes of expanding the value of Association
   membership.
- The committee indicated that one or more of the following items were desired for the 2009 kits (in order of preference): Sports Bag, long-sleeve shirt (white), short-sleeve shirt (not in white), sunscreen, and sport (water) bottle. Towels are always brought up, but due to the very high cost, they are not really feasible unless there is significant sponsorship.

The chair will relay the committee's kit requests to our Sponsorship Liaison. The committee also voted to get CSLSA stickers again, and the chair plans to order at least 2 years worth to augment whatever we receive from sponsors.

- The Membership Committee Chair attended the Ways and Means meeting and respectfully requested a budget allocation increase for 2009-10, from \$5000 to \$6500, which better represents monies needed due to our consistent membership total of 1300 lifeguards each year. The Ways and Means Chair was able to give us half of the additional \$1500 requested, for a line item total of \$5750.00. The Membership Committee understands that the allocation is only intended to supplement what we receive from sponsors, unless the CSLSA receives no sponsorship at all.
- Finally, the CSLSA was notified that we have two new potential chapters to our Association: the Santa Barbara County Lifeguard Association (at Campus Point) and the North Island Lifeguard Association (in San Diego). The Membership Committee recommended conditional approval of both their applications pending receipt of the two requirements: the \$250 Chapter Initiation Fee and a follow-up review of the chapter by a representative assigned by the Executive Board. The Board of Directors approved the Committee's recommendation with the addition of a December 31st deadline for receipt of application and fees.
