We also had eight athletes on the Youth National Team: Raylene Allen, Sydney Brouwer, Katelyn Nimsky, Maiken Pardon, Danny Gonzalez, Jake Graessle, Parris Mosteller, and Daniel Schwedock. Congratulations to all of the athletes and coaches for representing the Southwest Region of the USLA (CSLSA)!
- International Relations & Drowning Prevention Along with the ISRC, Durbin
 was also the host of the World Conference on Drowning Prevention. Renae
 Jackson and Leslie Schwene, both from our region, were honored as presenters.
 Congratulations to both of you!
- John Wayne Cancer Foundation & Block the Blaze John Wayne Cancer
 Foundation once again supported our organization with a generous donation of
 \$5,000. This will go towards a public education Public Service Announcement
 focused on rip currents. You can read more about this in the Public Education
 committee reports online. Thank you once again to John Wayne for your support.
- SoCal Paddle Down As a way of promoting the importance of sunscreen and skin exams, the CSLSA has partnered with the John Wayne Cancer Foundation again for the annual SoCal Paddle Down. This year the event went from the south to north (paddle up) and was the first year to go the full distance from the Mexican Border to Gaviota. This event had great publicity which was the goal heighten awareness of this important cause. Congratulations to everyone involved. Thanks to Mike Silvestri and Adam Sandler for promoting the cause and LA County for the amazing video they produced.

SUBJECT: Vice President's Report

Since our previous meeting, the following has taken place:

I attended the USLA Board of Directors Meeting in San Antonio, Texas.

While at the meeting, I attended and participated in the following Committee meetings: Lifesaving Sport, Special Awards, Junior Lifeguards, Memberships and Executive Committees. I also participated in the open discussion regarding the Delegate Count. The overall outcome was an increase in the number of delegates allotted for a few Regions. I also was interviewed by the USLA National Team Selection Staff regarding my interest in the position of Youth national Team Manager. I was later offered the same position.

I have received and reviewed a number of emails regarding various issues that required Executive Board attention.

The subjects have included: Email discussions regarding National Team Staff, as well as an EVote regarding the same. I also participated in the discussion regarding the proposed USLA agreements with various sponsors. I reviewed an email from Adam Sandler, as there was an issue regarding the submission of a photo for the art work to be used on the proposed Vanity Plates, and as to the ownership of the artwork by a State employee. I exchanged emails with State Park Superintendant Justin Mc Henry. Last week I received an email stating that the California State Parks was willing to allow the CSLSA to use the proposed art work, pending submission of a signed agreement and providing them with a copy of the artwork in our application packet. President Humphreys has informed me that he would have the signed paperwork at this meeting.

As reported by President Humphreys, Bill Richardson and Bob Moore will be in charge of preparing the proposed Guidance Documents for all of the Committees.

LIFESAVING SPORT

I prepared the Host agreement and the Athlete Waiver for our Regionals.

Due to a conflict, I did not attend the Regional Championships.

During the 4th of July weekend, it was announced that I was approved to return as the Youth (U19) National Team Manager for the USLA.

I attended the USLA Nationals in Virginia Beach. It appeared that the number of athletes participating was less than in 2018. Along with Head, Coach Casey Graham, and Assistant Coach, Alan Holt, we watched the Junior Guard competition and evaluated the athletes for possible selection to the USA Lifesaving Youth National Team for 2019. Once the team was selected, I helped prepare for the International Surf Rescue Challenge in Durban, South Africa. The trip required that we be out of the country from September 24 through October 4. At the closing ceremony I made a presentation regarding ISRC 2021, which will be held in Daytona Beach, Florida. I am currently preparing an announcement for the USLA to post regarding the open application period for the U19

I was asked and agreed to be a part of a small staff that is going to Costa Rica next week to provide a class in the use of Rescue Boards.

I have reviewed numerous emails, including the proposal and agreement regarding the Public Service Announcement that Mike Silvestre has been working on.

Attached are the current year's Balance Sheet and Profit and Loss Statements. The CSLSA's current income for the 19/20 membership year is currently below 2018 and has been showing a decline looking at our 5 year average. I am awaiting final numbers for JG and Professional Membership but currently our 2019 deposits include:

Annual Membership (Junior and Professional) \$20,796.00 Regional Lifeguard Comp (Junior and Professional) \$14,746.15

Interest: \$4.50

For a total of \$35,546.65

Utilizing our Zero Based budget model we will need to cut the annual budgets of several sub accounts to have an appropriate budget for 2020. If you are involved with the following Committees; Junior Lifeguards, Lifesaving Sport, Executive Board, Exchange Committee, Public Education and Public Relations, I would strongly suggest you attend the Ways and Means committee meeting this afternoon or tomorrow morning to participate in the budget discussion.

Also, after several discussions about some possible solutions to our decline in Membership I would recommend for discussion at the Membership committee:

- USLA / CSLSA membership dues 1/3-2/3 split (\$10-\$20) instead of 50%-50% (\$15-\$15)

Reasons for this change include: Regions are responsible for sending 40-50 Officers to the two USLA meetings a year requiring a large travel budget (USLA sends 8-10 Officers to same meetings).

- USLA could pay for membership kits out of their 50% of membership fees.
- Agency Membership, Annual dues (\$1000 large agency, \$500 small Agency) With the drop off of junior members in the Southwest Region JG programs this would augment our annual budgets moving forward.

Lastly, due to the intricacies involved with the CSLSA Treasures position, I will not be seeking re-election for this position.

USLA Vice-President Duties

As USLA Vice-President, I have had the opportunity to participate in a number of USLA Executive Committee actions, I have conferred with the USLA Executive Board on a variety of matters and I continue to assist the USLA President with various projects (i.e. reviewing the work of the USLA Executive Director, providing consultation and advice, etc.). I have been working with the Fundraising Project Group, and the Public Education, Certification, Membership, Bylaw and Heroic Act Committees.

At the last USLA Meeting, the USLA President asked me to report to the USLA Board of Directors in San Antonio on USLA's declining membership totals. I reviewed my 8-page report in the USLA Membership Committee meeting and would like to share the conclusion of the report with you now. I would also like to review the report recommendations with the CSLSA Membership Committee today.

Delegate Count

6 years and 11 USLA Meetings later, the Delegate Count has finally been improved. But who's counting? Hats off to the entire CSLSA Executive Board for a truly successful team effort. It would not have been possible if not for the efforts of every single CSLSA Executive Board Member. For the first time in a long time, we have some positive USLA news to report to CSLSA membership. Let's hope that this is not an isolated instance, but rather a sign of good things to come. Let's seize the moment and build on the momentum.

USLA-NJ

At the last USLA Meeting, after 4 years of negotiating with USLA-NJ, USLA signed an agreement to bring USLA-NJ under the USLA umbrella and into compliance with USLA certification standards. Unfortunately, I was recently informed that the Mid-Atlantic Region President, who signed the agreement with USLA, was not authorized to do so. So, USLA-NJ has informed USLA that the previously signed agreement is null and void. Therefore, the USLA President is conferring with USLA attorneys to determine the next course of action.

CSLSA Past President/Advisor

I continue to provide advise on a number of matters for the CSLSA President to consider.

Past-President's Report Page 2

Project Wipeout

On July 14th, I had the pleasure of representing CSLSA and USLA as a presenter at the 2019 Project Wipeout Lifeguard Conference. As many of you know, the conference drew a large in-person and video audience. The agenda was well organized and effectively addressed many pertinent lifesaving topics. At the end, I had the honor of presenting Kai Bond with the *Excellence in Lifesaving Award*.

Regionals

On July 27th, I joined many of you as an official at regionals. Later in the meeting, we will discuss if CSLSA wishes to return to Carpentaria for regionals in 2020. If so, I believe that we should address competitor awards, official radios, official uniforms, official lunches & restroom issues in the next host agreement.

Capitola

I am happy to report that Central Fire has followed through with all of their transition goals for Capitola Beach so far this year. They completed training for all 25 of their JG Instructors. This past summer, Central Fire Captain Scott Harway shadowed the Capitola JGI and Santa Cruz Marine Safety operations. Next summer, Central Fire is looking to provide operational oversight for the Capitola JG program and tower guard service. Negotiations between the City of Capitola and Central Fire are underway to accomplish this goal. Additionally, Central Fire is in the process of merging with Aptos La Selva Fire. Those two departments are combining efforts to form a new Marine Safety Division that will continue engine based rescue swimmers and mirror the excellent service provided by the Santa Cruz Marine Safety Division.

United States Lifesaving Association Vice-President Report on Declining USLA Membership

Date: April 25, 2019

INTRODUCTION

On February 12, 2019, the American Lifeguard Magazine Editor notified the USLA Executive Committee of a suspected 2,000 member decline in USLA membership from 2018 to 2019. As a result, the USLA President asked the USLA Vice-President to investigate USLA's declining membership totals and report the findings to the USLA Board of Directors in San Antonio. The investigation started with a spreadsheet, provided by the USLA Executive Director, breaking down each regions membership totals for each year from 2013 to 2018. The USLA Vice-President then requested that leadership from each region share reasons for membership declines in their respective regions. This report shares what regional leadership had to say and draws conclusions and makes recommendations based on that information. Hopefully, this report will assist the USLA Membership Committee in making recommendations to the USLA Board of Directors on strategies to not only curb current declines in membership, but also ultimately restore and increase future USLA membership.

COMMENTS FROM REGIONAL LEADERS

Great Lakes

- Professional Members (2016 42; 2018 24)
- Associate Members (2016 8; 2018 0)
- Back Yard Lifeguards (St. Louis) have decided to go in a different direction.
- 2. Retirements have impacted Associated Members with some moving out of the region.

Gulf Coast

- Alumni Members (2015 5; 2018 1)
- 1. Lost 4 Alumni Members because they do not want to compete anymore.
- Normal "ebb and flow" for the GC Region.

Mid-Atlantic

- Associate Members (2016 19; 2018 6)
- Junior Lifeguard Members (2017 1,266; 2018 1,032)
- 1. 50% of JG decline was the result of one agency withholding their membership as a result of a dispute over USLA certification. The problem has been resolved and the agency will be submitting JG membership this year.
- 2. This summer, the MA Region will be making a concerted effort to increase JG and Professional membership.

New England

- Professional Members (2016 48; 2018 20)
- Junior Lifeguard Members (2015 42; 2018 0)
- 1. Agencies see USLA certification as an insurmountable goal that they can't achieve.
- 2. Individual members don't feel membership will gain them anything.
- The NE Region is working on getting new agencies to join by introducing them to agencies that have achieved USLA certification and showing them that certification is not as unattainable as they may think.
- 4. The NE Region is continuing their discussions with lifeguards and is developing a new flyer to recruit more USLA members.
- 5. The NE Region has 2 Open Water Lifeguard Management Academies planned that will include a segment on USLA membership.

Northwest

- Professional Members (2013 103; 2018 76)
- Junior Lifeguard Members (2016 207; 2018 0)
- Associate Members (2016 4; 2018 0)
- The NW Region did not hold a regional competition in 2018. The region typically adds more members as a result of the regional competition.
- It has always been difficult to get seasonal lifeguards to see the benefit of USLA membership when they may only work 12 weeks during the summer.

Pacific Islands

- Professional Members (2013 214; 2018 69)
- Junior Lifeguard Members (2016 38; 2018 2)
- Associate Members (2016 10; 2018 0)

- Change in leadership on Oahu, Maui and Hawaii Island. New personnel not familiar with USLA, other than the agency certification program. They don't really know enough to encourage the troops to join or budget for USLA membership for their employees.
- 2. Lifeguards on the beach do not recognize the benefit of USLA membership. Belonging to "the only organization of open water lifeguards that sets and maintains high standards of lifesaving" doesn't really resonate in the tower or on the beach.
- There has been a drastic reduction in the number of Hawaiian competitors participating in Nationals during the past two years because traveling to the East Coast from Hawaii to compete is extremely expensive.
- 4. Politics, regionalism and maneuvering at the Board of Directors meetings is discouraging to membership.

South Atlantic

- Professional Members (2016 903; 2018 792)
- Associate Members (2016 6; 2018 1)
- 1. Horry County had 251 members in 2016 and only 124 in 2018.
- Lack's Beach Service in Myrtle Beach had their USLA certification revoked in 2008, so they ceased membership. Their lifeguards started signing up members again in 2016. In September of 2016, USLA sent a letter to the Mayor of Myrtle Beach stating that Lack's lifeguard service failed to meet USLA standards. The Horry County numbers declined the next year.

Southeast Region

- Professional Members (2017 787; 2018 557)
- Junior Lifeguard Members (2017 547; 2018 172)
- Alumni Members (2015 48; 2018 39)
- Florida is a "Right to Work" state. Therefore, union dues, professional associations, etc. cannot be imposed upon any employee. Therefore, SE Region membership is strictly comprised of those interested in the mission of USLA.
- As an example, USLA membership in the Miami Beach Chapter is down from over 100 to 36 since budget cuts no longer allow the department to pay for USLA membership for all the Full Time employees as has been done in the past.
- Competition is one of the main drawing cards for membership. When the National Lifeguard Championships are held in the SE Region, there is an increase in membership from the SE Region.
- 4. The SE Region Executive Board is reviewing how to increase future USLA membership.

Southwest Region

- Professional Members (2015 1.347: 2018 1.013)
- Junior Lifeguard Members (2013 7,524; 2018 1,448)
- Associate Members (2016 32; 2018 9)
- 1. Lifeguards are not seeing the value of USLA membership. Part of the reason is we are not doing a good job of promoting the benefits. Benefits must appeal to end-users. For example, although we value USLA as an organization promoting professional lifesaving standards and beach safety education, a young lifeguard may not appreciate that; not enough to pay to join anyway. What they would appreciate is significant discounts and benefits of being a member. For example, it helps if USLA is offering exclusive discounts on items lifeguards use (fins, wetsuits, rashguards, sunglasses, watches, surfboards, binoculars, etc.). Savings from one purchase pays for the membership many times over. Partnering with companies, such as HydroFlask, even if USLA doesn't recoup a dime, adds value to membership. USLA would make more in membership dues this way than they'd make from cash deals and always requiring vendors, such as HydroFlask, to pay to give discounts.
- 2. Many influential chapter leaders have been discouraged by what, at times, seems like a small group of regions that oppose the SW Region for seemingly no good cause. Some of the issues would have no impact on other regions. However, the negative impact on the perception of USLA has been huge on SW Region membership. As just one example, look at the previously proposed, approved in committee, but defeated on the floor, increase in the regional delegate count, based on representation proportionate to membership. This would not have increased the SW Region's ability to influence USLA at all. Other regions would have shared the same increase.

However, almost as bad as the proposal failing, was the way it failed. The motion was discussed and debated in committee, and passed nearly unanimously. Then, when it went to the floor, three people spoke in favor of the motion and no one from any region opposed it. But, when the vote was held, the motion failed. This sent a strong message and some of our members felt that there was behind-the-scene collaboration. Somehow, votes from committee members changed, but no one expressed the reasons or even debated on the floor, which is why we have discussion and open debate. Compounding this, no one had the courtesy to bring this to the attention of the SW region ahead of time, not even to say they had changed their mind.

- 3. Competitors are frustrated by many Lifesaving Sport and Fitness issues, including:
 - a. Cost of travel to the east coast for repeated national competitions,
 - b. Lack of clear policy for the selection of national team managers and coaches,
 - c. Lack of clear policy for the selection of national team competitors,
 - d. Late committee meeting agendas that do not allow all topics to be addressed, and
 - e. Late committee reports that do not always accurately reflect committee votes.

Lack of accountability for these ongoing issues negatively impacts membership totals.

4. When actions like the examples in #2 and #3 above are relayed back to local chapters, some of which are very large, the members and leadership get very discouraged. As a result, you can bet they impact USLA membership totals. Tie this to #1 above and you'll

see the compounding effect of dissatisfaction. The dissatisfaction could easily be overcome with proper focus on one of our fundamental missions, to serve the membership.

- Around 2016, the Assistant City Manager for the City of San Clemente did not see the value in paying for Junior Lifeguard membership, despite being provided with an extensive list of benefits. As a result, the ACM did not approve the line-item budget for 800 members.
- 6. In 2017, the City of Newport Beach no longer saw the benefit of paying \$10 for each Junior Lifeguard. As a result, they stopped paying for their 1,400 Junior Lifeguard memberships. However, Newport Beach leadership mentioned that if USLA offered something similar to the \$2,000,000 liability insurance provided by the Boy Scouts of America, USLA membership would be an easier sell to their city officials. Liability insurance may help other programs, like San Clemente and Los Angeles County, justify USLA membership for their JG's.
- 7. Around 2013, Los Angeles County stopped paying for all their Junior Lifeguard memberships for reasons similar to those mentioned in #5 and #6 above. They had 2,400 members at that time. Today, they have 4,200 JG's. Approximately 500 of those JG's sign up for membership on the USLA website.

COMMENTS FROM USLA MEMBERSHIP COMMITTEE

(on declines in National, International and Unaffiliated Memberships)

- Professional Members (2013 18; 2018 3)
- Junior Lifeguard Members (2017 99; 2018 4)
- Alumni Members (2013 4; 2018 0)
- 1. The decline in international memberships may be due to not sending them the magazine anymore.
- 2. The decline in national and unaffiliated memberships may be due to individuals changing employment or losing interest.

USLA JUNIOR LIFEGUARD COMMITTEE DISCUSSION

(from meeting in Delray Beach)

- 1. The major decline in JG membership is due to 3 large agencies discontinuing automatic JG membership as part of their program registration process.
- The USLA JG Committee recommends focusing on improving the value of USLA membership to 4 audiences:
 - a. The JG Agency
 - b. The JG Member
 - c. The JG Member's Family
 - d. The JG Instructor
- 3. What is the value to the agency? How does an agency justify thousands of dollars for membership when the value does not appear to match the cost?

- 4. Magazines are outdated for children. Try to find a new avenue for content and information delivery. Children respond better to digital media rather than print media.
- 5. JG Instructors do not value USLA membership. Instructors need to see more value and benefits than just competition.
- 6. Develop a "Youth Protection Guidelines" similar to the Boy Scouts of America.
- 7. Look into corporate sponsorship for all USLA JG members to help agencies that can't sign up members due to restricted use of public funds or other firm barriers.
- 8. Establish a USLA JG scholarship program to appeal to parents and families.
- 9. Consider JG basic membership free of charge, which would not include participation in the national competition. JG basic membership would dramatically increase USLA's JG membership total, potentially making it more lucrative for sponsorship. JG basic members could still receive product discounts that may result in increased sales for sponsors. JG basic membership would also expose many more children to positive association with USLA. The increase in JG basic membership would also hopefully translate into a larger pool for professional membership in the future. Under this concept, JG's who wish to compete would pay for JG competition membership.

COMMENTS FROM USLA TREASURER

- I think that understanding our membership numbers is complicated due to a number of issues.
- 2. Membership Year vs. Fiscal Year The fiscal year for the USLA runs January 1 December 31. However the membership year runs July 1 June 30. This makes it challenging to report on, because matching the numbers is nearly impossible depending on when members sign up or are uploaded in bulk vs. when payment is received. For example, we entered 2019 with (2) outstanding invoices from regions for bulk uploads where the payment for those memberships were not received until 2019. One of those invoices was upwards of \$12,000+. Obviously when reporting on the budget, 2018's membership finances will appear deflated, while 2019's membership finances will appear inflated.
- 3. Working for an agency that offers various annual and seasonal memberships, I recommend discussing the pros and cons of having our memberships to run for 1 year from the time of purchase. I know based on past conversations this does present challenges, but reviewing why we are operating the way we are versus other options may be important.
- 4. In the numbers you pointed out for the South Atlantic, you state that the SA Region only had 792 in 2018, but according to the 2018 finances that numbers show 918. I don't know the reason for the discrepancy or the source, but I'm curious to know why. We receive membership revenue all year long.

I'm curious if we have tested running membership reports based on certain dates and what they would show. Is it possible that the 792 was based on a report that was run before all the uploads were completed?

I don't know. Perhaps we can find out.

5. I checked our numbers for the past 3 years. Below are the membership revenue totals.

2018 \$135,262 (\$153,863)

2017 \$154,739 2016 \$155,484

- 6. Note, if those 2 invoices for 2018 had been paid on time, 2018's total would have been \$153,863. This brings those numbers within a few hundred dollars of each other with a slight decline, but nothing substantial. Now in recent years, we have become better at following up on membership dues owed to the USLA by utilizing QuickBooks. So if we are doing better at getting the revenue owed, while at the same time numbers are dropping, then I can see how the membership totals in the budget are hovering around \$154,000. This only goes to show how difficult it is to pinpoint what is happening.
- 7. In the end we need to figure out our membership, what we are offering, how we are selling it and how is the data being collected.

CONCLUSION

USLA's professional and junior lifeguard membership totals have declined for a number of reasons, including:

- 1. Lack of perceived value to individual members,
- 2. Lack of perceived value to lifeguard agencies,
- 3. Some lifeguard managers and administrators are unaware of the benefit of USLA membership,
- 4. Lack of agency funding or corporate sponsorships for USLA memberships,
- Disproportionate regional membership representation to the USLA Board of Directors, and
- 6. National Lifesaving Sport and Fitness issues.

In order to address these issues, USLA's Membership Committee, Junior Lifeguard Committee, Lifesaving Sport & Fitness Committee and Board of Directors will need to develop effective strategies. These strategies should be designed to increase real and perceived value to members and may need to vary among membership classifications. For example, junior lifeguard members may have different needs and wants vs. professional members.

Outreach and recruitment programs will need to feature benefits and incentives that potential members and agencies will value. Sponsorships and other funding sources will need to be implemented to increase membership. Policies will need to be improved to provide clarity, fairness and accountability for all members. Ultimately, USLA will have to utilize its many dedicated volunteers to encourage all members and regions to commit to reducing politics and regionalism, to embrace our common mission, in order to help our organization reach its true potential.

RECOMMENDATIONS TO STIMULATE USLA MEMBERSHIP GROWTH

- Have the USLA Membership Committee review this report, determine which of these and other recommendations have merit, and develop strategies that can be implemented at the regional level.
- 2. Encourage all regions to develop strategies to increase USLA membership at the chapter level.
- 3. Encourage all regions to develop an agency outreach strategy that will educate agency leaders on the benefits of USLA membership.
- 4. Develop a new USLA recruitment flyer highlighting all membership benefits.
- 5. Develop better incentives, including discounts and corporate partnerships, to encourage seasonal lifeguards to join USLA.
- 6. Continue to develop additional certification programs that will benefit lifeguard agencies and increase the value of USLA membership.
- 7. Encourage the New Jersey Subcommittee of USLA Certification Committee to work cooperatively to effectively address certification and corresponding membership issues.
- 8. Provide incentive, such as more proportionate representation, for larger regions to expand their membership.
- 9. Develop a national sponsorship strategy to make it sustainable to rotate the USLA National Championships between coasts on an annual basis again.
- 10. Continue to improve the host agreement to make it sustainable to rotate the USLA National Championships between coasts on an annual basis again.
- 11. Improve USLA policies to make the selection of national team athletes, managers and coaches more clearly defined.
- 12. Seek compliance with the USLA Policy III-I: Officers, Committee Chair and Regional Reports regarding posting time requirements and accurate reporting standards.
- Make sure all committees add requested topics to meeting agendas so all issues may be discussed.
- 14. Have the Junior Lifeguard Committee develop strategies to stimulate membership from prospective JG's, agencies, instructors and parents.
- 15. Develop "Youth Protection Guidelines" and consider liability policy insurance, similar to the Boy Scouts of America, to encourage agencies to increase their JG membership.
- 16. Consider digital media to appeal better to JG membership.
- 17. Seek corporate sponsorship to assist agencies in funding JG membership.
- 18. Establish a JG scholarship program to appeal to parents.
- 19. Consider the potential benefit of making JG basic membership free or reducing the cost of membership to JG's.
- 20. Consider the pros and cons of having USLA membership run for 1 year from the time of purchase.

Spring USLA BoD Lifesaving Sport Committee meeting -San Antonio, TX

USLA Lifesaving Sport Committee: Chair: Ed Zebrowski III-Mid Atlantic

I submitted 3 Southwest proposals for Lifequard rules and 1 proposal for Junior Guards

SW Proposal 1. Eliminate the rule that if you propose a new event it must replace an existing event. SW Proposal 2. Southwest Region again proposes to add the ILS 3-person Paddleboard Relay for both Open Men & Open Women. The Paddleboard Relay event motion successfully passed in the Lifesaving Sport Committee in both 2008 and 2015 but both was overturned in voting on the floor by a full floor vote by all the Board of Directors. At the Fall 2018 USLA Lifesaving Sport Committee meeting it was decided the Paddleboard Relay would be a demonstration event at the 2019 USLA National's in Virginia Beach, it was discussed the Paddleboard Relay would be contested for places, but no points would be awarded- It was a Newport, Santa Barbara, Hamptons Trio that won the Men's & LA County won the Women's race – each team won a Dolphin Paddleboard.

* While we do not want it to come to this but if an event must be replaced at the National Championships it would be the Ironguard and then the RSR- which is already very similar to Surf Race, and to the Ironguard (Run Swim Paddle). While RSR has a long history in the USLA (first contested as an Open Championship event in 1970) the USLA is one of only three of the top 15 surf lifesaving nations that has a Run Swim Run event as part of its Nationals Championships events program-the others are New Zealand and Great Britain. While the ILS does have RSR rules it is not part of the National Teams Championships nor the Interclub or Masters Championships.

SW Proposal 3. Add the 90m Beach Sprint as an individual event for U19 and Open.

SW Discussion item 1. Discussion on how to return the Board Rescue and the Tube Rescue Races to the Masters event schedule soon. Maximum of 4 Master's teams per chapter per age grouping. The Master's Board Rescue & Master's Rescue Race events were part of the USLA Masters Competition at USLA Nationals up until 2007 when we adopted ILS rules and changed the event schedule and rules. As Open Water Rescues are the most important function of what we as Lifeguards do then these two Rescue events are at the core of our profession and all age groups JG, U19, Open, Masters should contest these Rescue events fairly with their peers.

SW Discussion item 2. Explore methodology to add an Open Mixed Surfboat Race -1 male rower & 1 female rower- row 2 laps of the Surfboat apex course. Maximum of 4 Mixed Surfboat teams per chapter

Proposal motions made in USLA LS & JG Committee: per Casey Graham and Gus Avila's request Southwest would like to add Board Rescue to the U19 National Championships event list

2019 CSLSA California Surf Lifesaving Championships-July 26 & 27-Carpinteria City Beach

Kudos to all the organizing committee efforts from the Carpinteria Chapter. I was arrived pre-dawn on and was on site all day for three days -Thursday, Friday, Saturday-left late Saturday night when the load out was almost complete, worked my 48-hour shifts on Sun & Monday, and drove up to pick up and tow the already loaded Trailer on Tuesday. On site the Carp Lifeguard and JG staff offered me more people power for set up, and break down, than any other chapter in the past decade.

Cal State won the overall point score and Large Agency Championship for the 7th year in a row. Laguna Beach won the Small Agency Championships.

SUBJECT: Public Education Activity Report Fall 2019

PSA Project:

After the spring meeting, I discussed the project with a marketing firm. They suggested we complete the PSA first then consider the marketing approach for distribution. I arranged for two bids for the PSA. We decided on using TheBrandAmp in Costa Mesa. One of their staff is Newport City Lifeguard Eric Hernandez. He knows what we are looking for and speaks the language. Lauren from JWCF and I met with staff to go over the project. Lots of emails and phone calls in between. I signed the contract on August 9th to officially begin the PSA.

TBA has a great crew to work with especially with Eric on board. They got a lot footage over Labor Day Weekend at the HB pier. They had some huge projects to complete (as you can imagine our \$10,000 project is very small) so they are just now scouting and getting ready for final field filming later this month. They will be shooting footage and Laguna City main beach, Crystal Cove State Park, Newport Beach City and Huntington Beach City. We have received awesome support from all the agencies involved.

After our meetings, they gave us two concepts to choose from for the project. We decided on Concept 2, which I can share in committee. They developed a storyboard based on this concept and I will share that in committee as well.

We were hoping to have the project ready for this meeting but it will probably be sometime in December before completion. Definitely ready for the spring meeting. There will be three versions available to everyone. A 30-second PSA with voice over, the PSA with text only and an audio only version. That will give us a lot of flexibility in getting the PSA out into our communities.

The next step will be to discuss the possibility of hiring a marketing firm to see about getting the PSA into airports, hotels, etc.

Educational Conferences:

We are now up to three official lifeguard educational conferences. This past summer Ventura hosted their first ever on July 8th – Spinal Motion Restriction by Todd Larsen, MD; Going the distance for Lifesavers by Chris Dobrosielski; Surviving a spinal cord injury by Alex and Greg Shaner; Regional White Shark update by John Higgins. This was followed by San Diego on July 9th – Drowning resuscitation for Lifeguards by Justin Sempstrott, MD; Epidemeiology and prevention of drowning by Dan Galanis Phd; Skin Cancer for Lifeguards by Hugh Greenway MD; Human factors in Lifeguarding by Jonathan Weber; Sharks and Sting Rays by Dan Dimarzo. Finally, Project Wipeout on July 10th – 40th Anniversary by Mike Beuerlein; Cspine by Pascal Juang MD; Lifeguard health by Jack Shohet MD; Shallow Water Blackout by Matt Hunt MD; Lifeguard role in emergency response by Mike Halphide Newport Beach; Human Factors in

Lifeguarding by Jonathan Webber; Excellence in Lifeguarding Award to John Rodgers. All hugely successful!

Santa Cruz - you are next! Let's make it happen summer 2020! LA County, I am not giving up!

John Wayne Grit Series:

We passed this info on to all State Guards and had some interested. Joanne Warzoha raised about \$2,000 for her run in Colorado. I just got an email from her. She dislocated her ankle and suffered a lower leg fracture that will require surgery so she will not be able to attend the run.

Scripps Lifeguard Advisory Committee (SLAC):

We met on September 11th at Scripps La Jolla. We discussed the SoCal Paddledown, the CSLSA PSA Project, the Encinitas bluff collapse, the general increase in sting ray activity and shark sightings, E-scooter incidents in Mission Beach, San Diego City IPad use for EPCR went live August 1st, multiple agencies reported increased employee injuries along with contributing factors (they don't make them like they used to), support to move forward implementing the new drowning protocol, the 2019 educational conference, research project with UCSD, the Orange County School presentation to be shared and revamped for San Diego County.

UCSD Study:

Will Koon, Paige Colburn-Harris from Scripps and I met with Professor Nancy Binkin from UCSD to discuss a proposal for the UCSD Bachelors of Public Health Honors Practicum Project. This project will be conducted by an elite and select group of honors students for the 2019-2020 school year. They will conduct interviews with lifeguards from the San Diego County agencies. They will interview and test high school students from both coastal and inland schools with the focus being on rip currents. They look to publish this study when complete.

This is a unique opportunity as no study like this has ever been conducted on the west coast. It will give us hard data on high school age groups vising our beaches. This will allow us to create our public education efforts based on facts rather than past practice, corporate knowledge, etc.

In order to assist the UCSD team, I went to all the lifeguard agencies in San Diego County to summarize how they collect and report their data. I also collected samples of all the forms they used in their process. As expected, no one does it the same. This really shocked the team and we are really missing the boat by now collecting at least a core set of data points. I will discuss the data collection summaries in committee.

It was discussed at SLAC and everyone supports the program. The program will start this fall and we will have a finished product next spring. It will be made available to all lifeguards. PSA Project:

They will be filming the project on November 12 and 20. If completed, I will share at the upcoming USLA meeting. If not, we will release to all the lifeguard agencies as soon as available.

The Public Education Committee will meet in the spring and create a formalized PSA Release Plan for Memorial Weekend.

I will get bids for marketing the PSA to airports and hotels and bring it to the spring meeting.

UCSD Study:

Will Koon explained the project in detail and answered questions. If complete, we will bring the results of the project to the spring meeting.

Public Education Budget:

The CSLSA is having some budget issues from decreased membership revenues. As such, the PubEd Committee took a significant hit in the 2020-2021 budget. In 2016, our budget was \$2,500. In 2017/18/19 it was \$1,500. Starting in 2016, the John Wayne Cancer Foundation donated \$5,000 each year to the CSLSA. I went to Ways and Means in 2016/17/18 to request the \$5,000 be relocated to the PubEd Restricted Fund. This was successful each year.

Due to the budgetary constraints, PubEd was not allocated a budget for 2020-2021. In addition, I went to Ways and Means to request the JWCF \$5,000 be put in the PubEd Restricted Fund. It was only approved for \$3,500.

So, annual monies available to PubEd have been \$6,500, the next fiscal year will only be \$3,500. A significant hit that many mean we delay entering into a marketing agreement for the PSA until the 2021-2022 fiscal year.

Everyone took a hit but this one will probably hurt our PSA marketing plan and potential future PubEd Programs.
